**ARTICLE I
NAME**

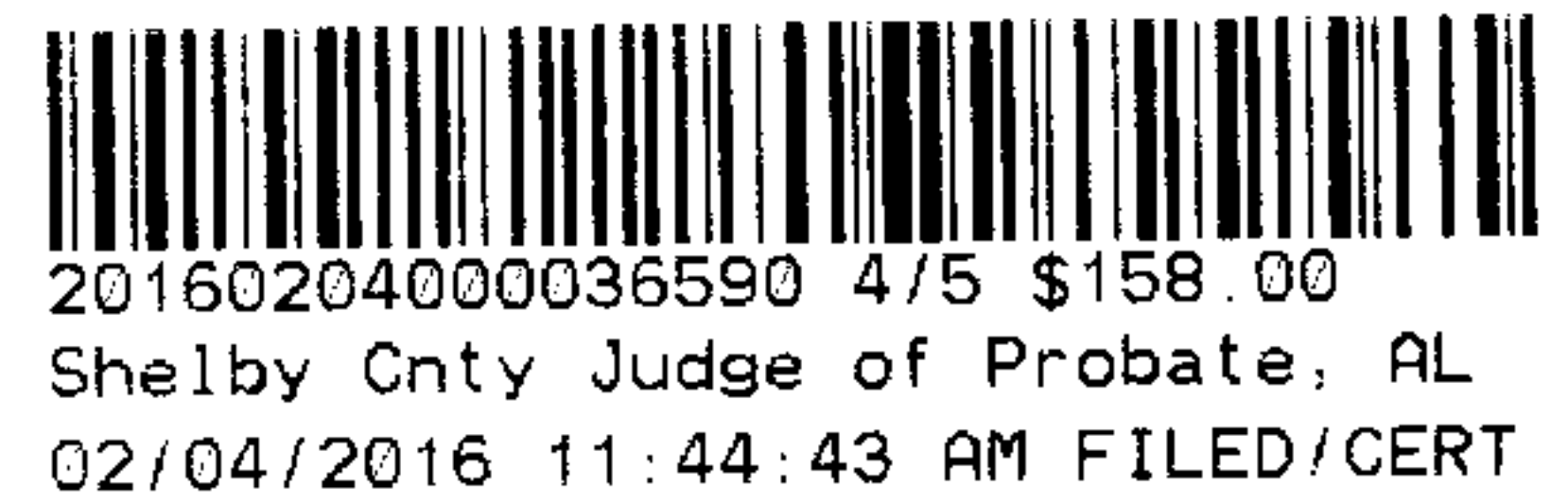

MANAGEMENT**

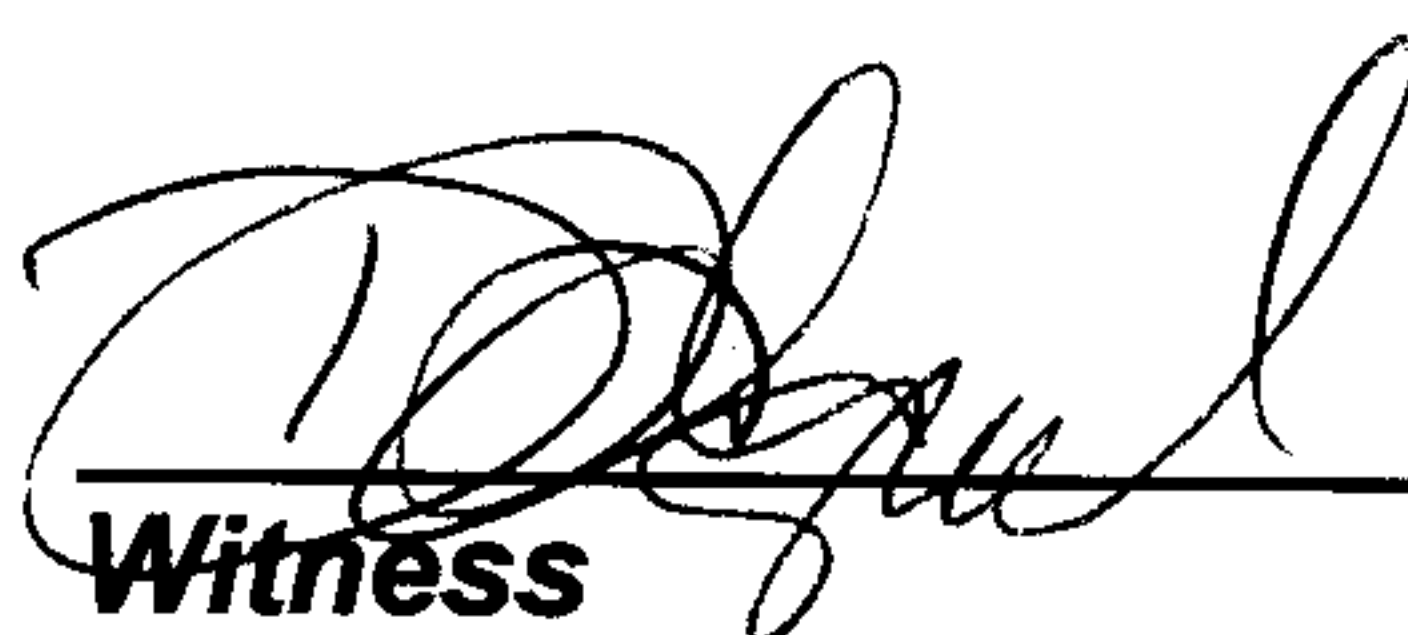
The Company shall be managed by the managing member, Jennifer Barragan.

AMENDMENT**

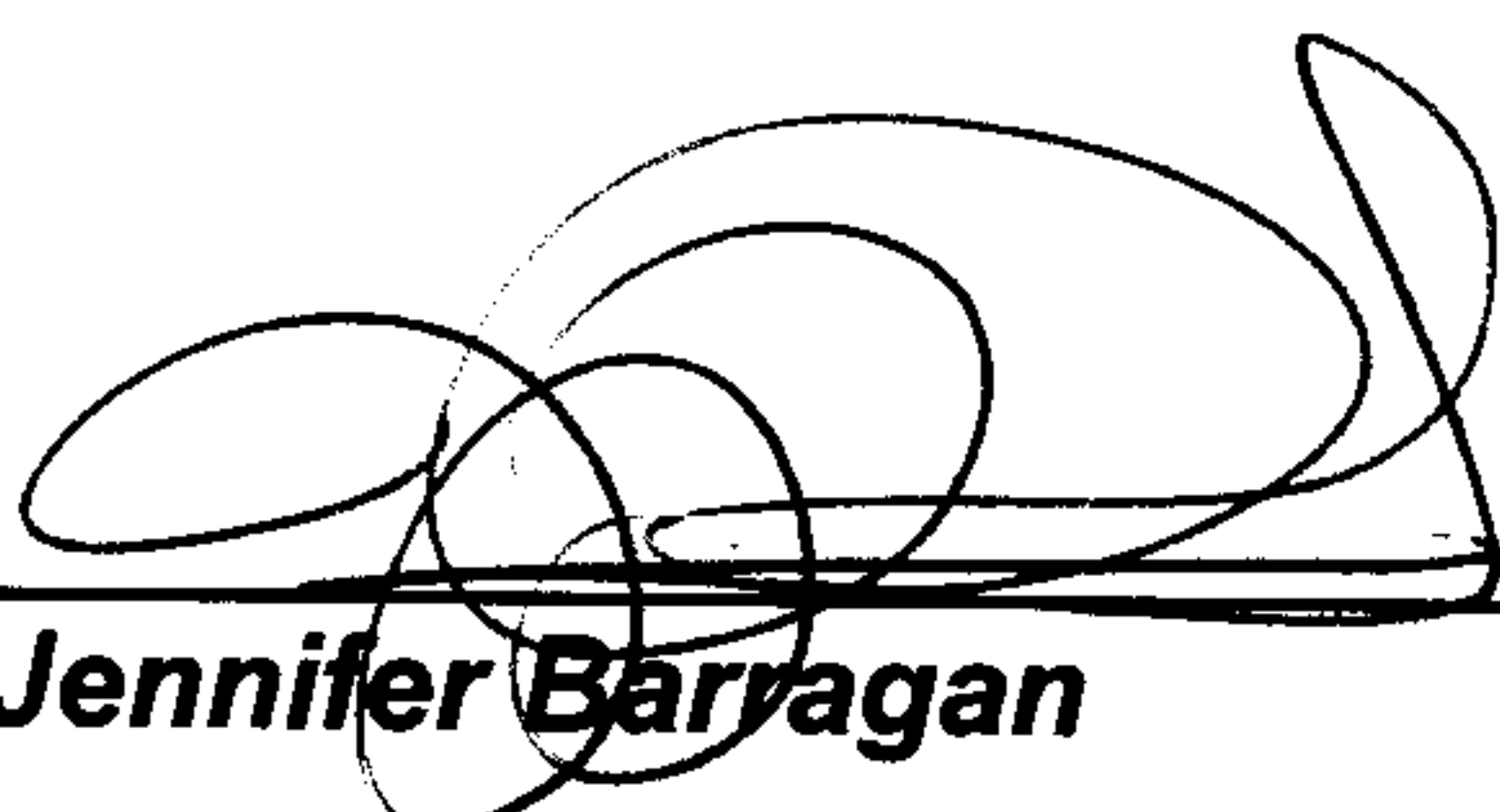
Any amendment to this Certificate of Formation shall require approval of all the members.

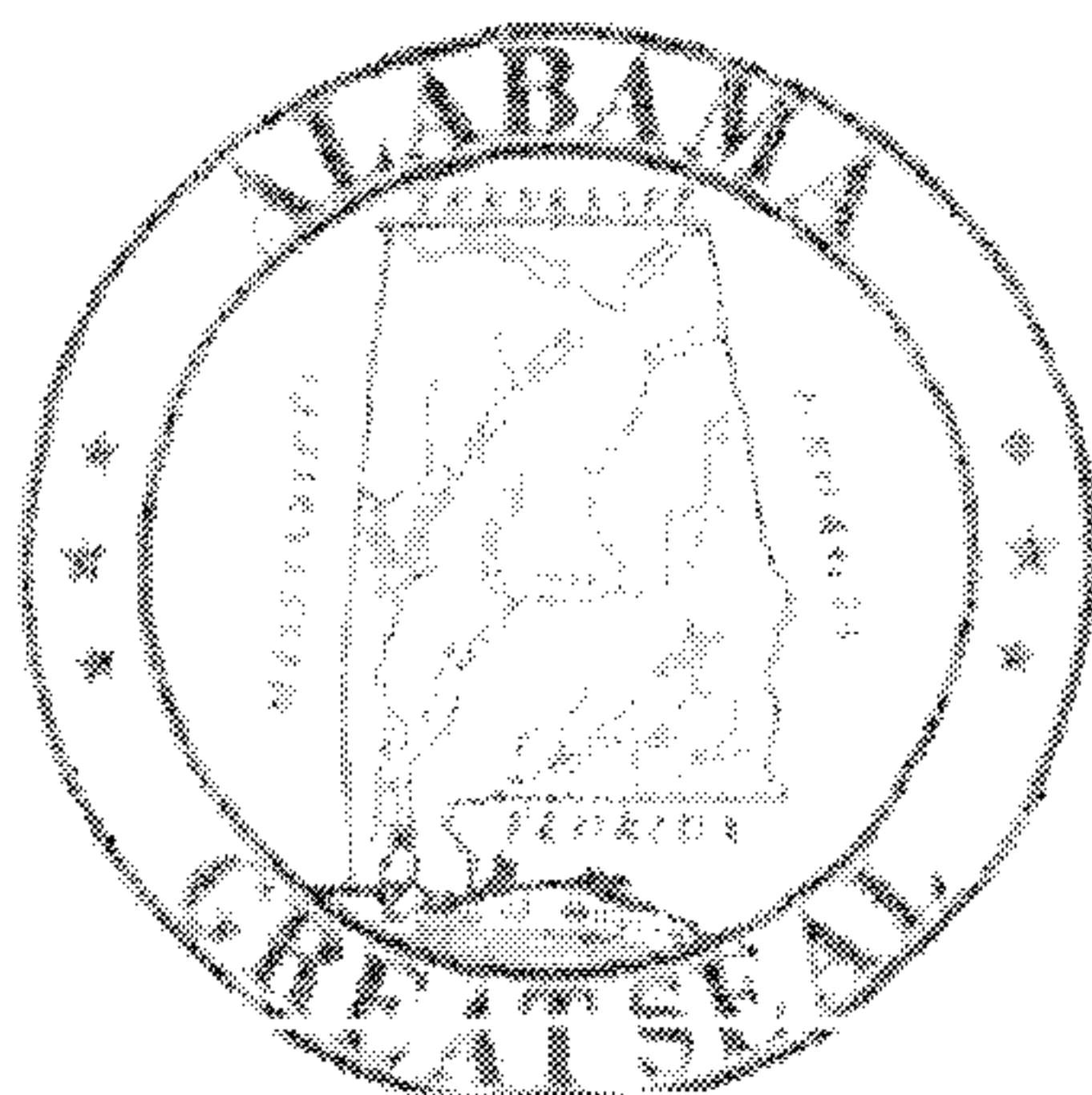
