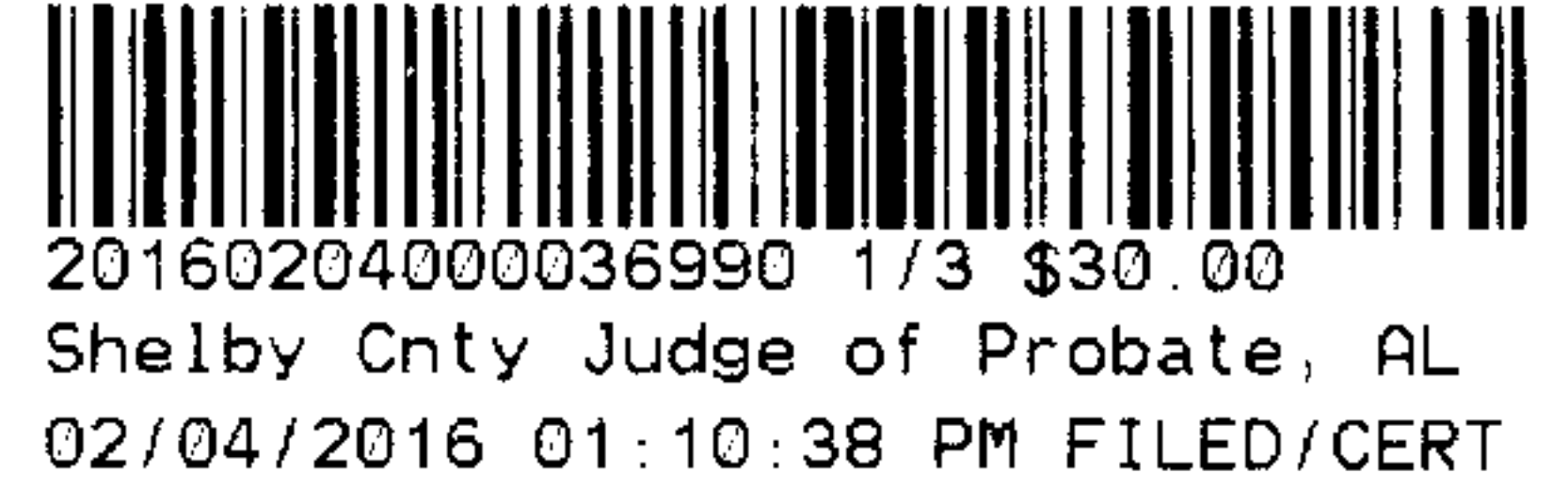

(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

RONALD D. VINES, TRUSTEE, OR HIS SUCCESSORS IN TRUST, UNDER THE VINES LIVING TRUST, DATED DECEMBER 1, 2015, AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), all my interest in the following described real estate, situated in Shelby County, Alabama, to-wit:

Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

The above described property does not constitute the homestead of the Grantor or the Grantor's Spouse.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEE, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises: that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEE, his, her or their successors and assigns forever, against the lawful claims of all persons.

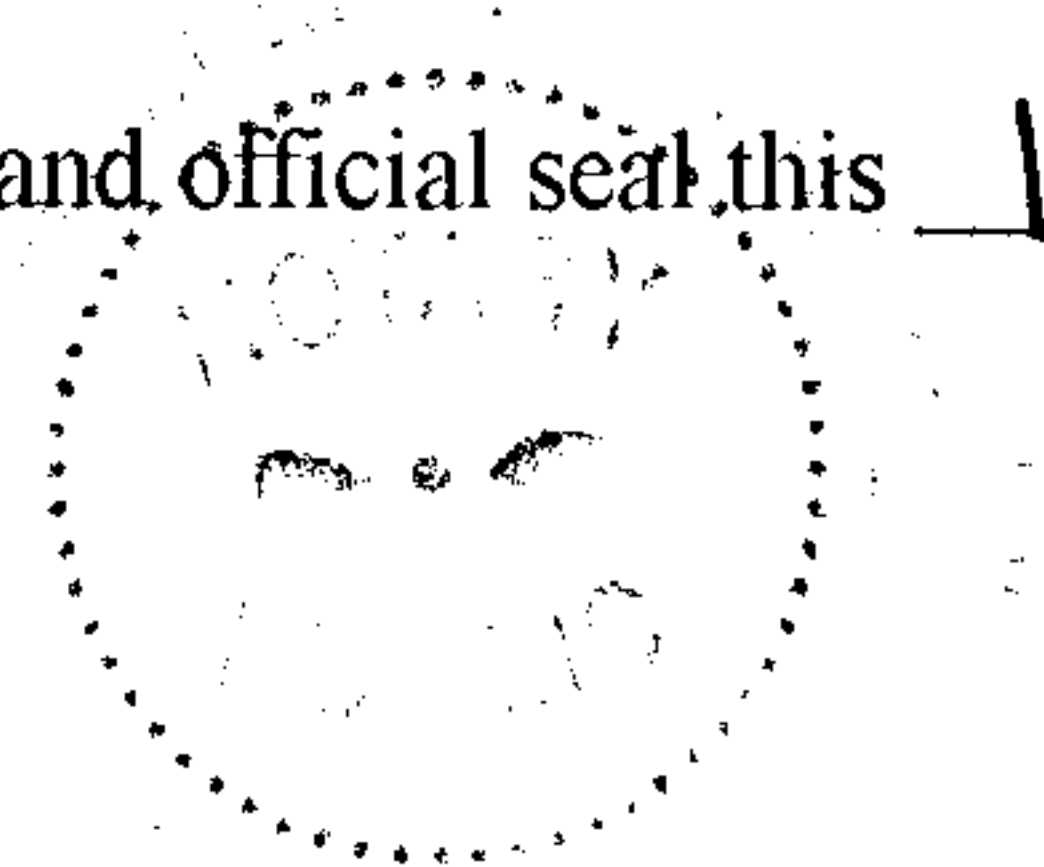

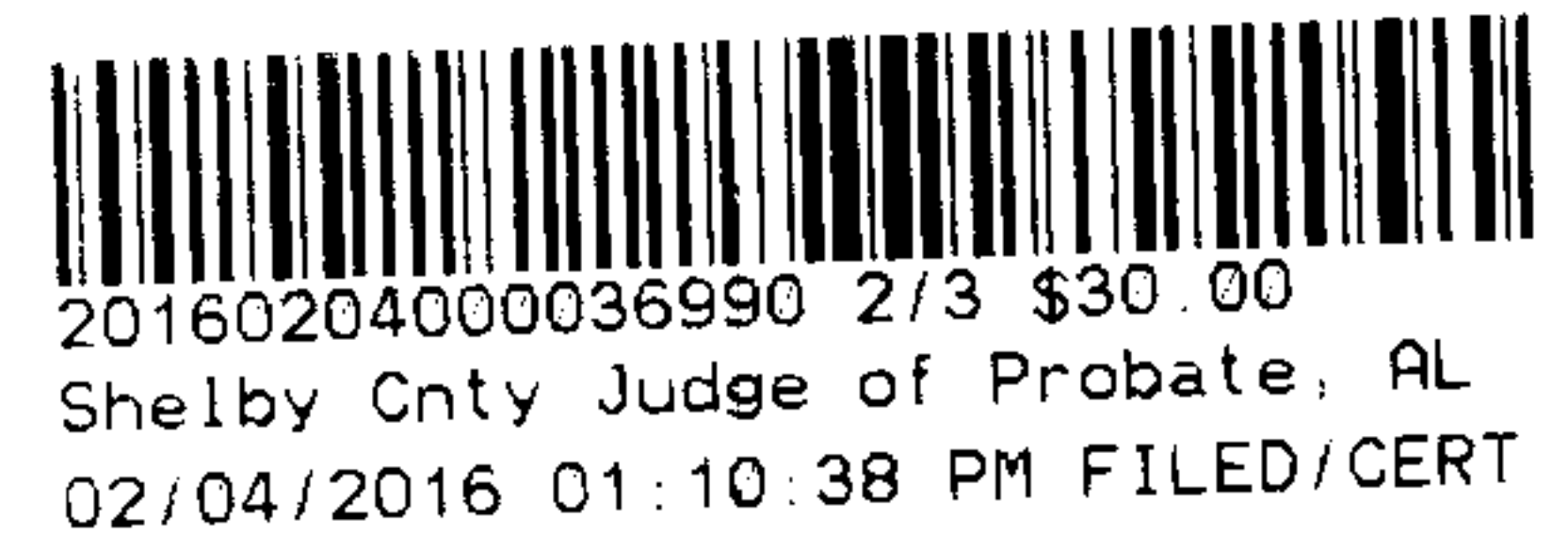

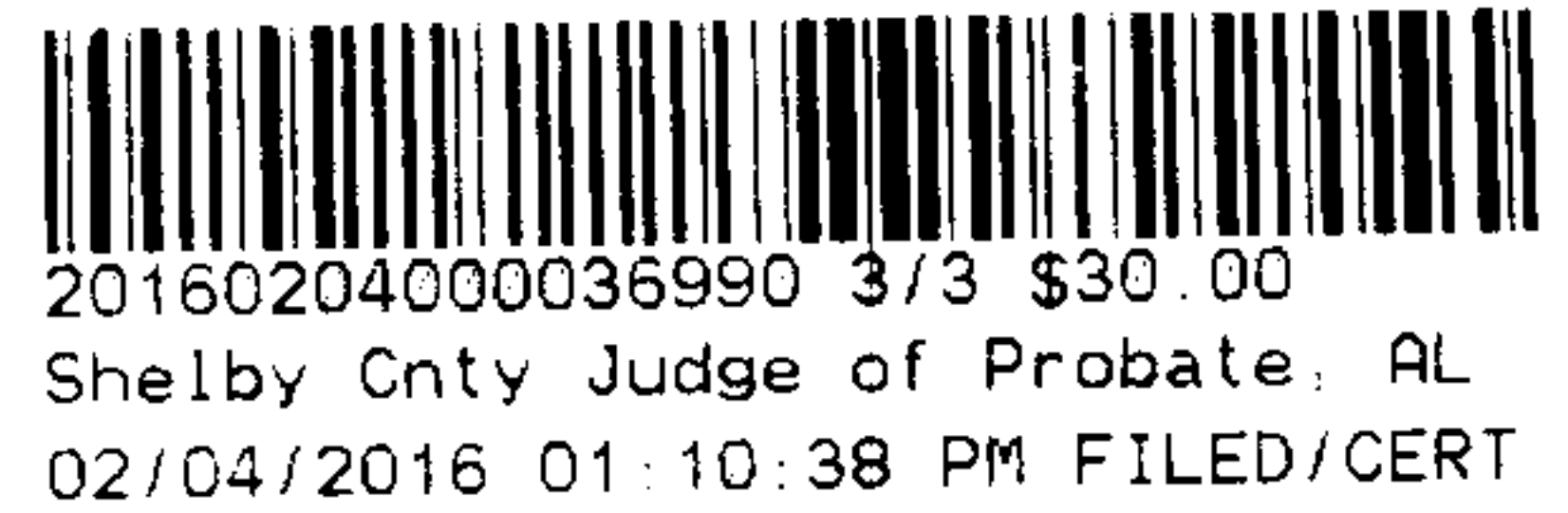
