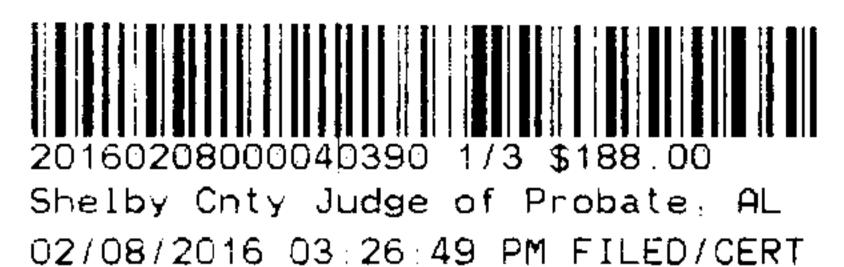

SPECIAL WARRANTY DEED
