ARTICLE I

NAME

DURATION

The period of duration shall be for **fifty-three (53)** years unless otherwise terminated. It will not be perpetual.

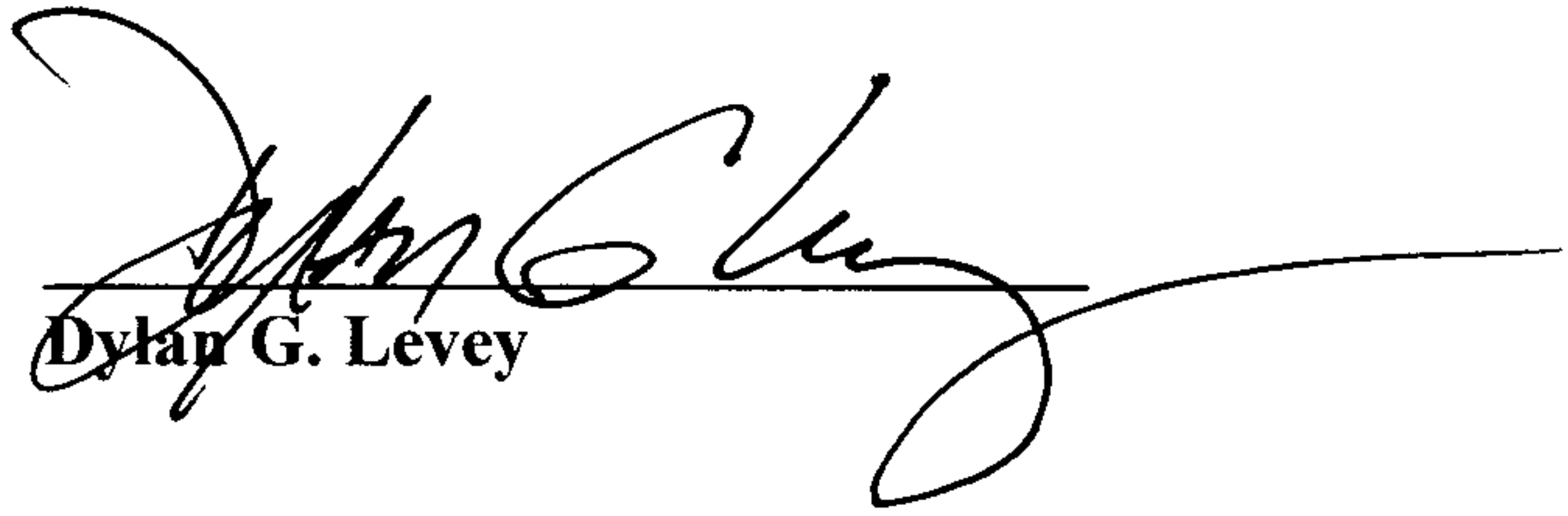
