KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of June, 2007, Kim Lan Ho, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for EquiFirst Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070711000326400, said mortgage having subsequently been transferred and assigned to SABR Mortgage Loan 2008-1 REO Subsidiary-1 LLC, by instrument recorded in Instrument Number 20150515000161350, in the aforesaid Probate Office ("Transferee"); and

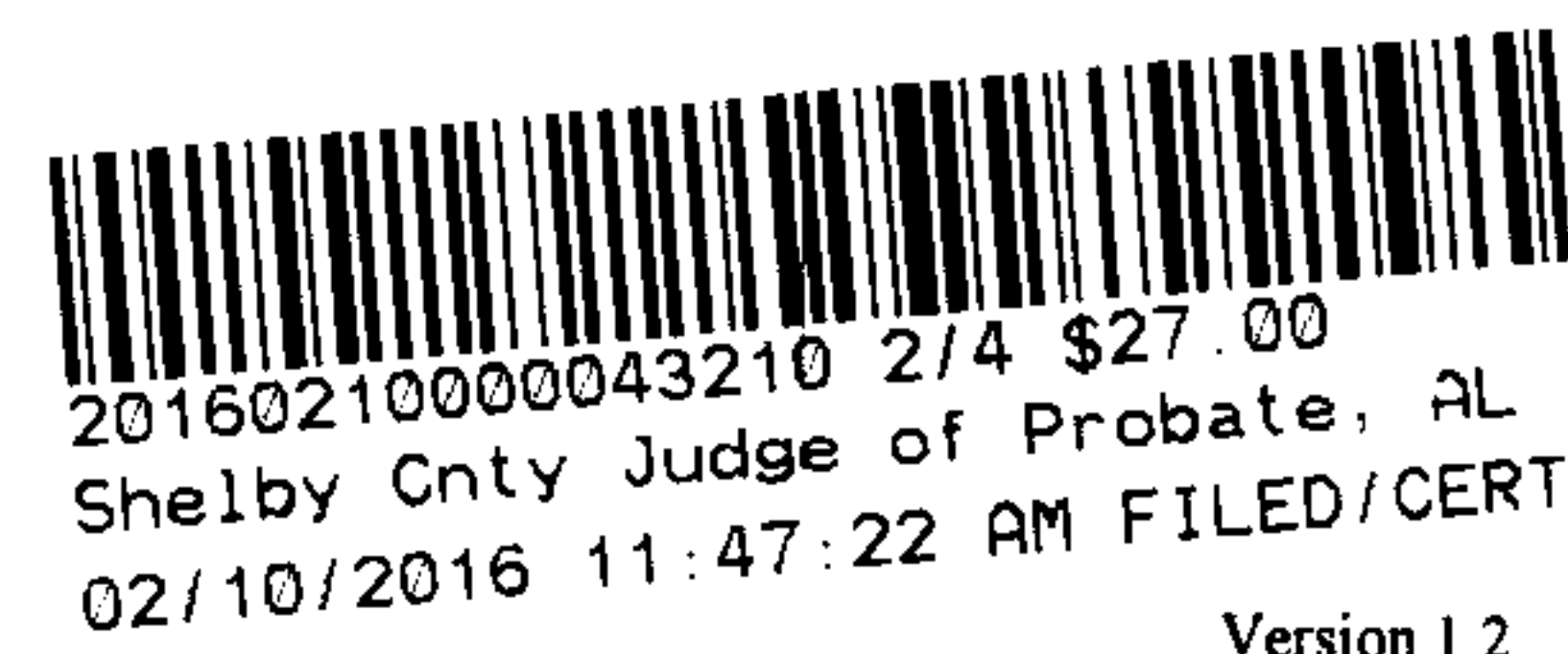
