WHEREAS, heretofore on 05/29/07, Alvin D. Langham and Laronda S. 



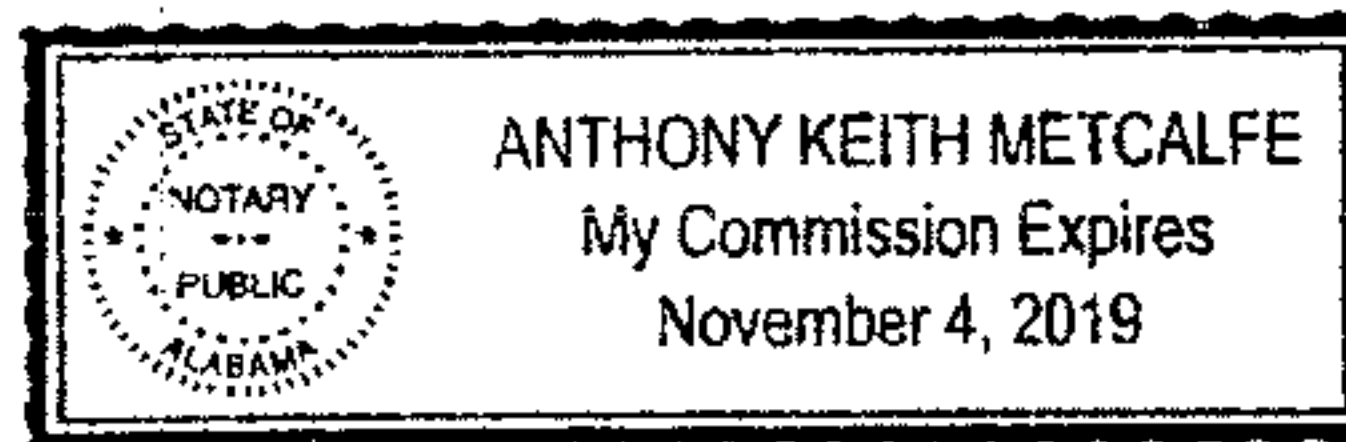
