
ORDINANCE NO. 135-208



AN ORDINANCE OF THE CITY OF PELHAM, PROVIDING THAT THE CODE OF ORDINANCES, CITY OF PELHAM, ALABAMA, BE AMENDED BY ADDING A SECTION TO BE NUMBERED 135-208 PROVIDING THE FOLLOWING AMENDMENT TO THE ZONING ORDINANCE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA AS FOLLOWS:

SECTION ONE: The zoning of property located on County Road 105 (Bearden Road) across from Pelham High School to be rezoned from R-T Residential Townhouse District to R-G Residential Garden Home District. Applicant: J.R. Adams.

SECTION TWO: All ordinances or parts of ordinances, in any manner conflicting herewith are hereby repealed.




