

## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 20th day of December, 2012, KIMBERLEY T. BARDEN, HUSBAND, WILLIAM MULLINS executed that certain mortgage on real property hereinafter described to JPMORGAN CHASE BANK N.A., which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on January 15, 2013, at Instrument Number 20130115000020290, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **NATIONSTAR MORTGAGE LLC**, by instrument recorded in Instrument Numbers 2013031300007802 & 2015043000014150, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, default was made in accordance with the loan terms, and Nationstar Mortgage LLC did declare due all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of 12/30/2015, 01/06/2016, 01/13/2016, that the property would be sold on January 25, 2016; and

WHEREAS, on January 25, 2016, the day on which the foreclosure was due to be held under the terms of the said notice, between the legal hours of sale, said foreclosure was duly conducted, and Nationstar Mortgage LLC did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described; and




