**KNOW ALL MEN BY THESE PRESENTS,**

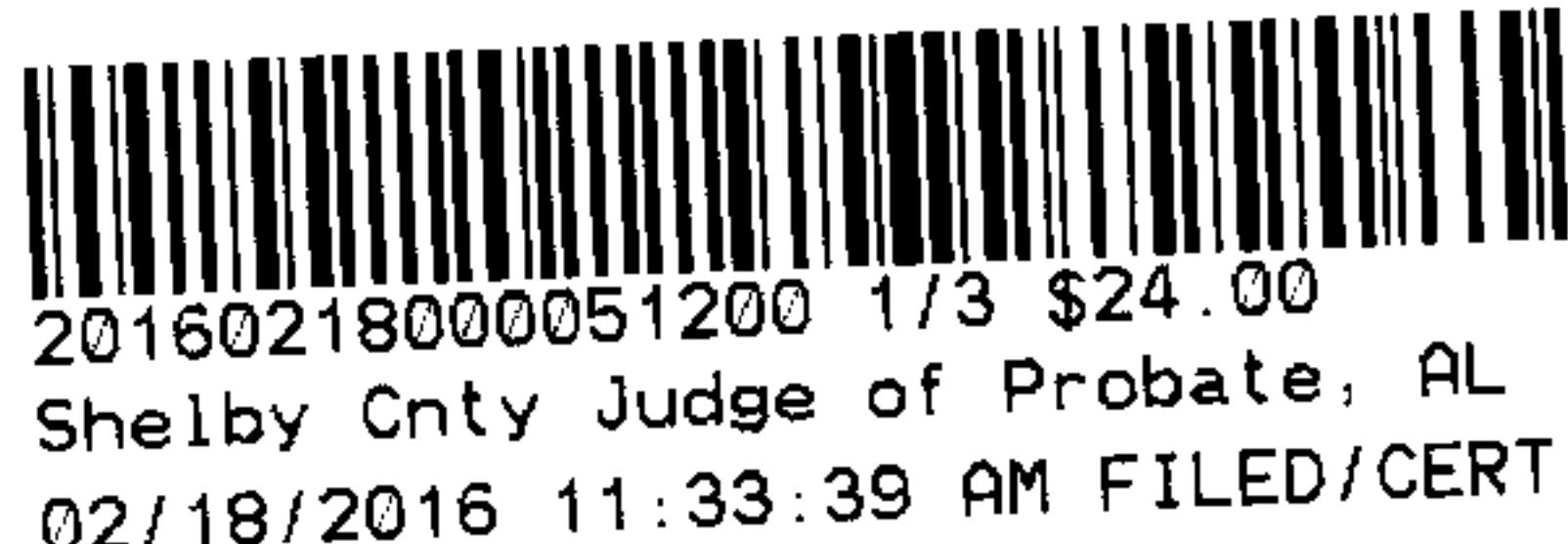
**On this February 17, 2016**, That for and in consideration of **TWO HUNDRED SEVEN**

for and during their joint lives and upon the death of either, then to the survivor of them in fee simple,

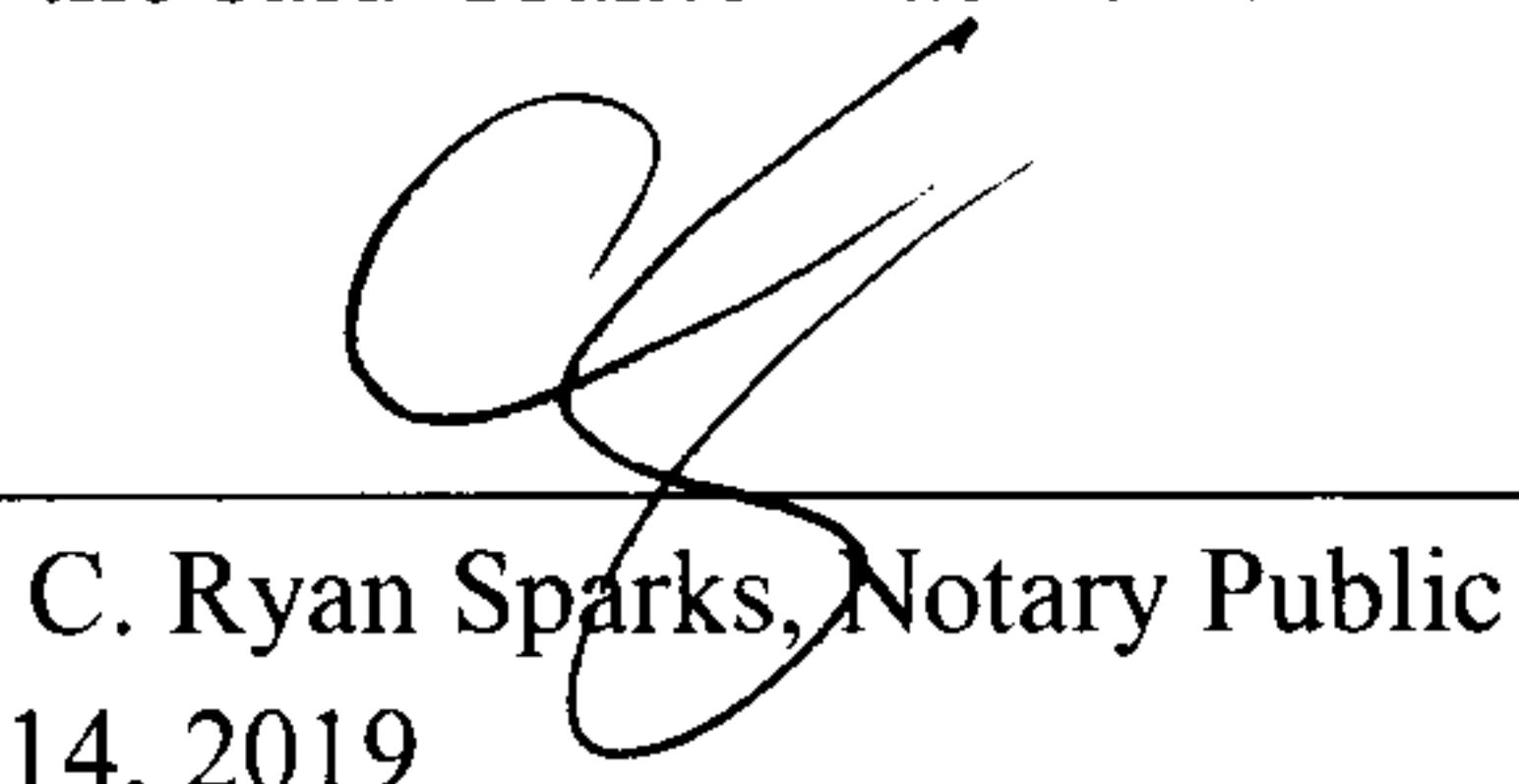

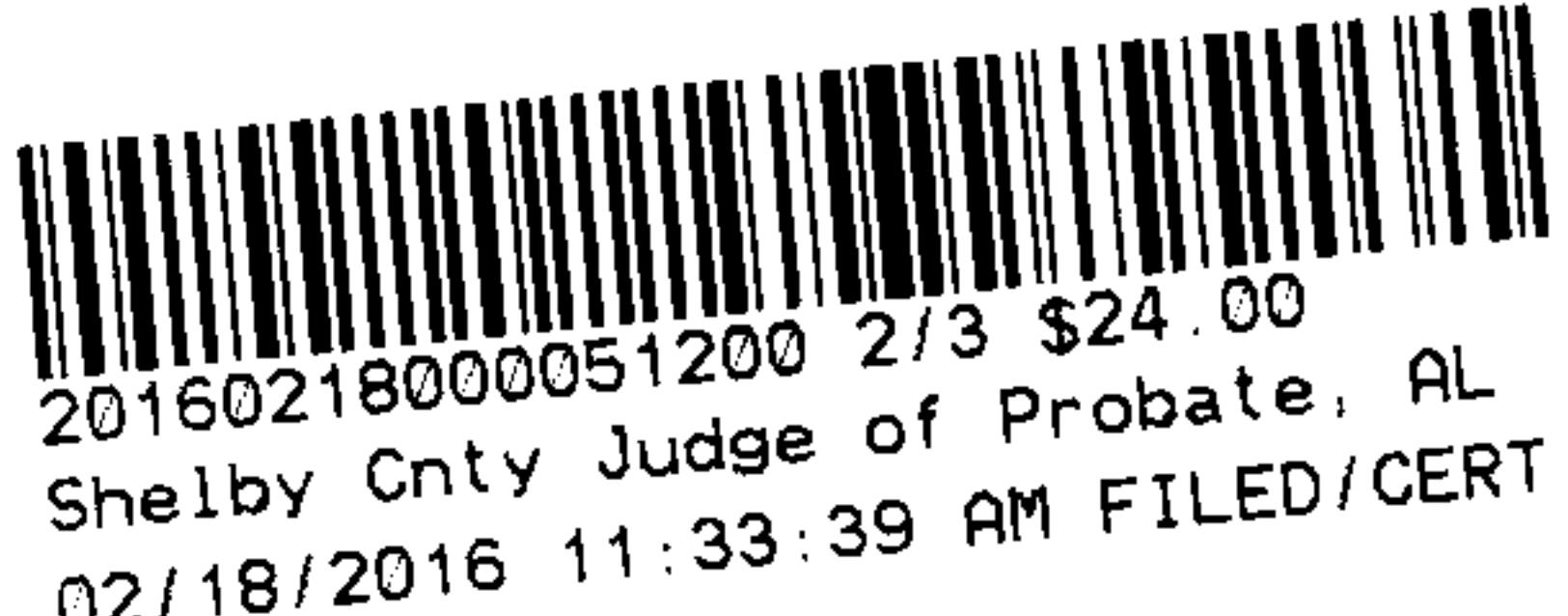
