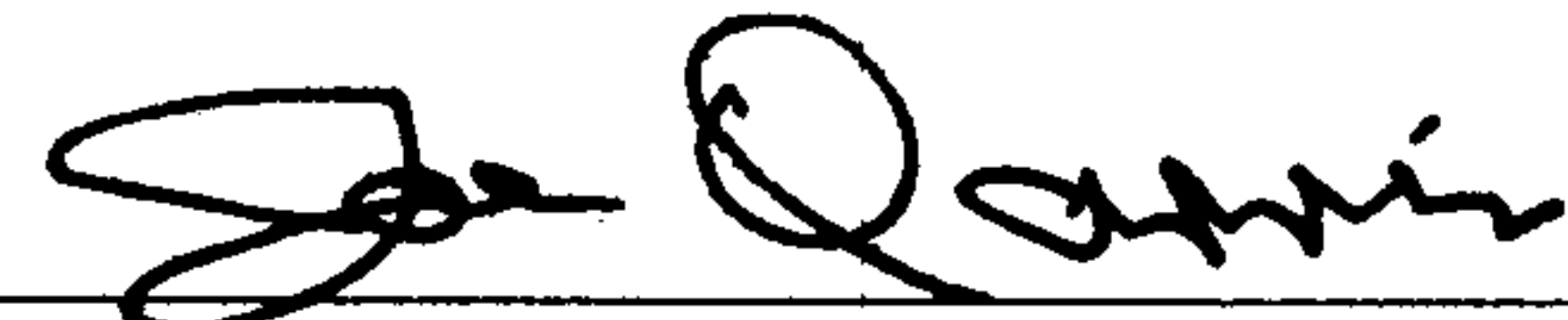

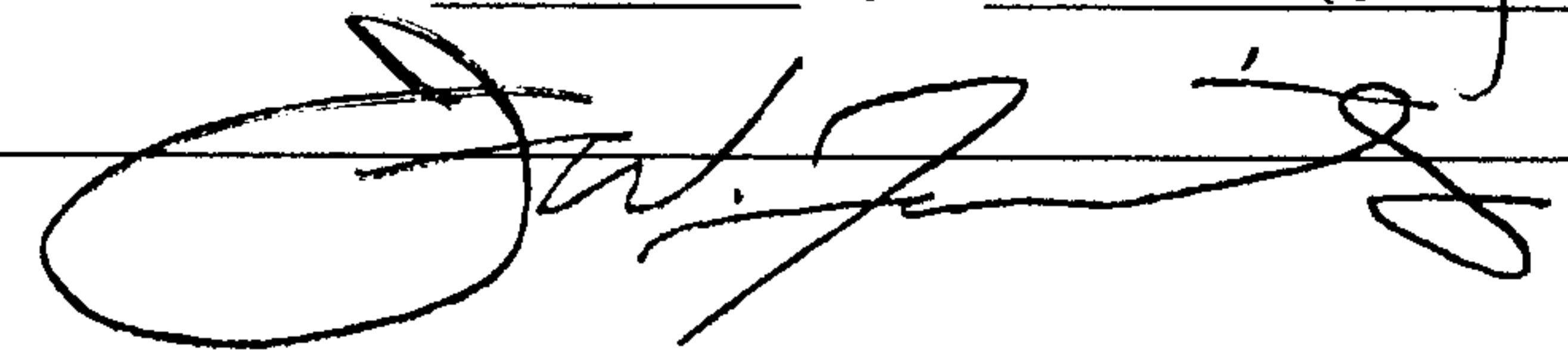

**POWER OF ATTORNEY

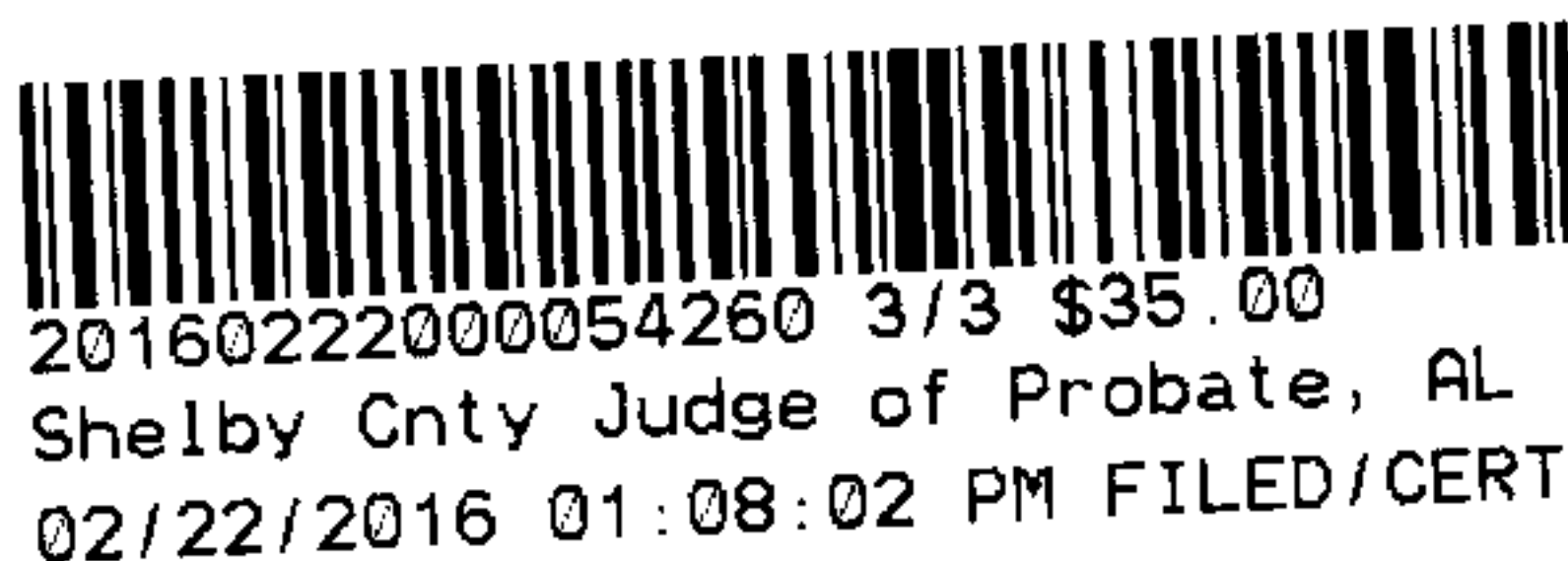
