Subject to: current taxes, easements, restrictions, and rights-of-way of record.

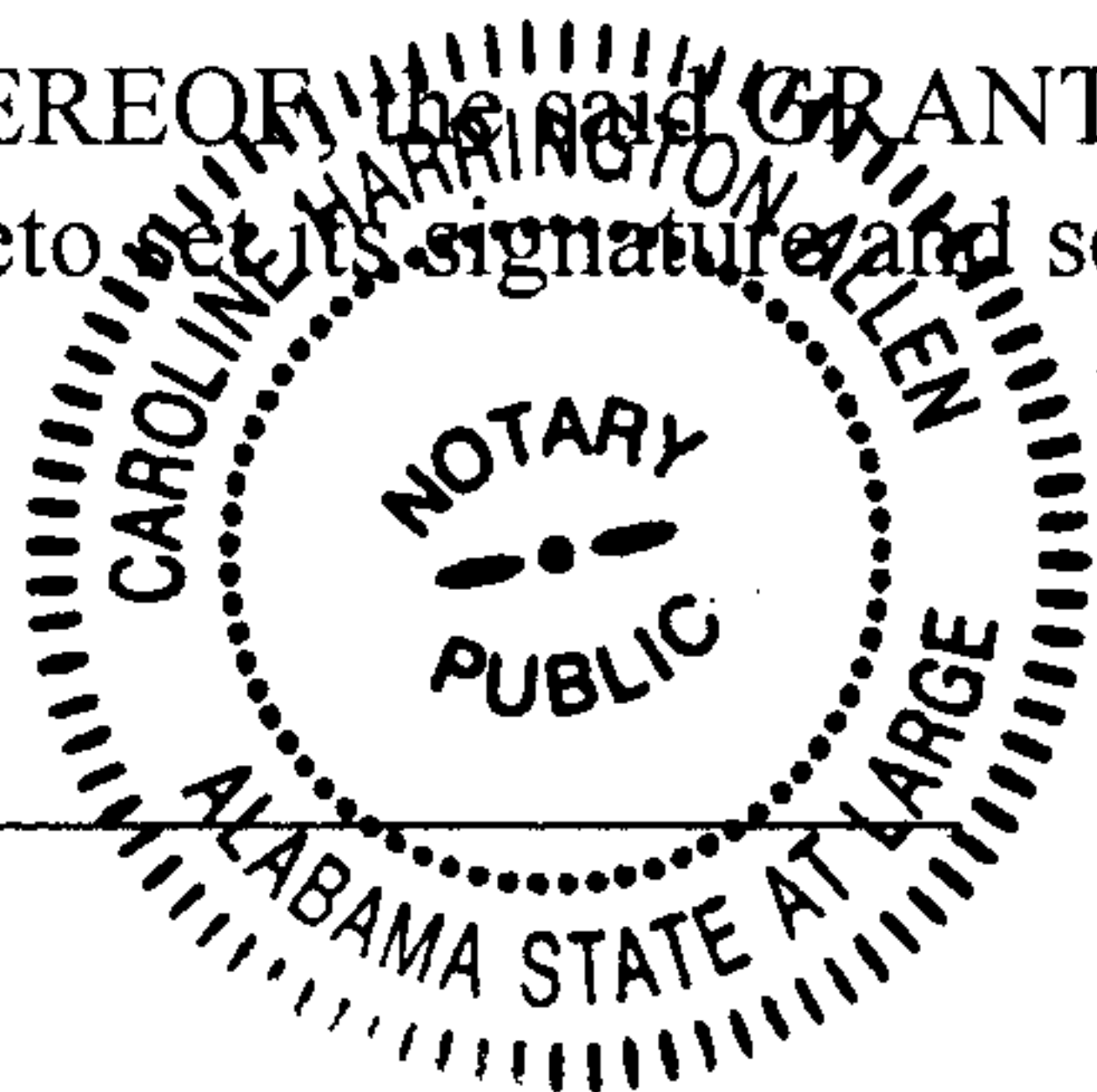

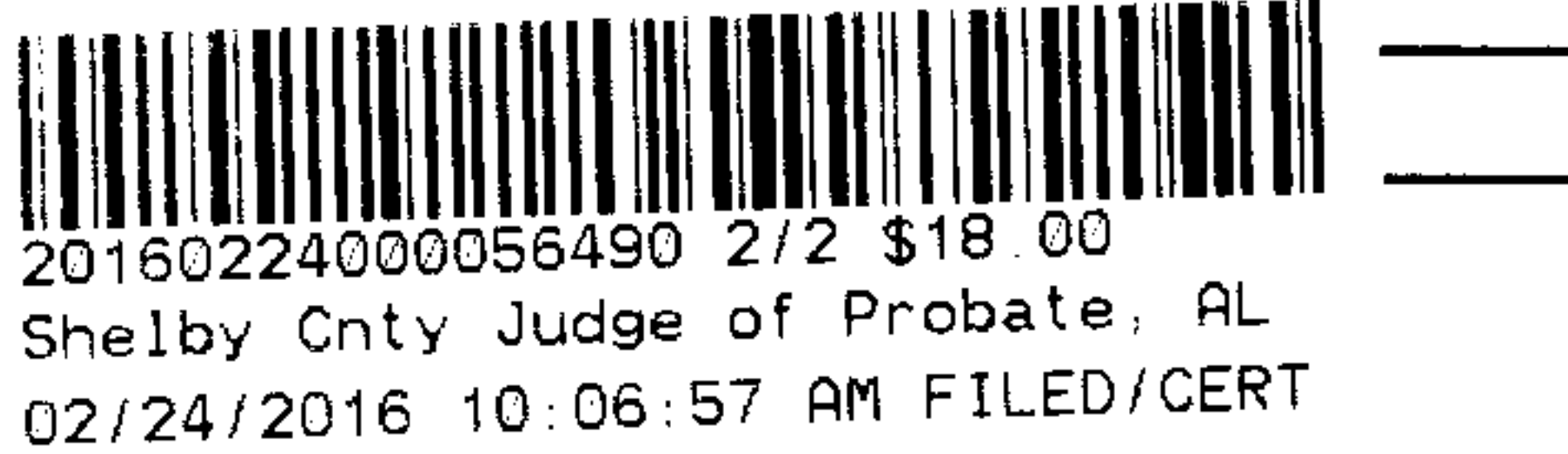
