KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of March, 2009, Alan C. Black, a married person, spouse Cecelia W. 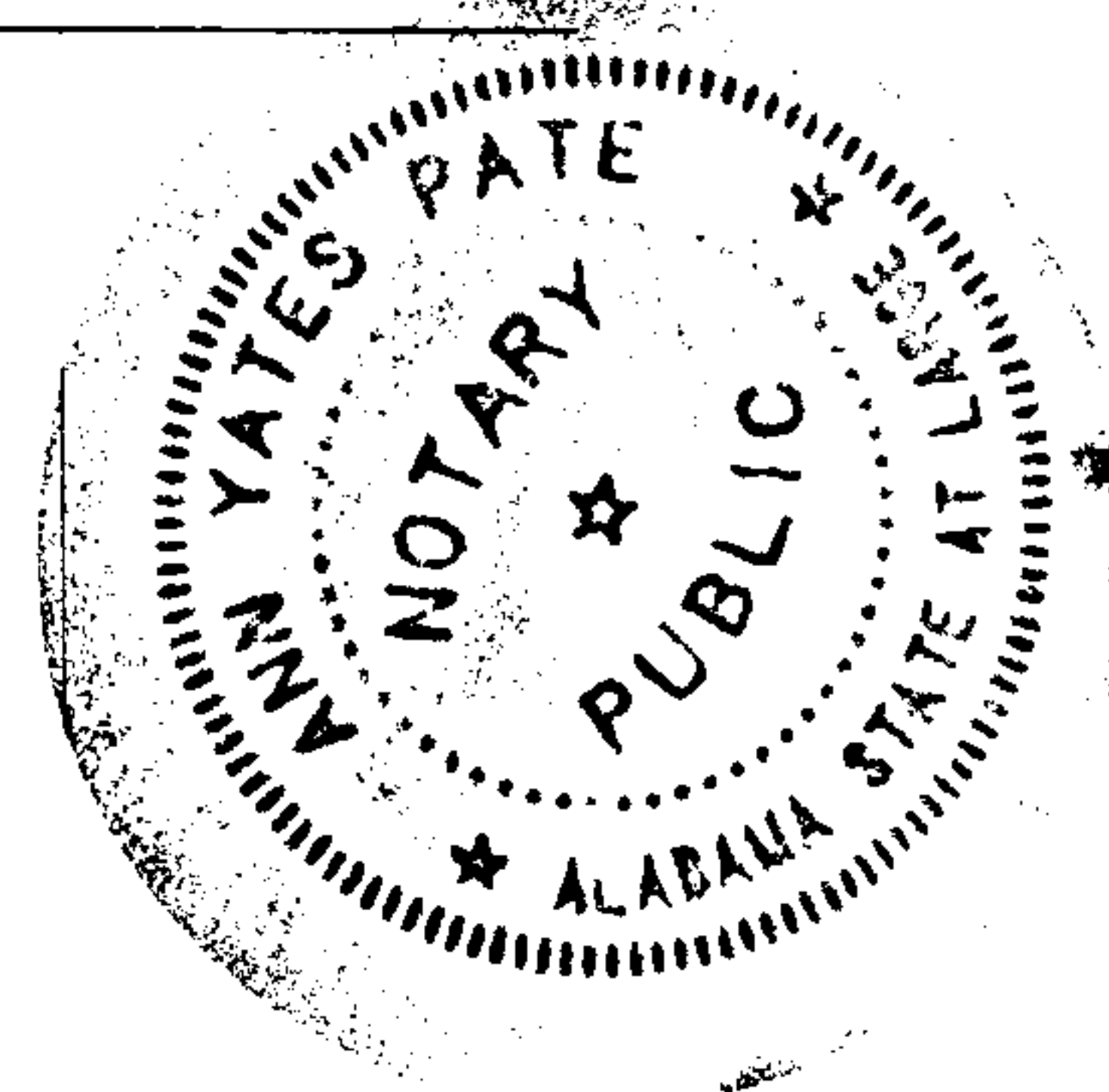
