The purchase of the herein described real property is being financed in whole or in part by the proceeds of purchase money mortgages being executed simultaneously herewith.

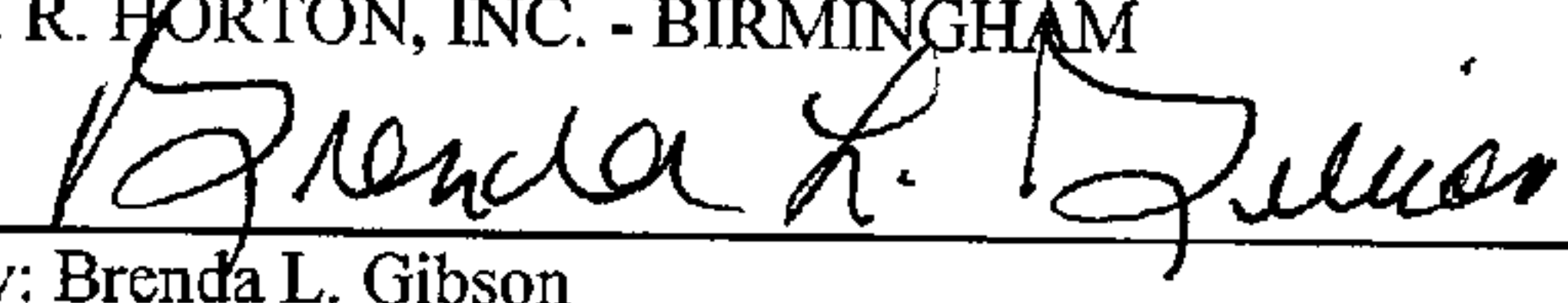
