A copy of the name reservation certificate from the Office of the Secretary of State is attached hereto and incorporated herein by reference.

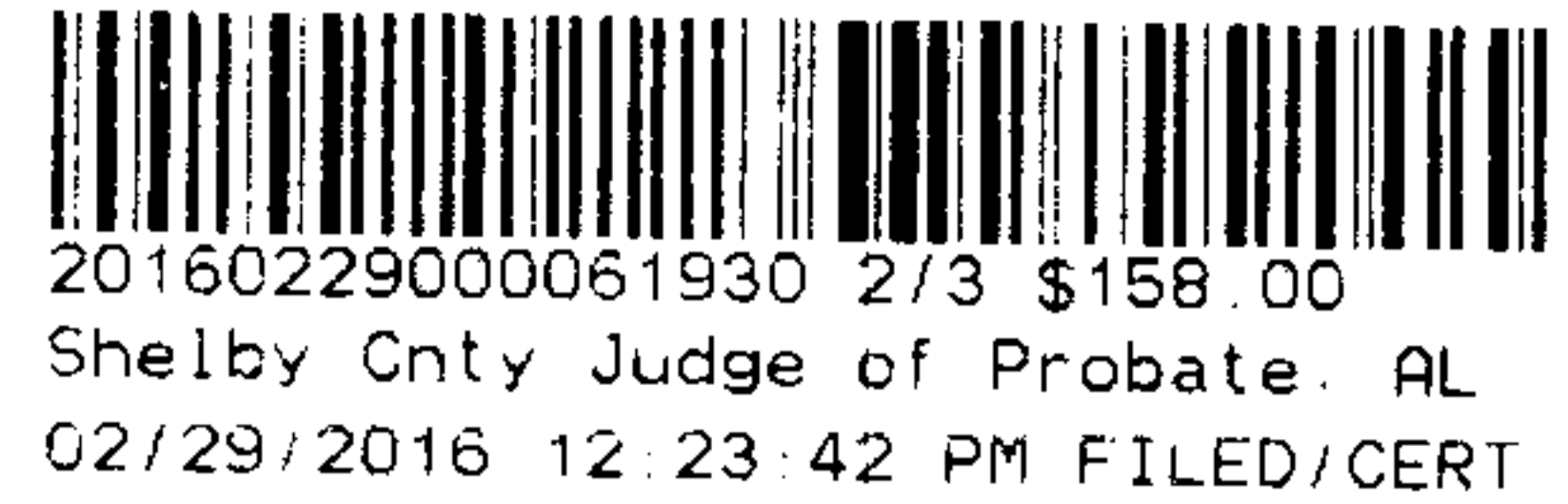
### ARTICLE THREE
