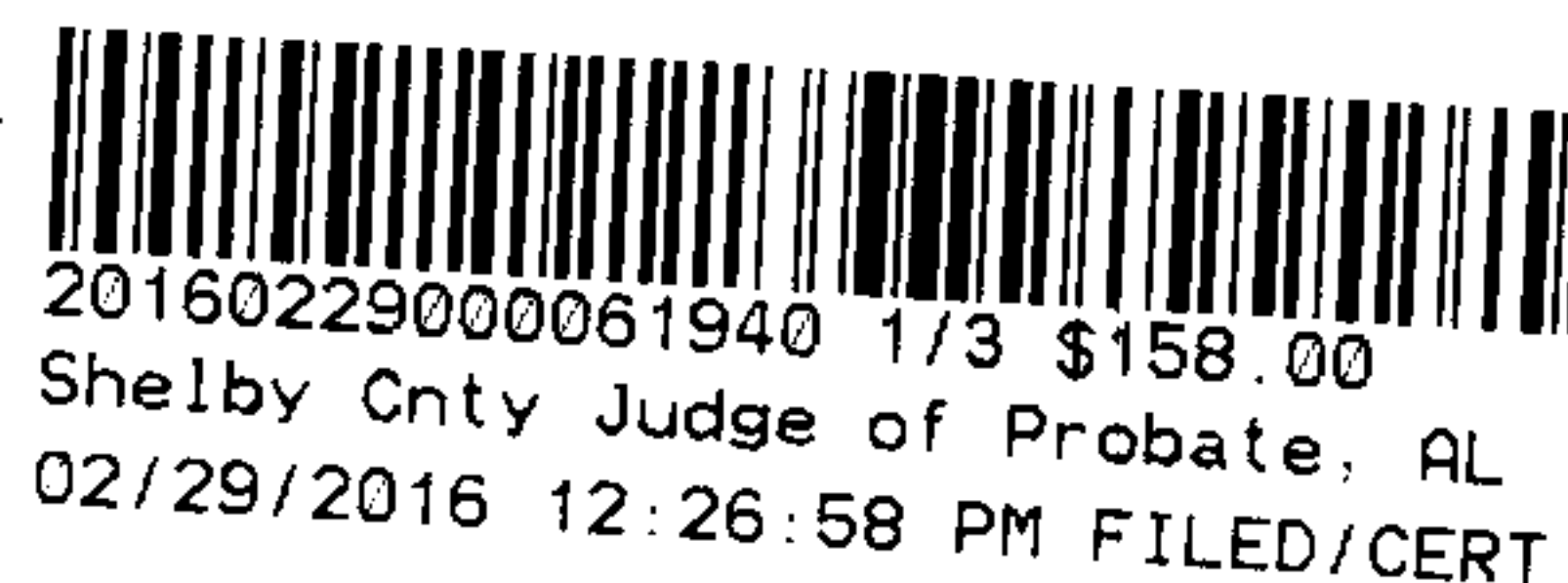


Effective Date

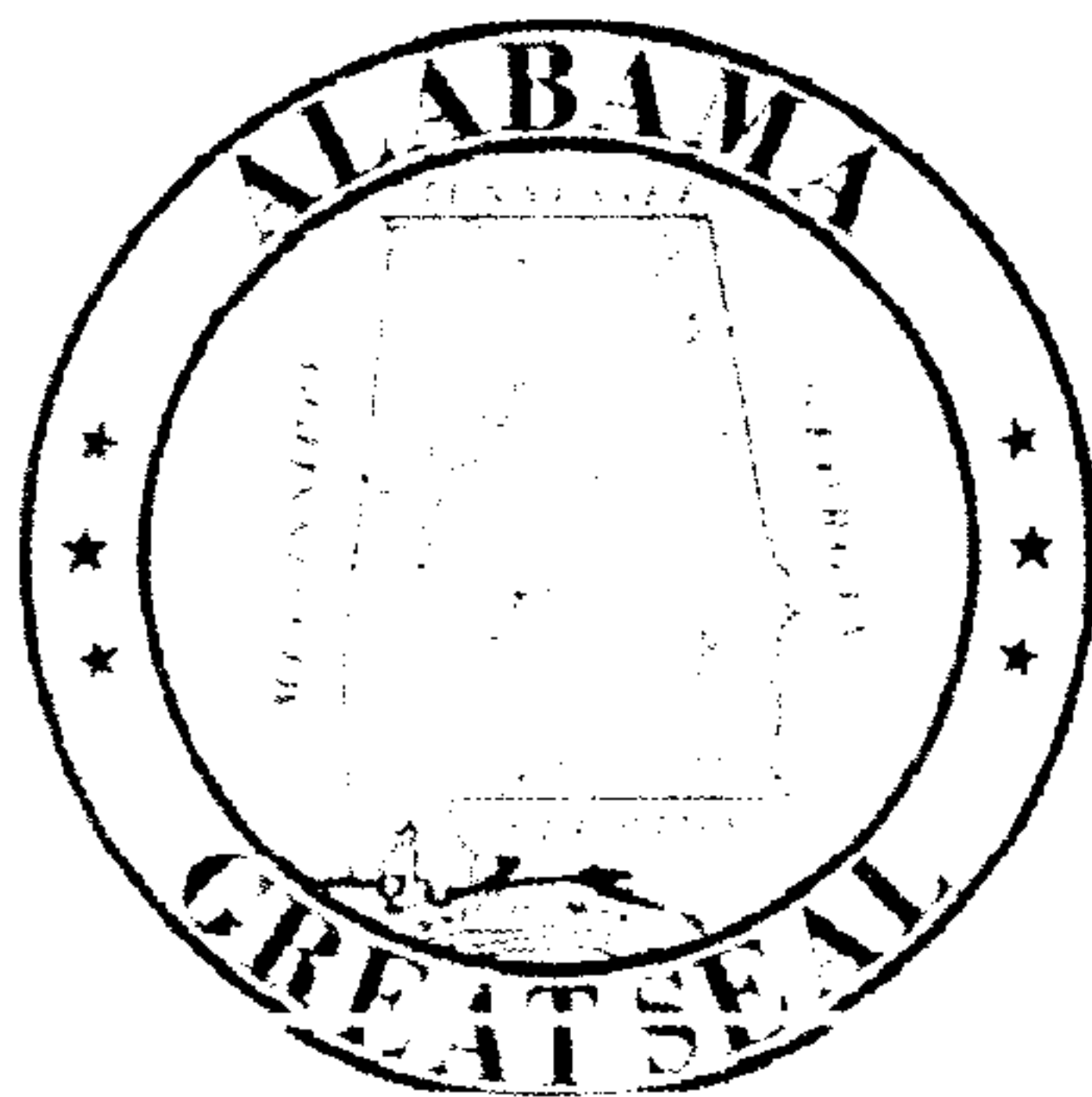
