PROVIDED.

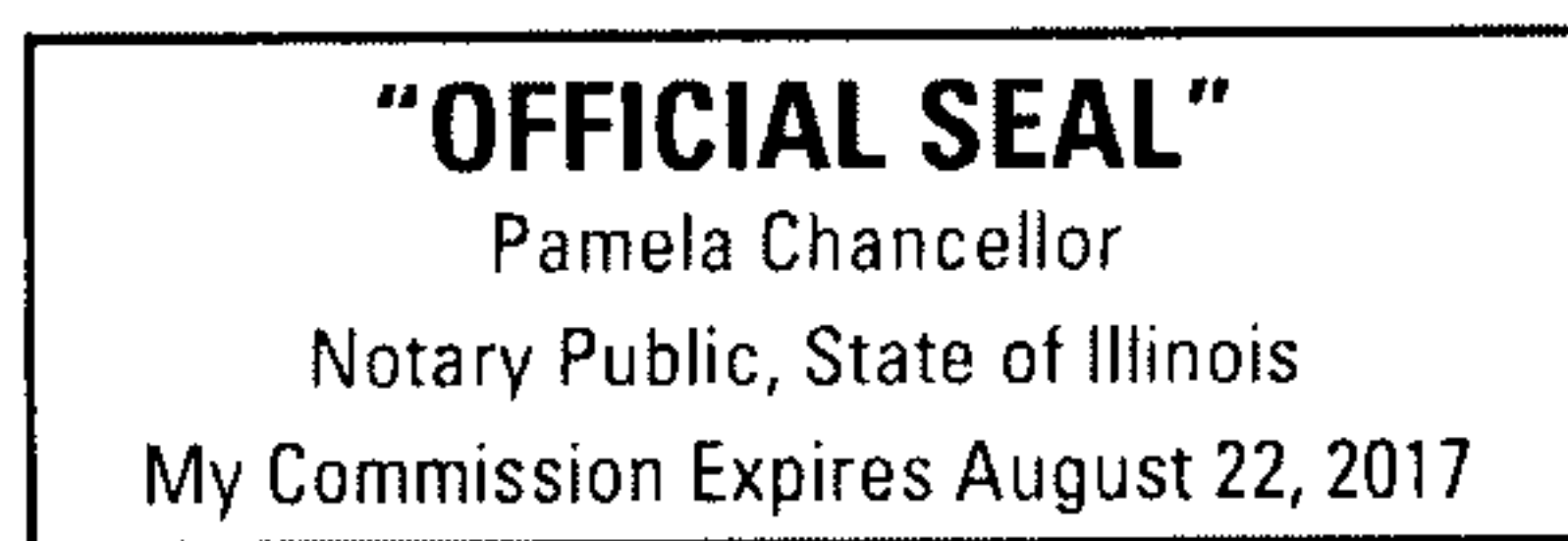
