WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **One Hundred Forty-Eight Thousand Five Hundred and 00/100 Dollars (\$148,500)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Ben Nelson, and his wife, Cassidy Harrison

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

William Oldfield and Elizabeth Oldfield

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 19, according to the Survey of Berryhill 3rd Sector, as recorded in Map Book 16, page 28, in the Probate Office of Shelby County, Alabama.

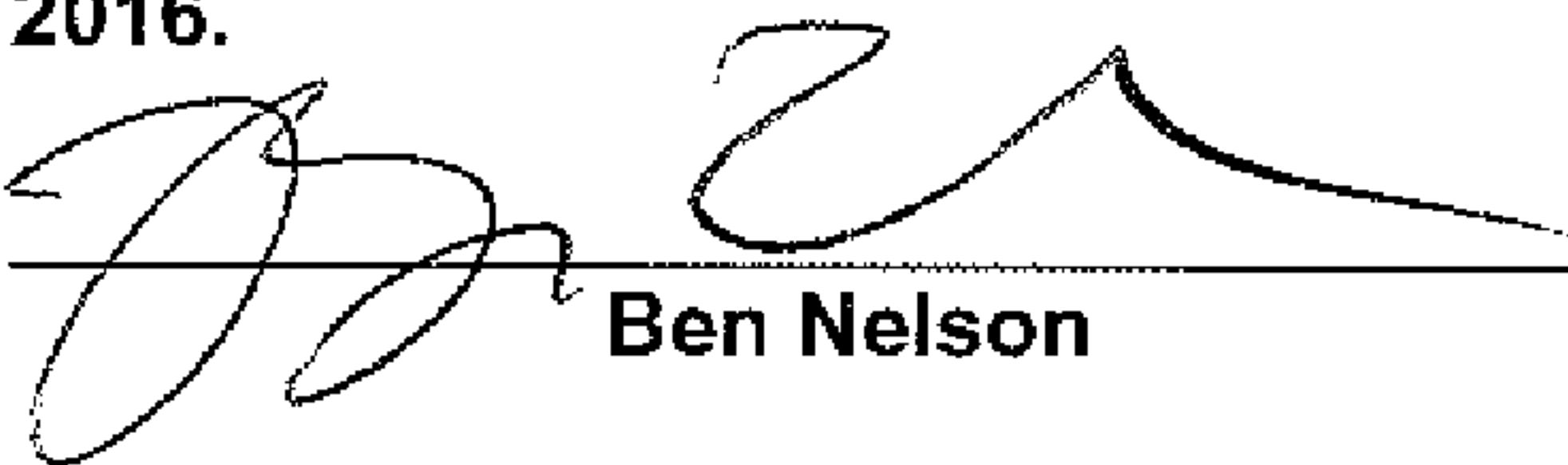
\$142,025 of the proceeds come from a mortgage recorded simultaneously herewith.

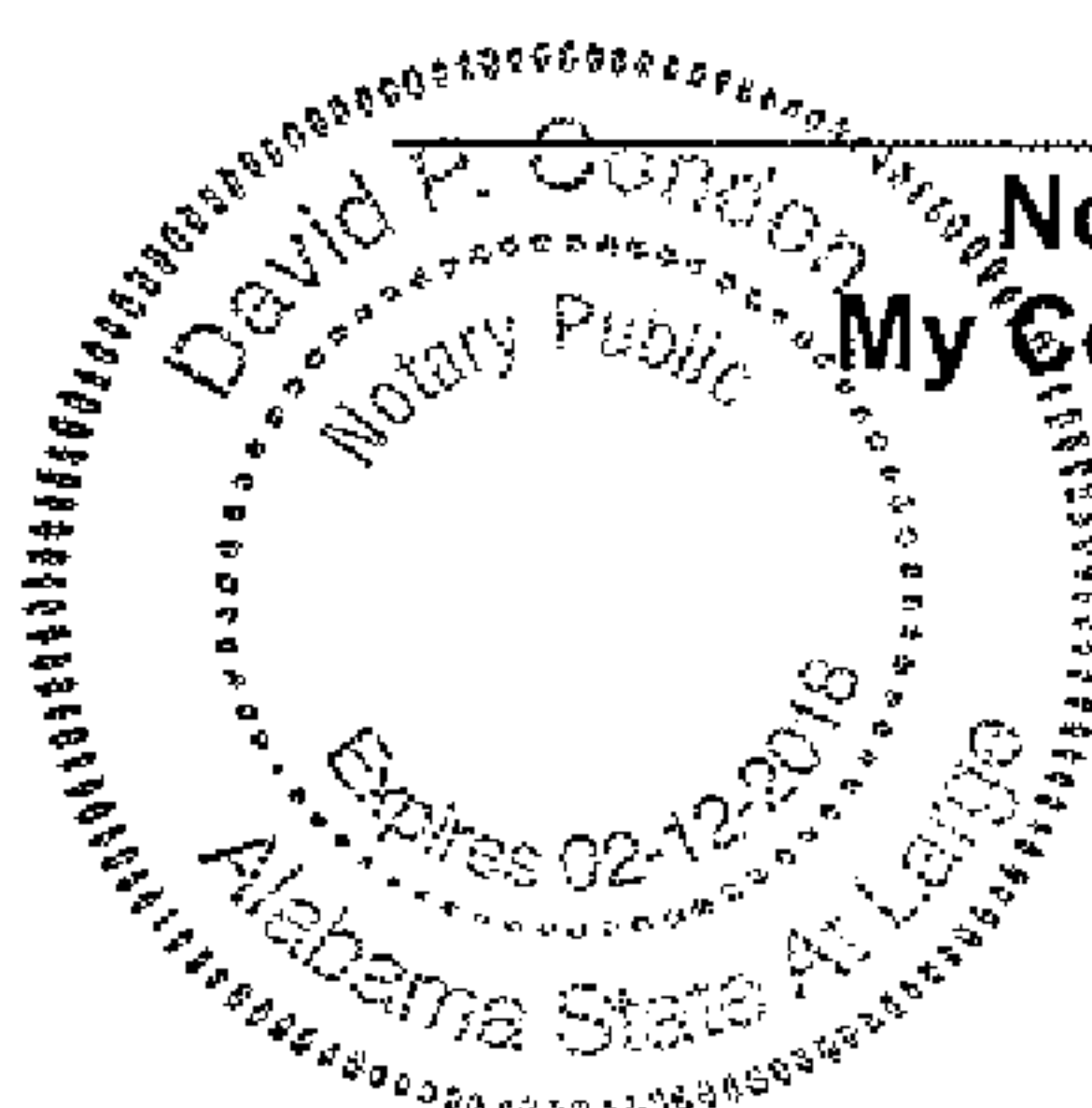

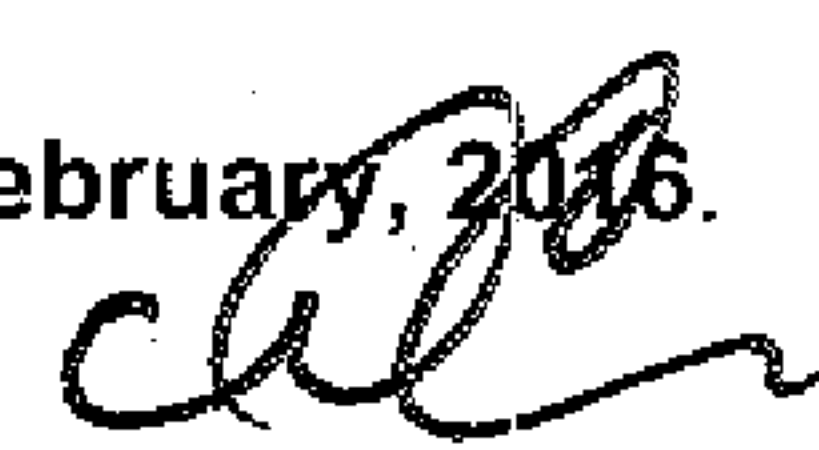
