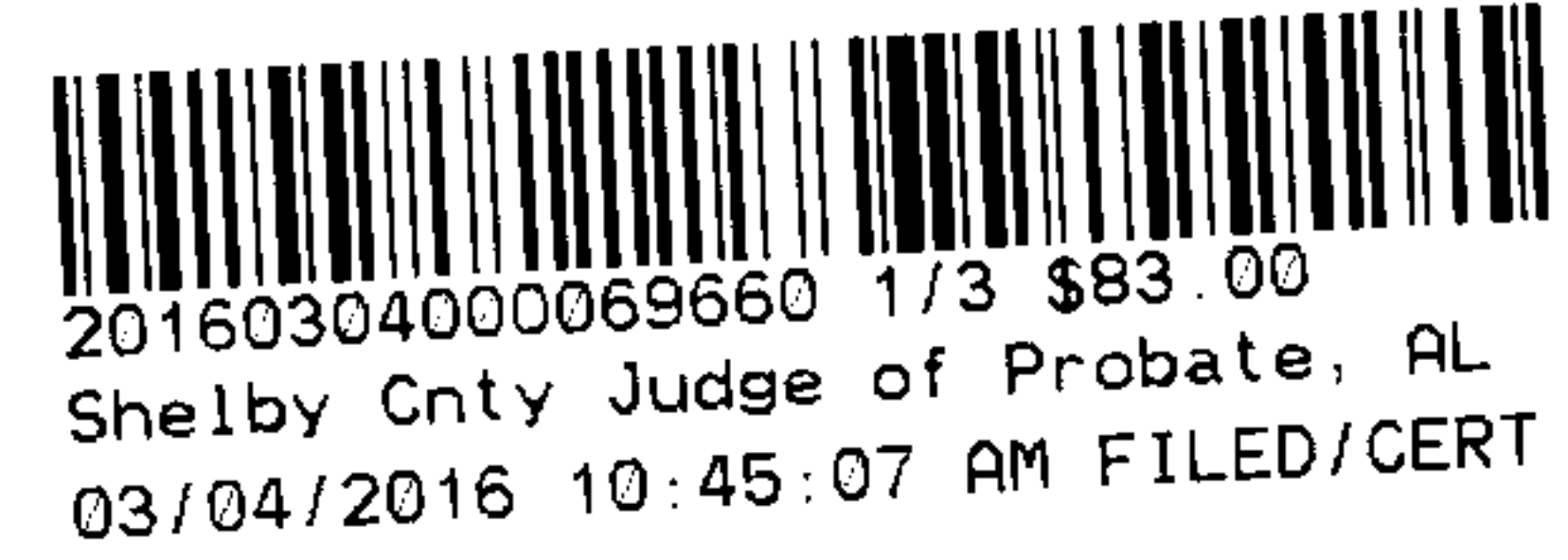


**AMENDED ARTICLES OF INCORPORATION

The name of the corporation has been changed to Institute for Defending Freedom's Orphans.




6.01 Membership
