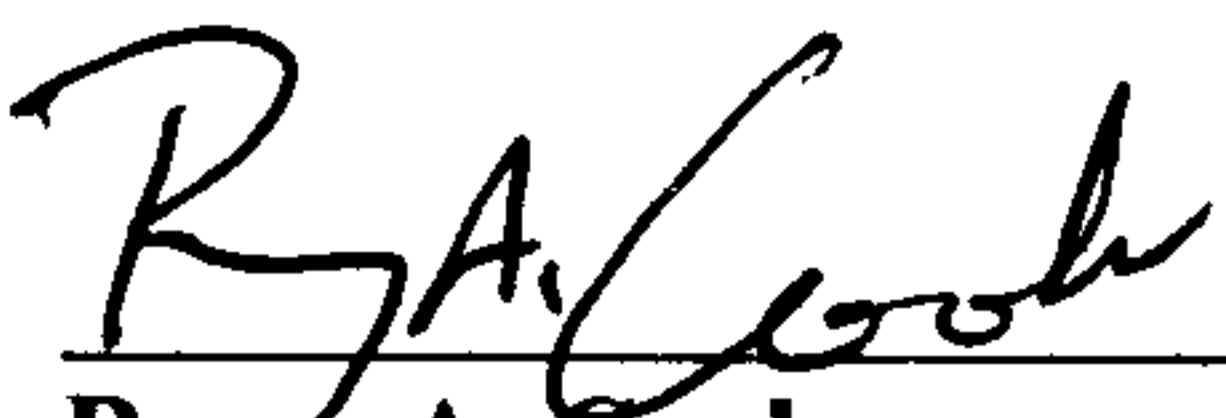

2. Easements, restrictions, rights of way, and permits of record.

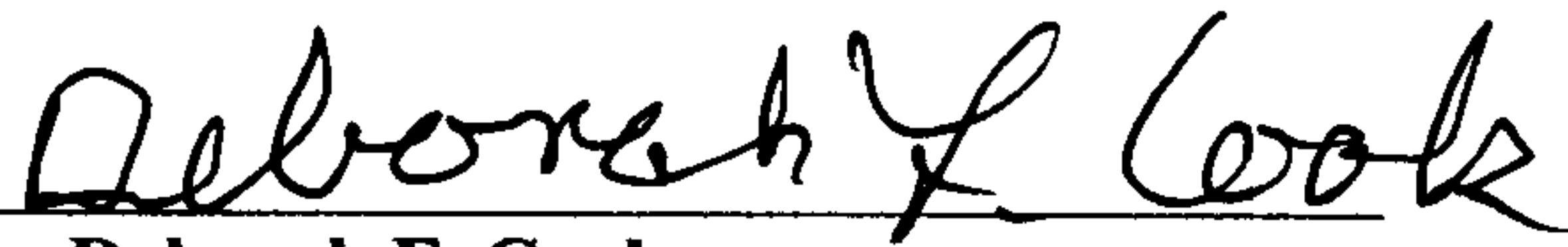

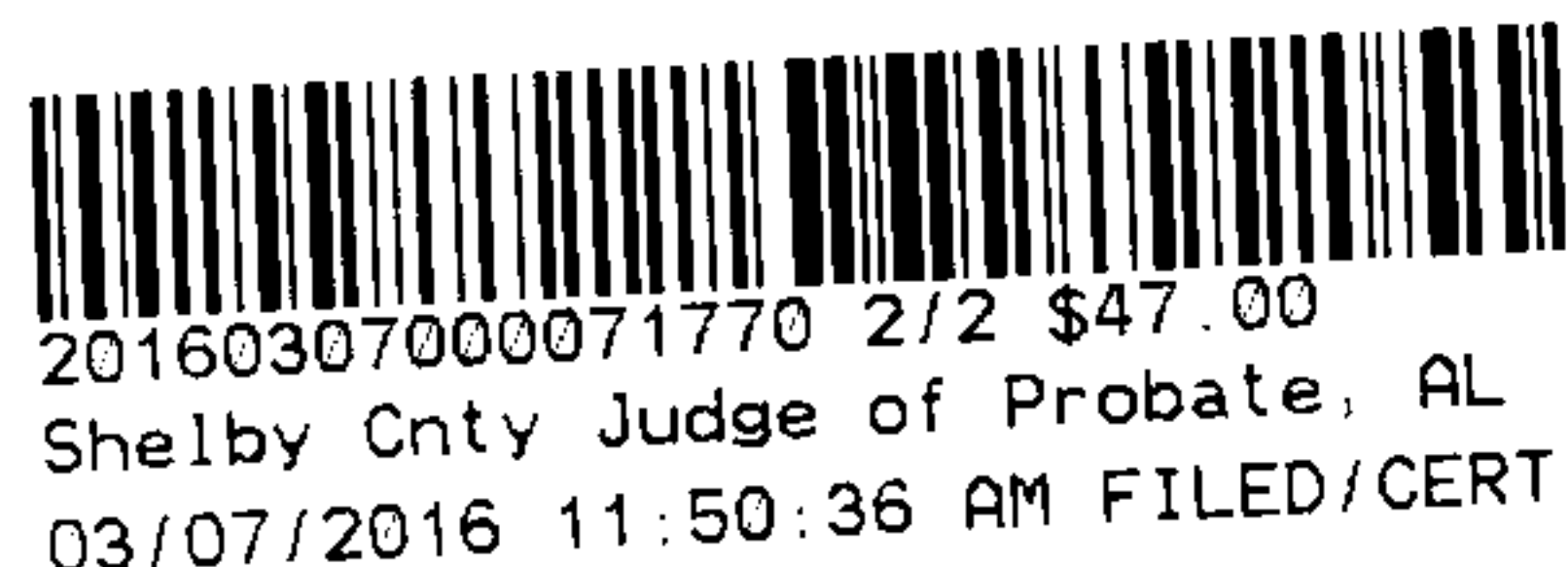
