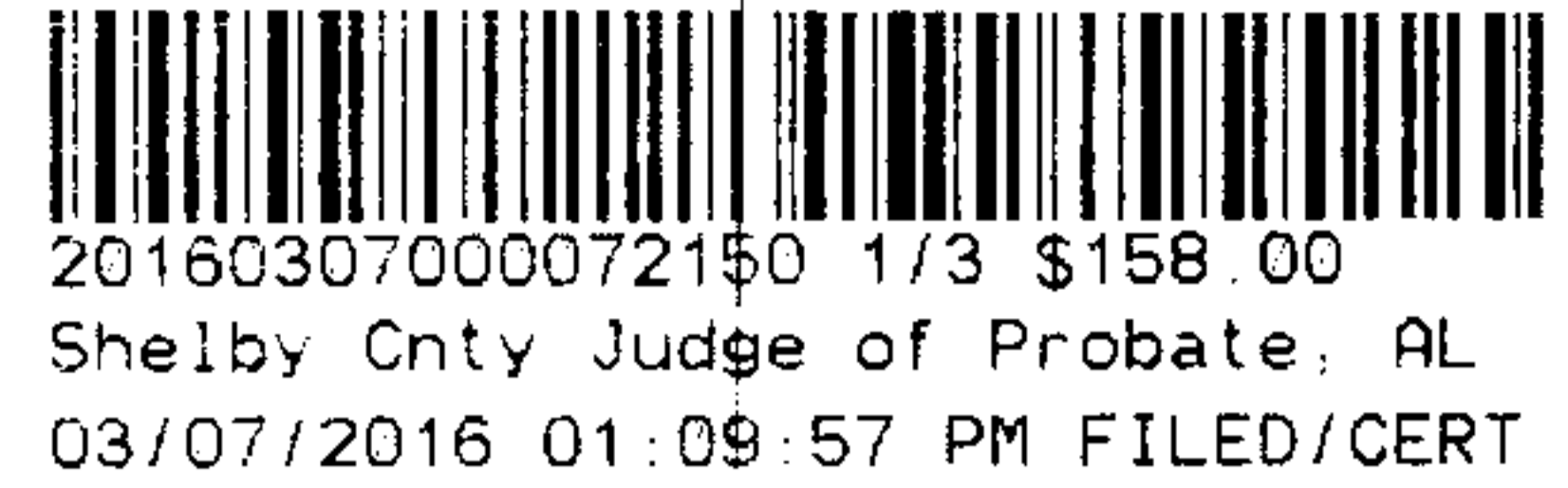


CERTIFICATE OF FORMATION

OF

HZC Holdings, LLC



Pursuant to the Provisions of The Alabama Limited Liability Company Law of 2014, the undersigned hereby adopt the following Limited Liability Company Certificate of Formation.

ARTICLE I

The name of the limited liability company is HZC Holdings, LLC, (the "Company").

ARTICLE II

The Company shall have perpetual duration from the date of organization unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Law of 2014, or the Operating Agreement of the Members.

- (b) To engage in any other lawful business of any kind or character whatsoever as the Member(s) should decide is prudent and in the best interest of the Company; and

ARTICLE IV

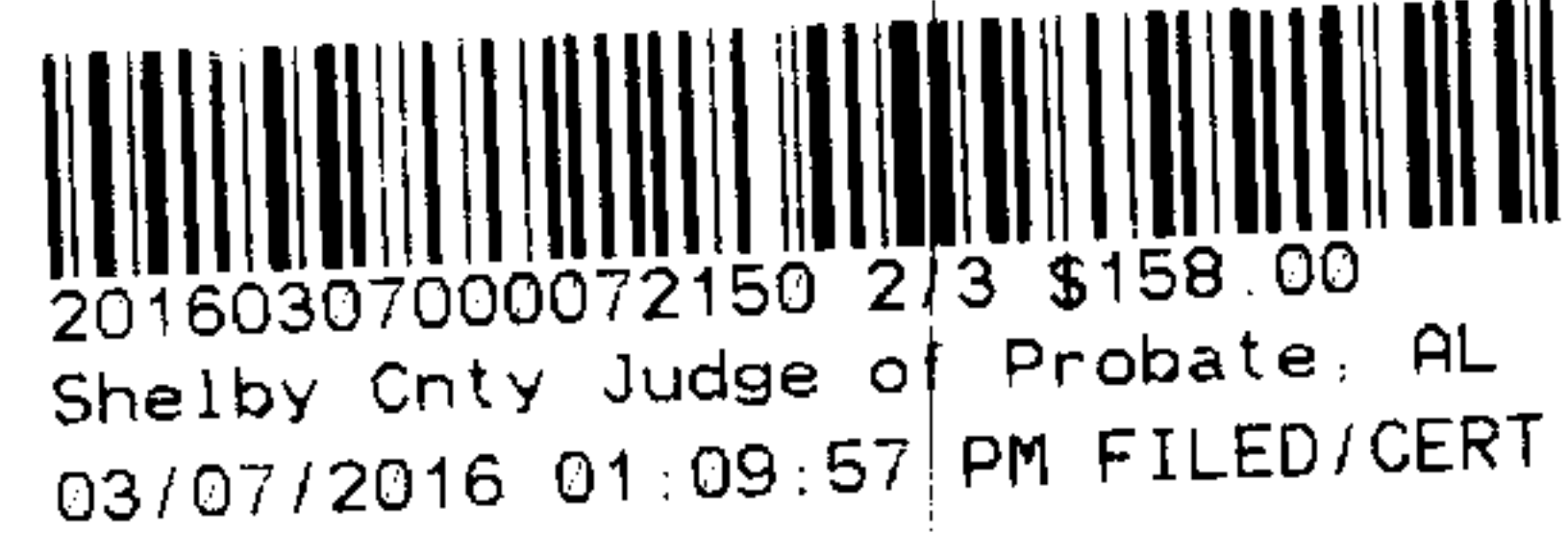

The Company shall have one or more members.



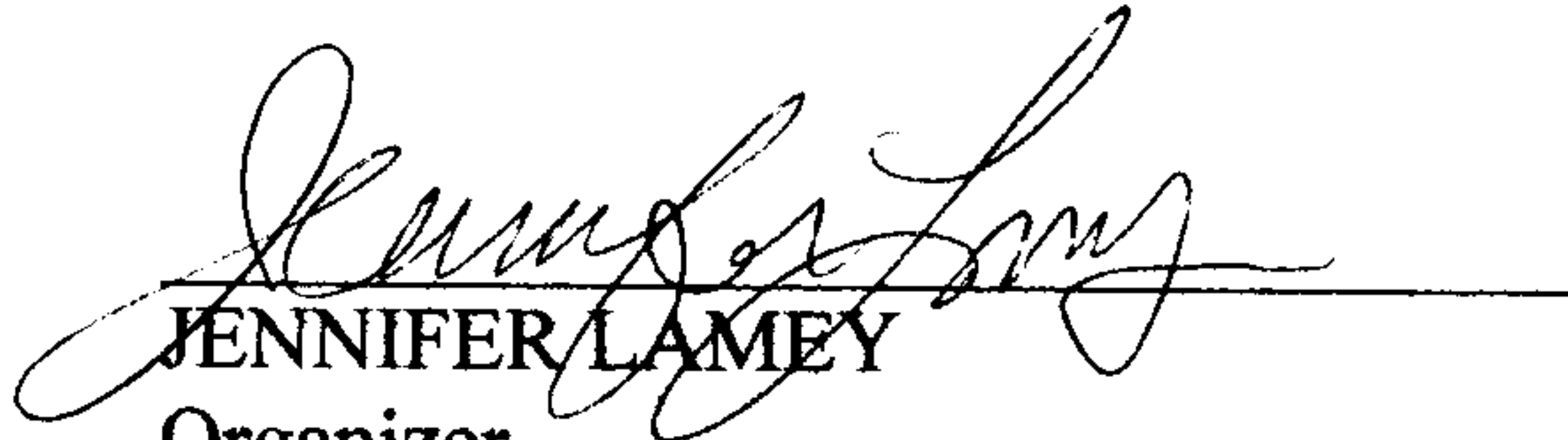
ARTICLE VII

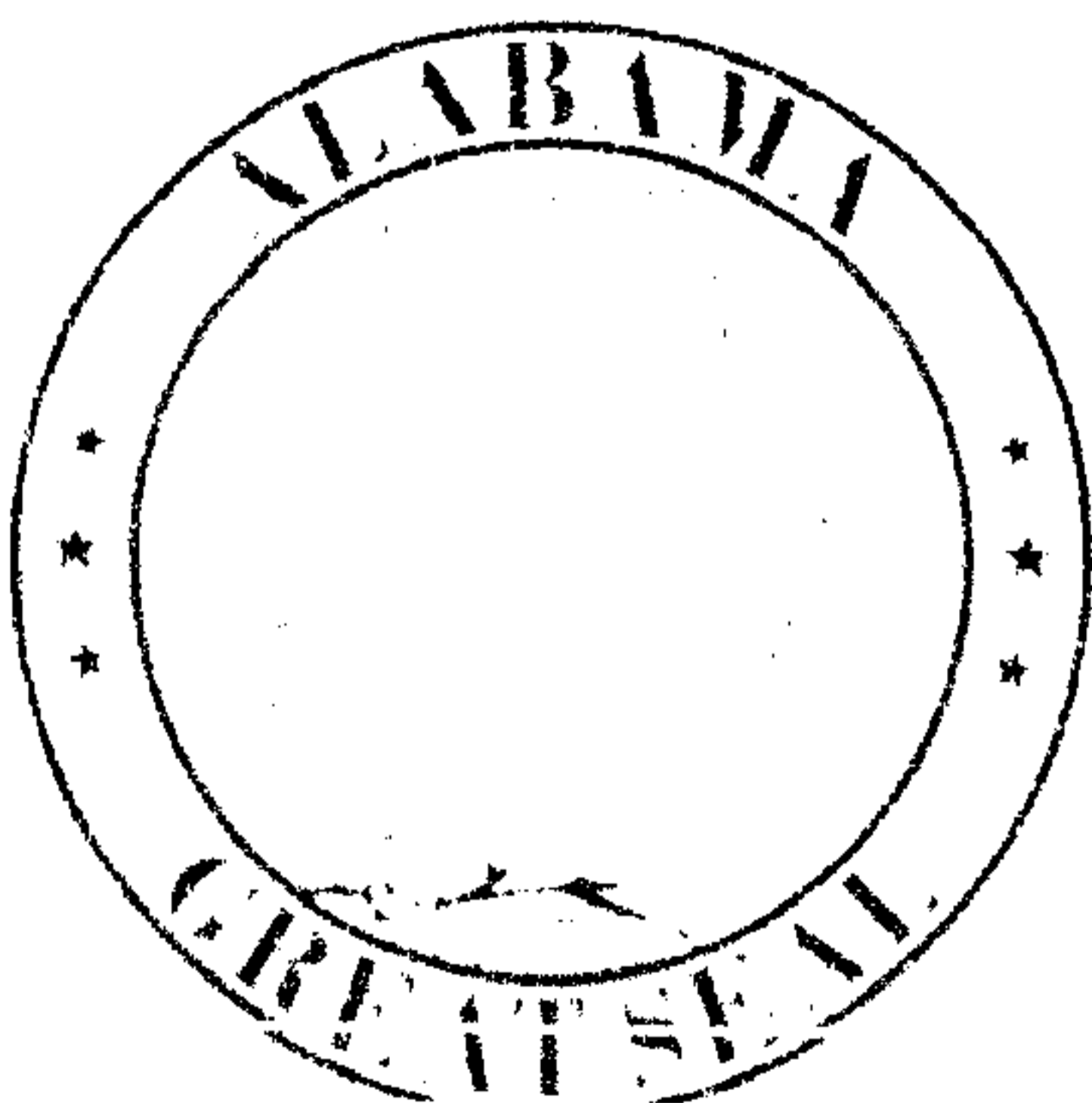
