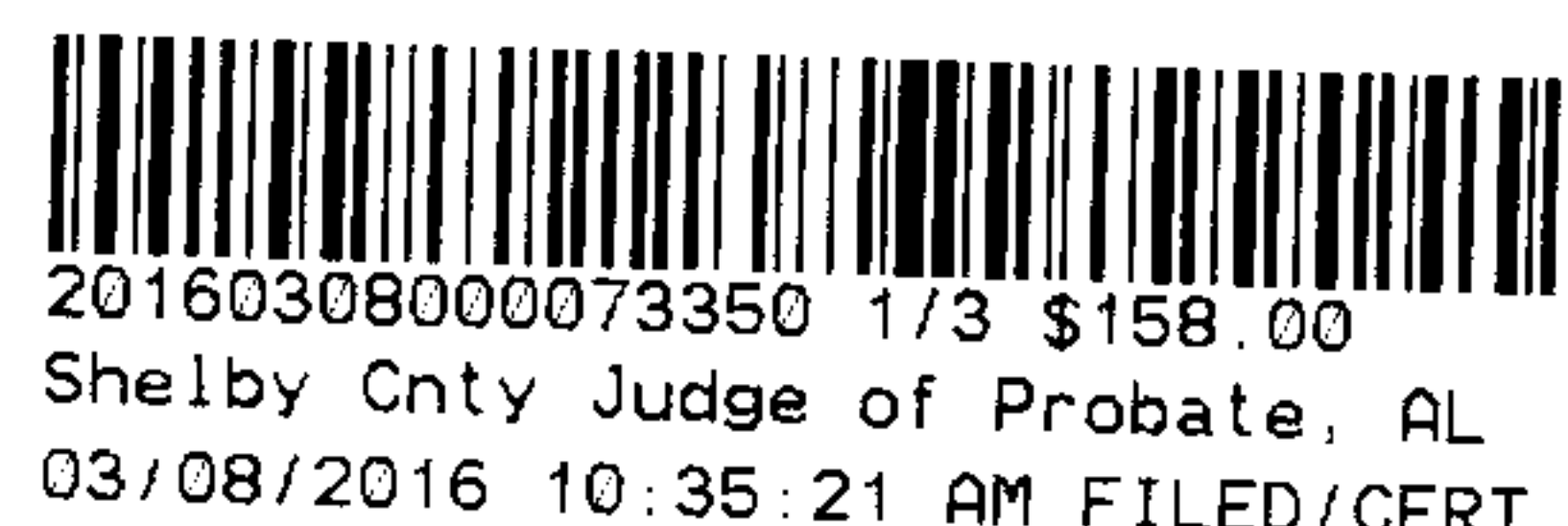
CERTIFICATE OF FORMATION  
(ARTICLES OF ORGANIZATION)

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certify as follows:

8. The members of the limited liability company shall have the right to admit additional members to the limited liability company upon the unanimous consent of all the members of the limited liability company.




9. The cessation of membership shall not result in dissolution unless there are no remaining members.
