CERTIFICATE OF FORMATION

OF

The undersigned, for the purpose of forming a limited liability company under the Alabama Limited Liability Company Law of 2014, Title 10A, Chapters 1 (to the extent applicable to limited liability companies) and 5A of the Code of Alabama (1975), as amended (the "Law"), hereby files the following Certificate of Formation and attests that the facts stated in this Certificate of Formation are true and correct:

1. **Name.** The name of the entity being formed (hereinafter referred to as the "Company") is Satterfield Acquisitions, LLC.
2. **Type.** The Company is being formed as a limited liability company.
3. **Purposes.** The Company has been organized for the purpose of transacting any lawful business for which a limited liability company may be formed under the Law.
4. **Duration.** The period of the Company's duration shall be perpetual.

11. **Effective Date.** This Certificate of Formation shall be effective immediately on the date it is filed with the judge of probate of the county listed above.

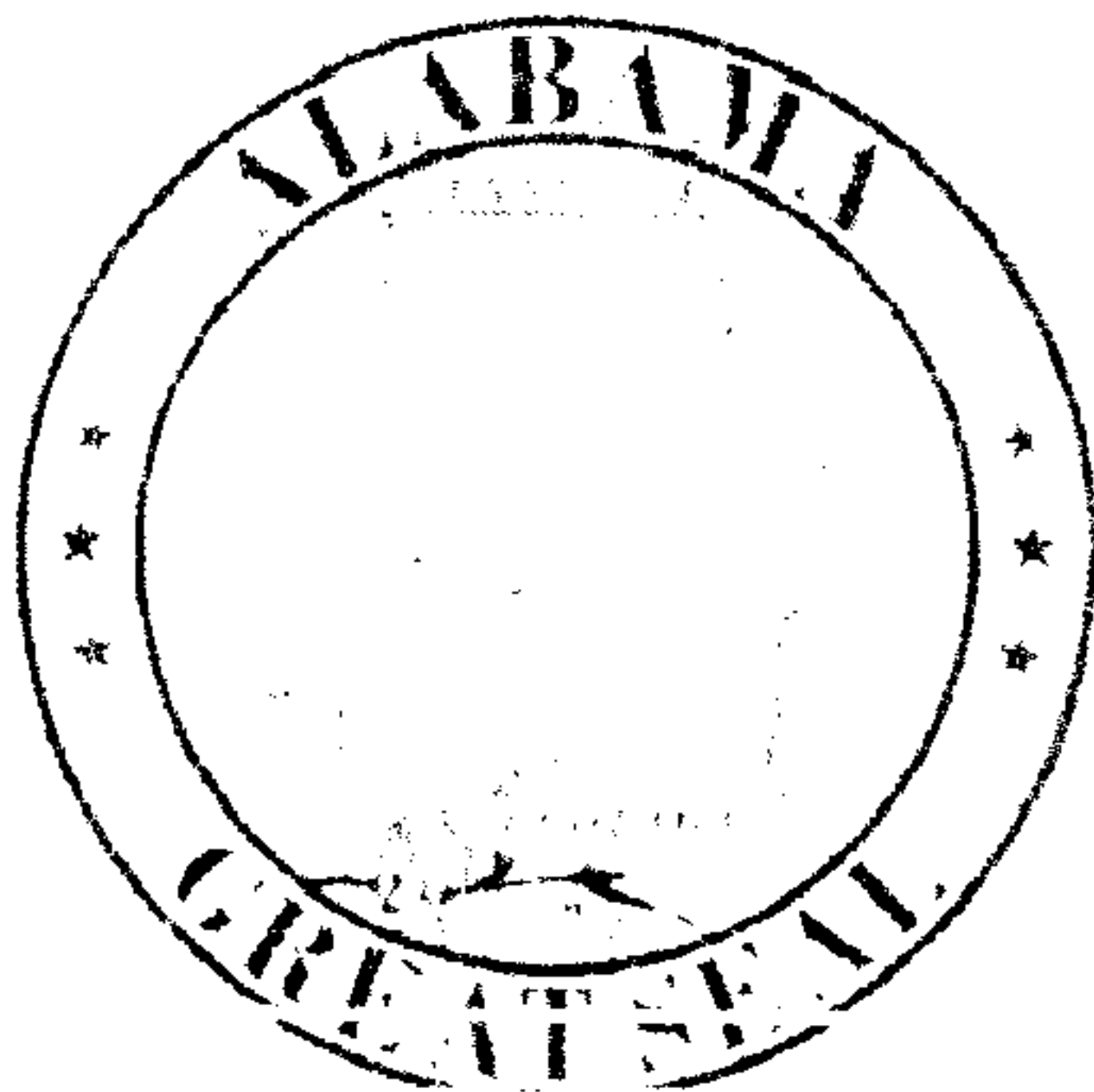
