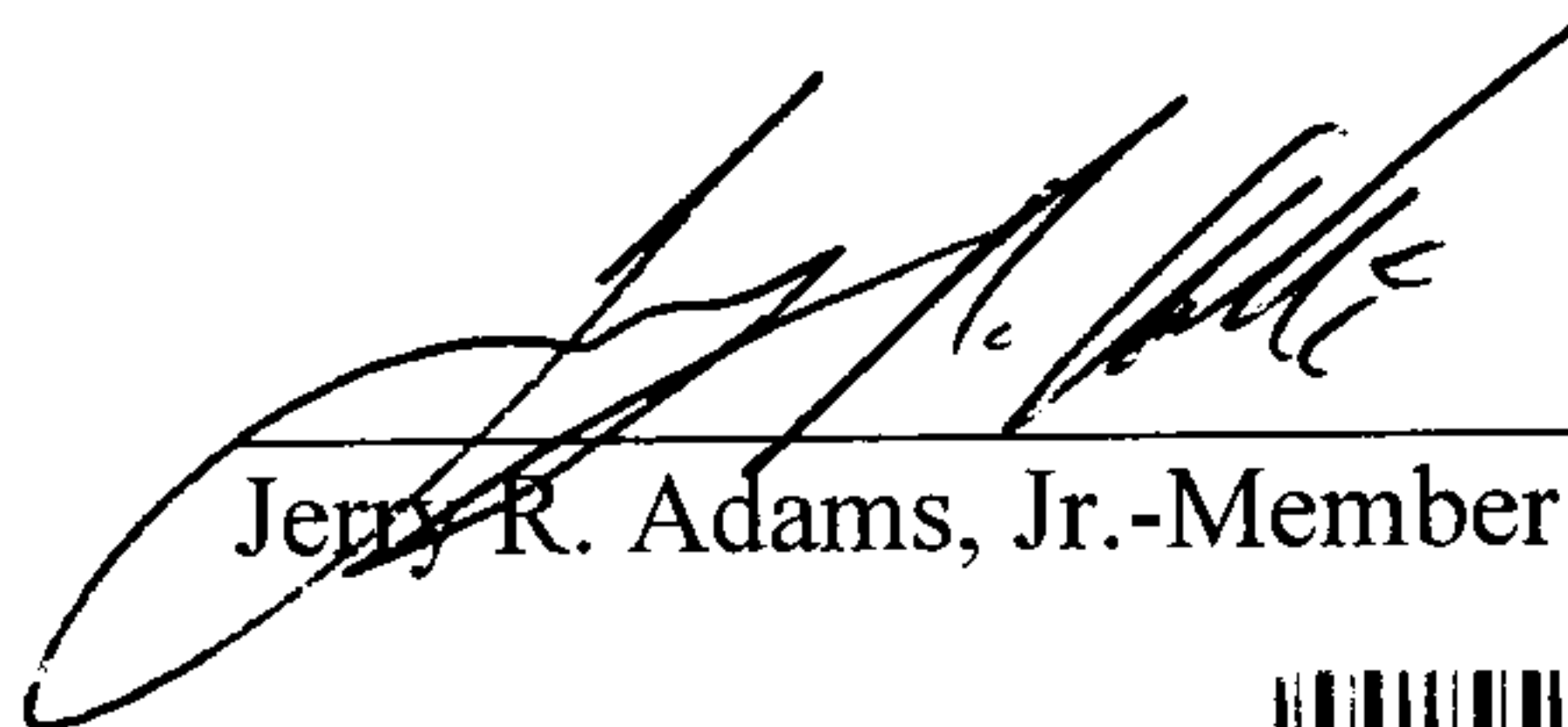
**ARTICLE IV**

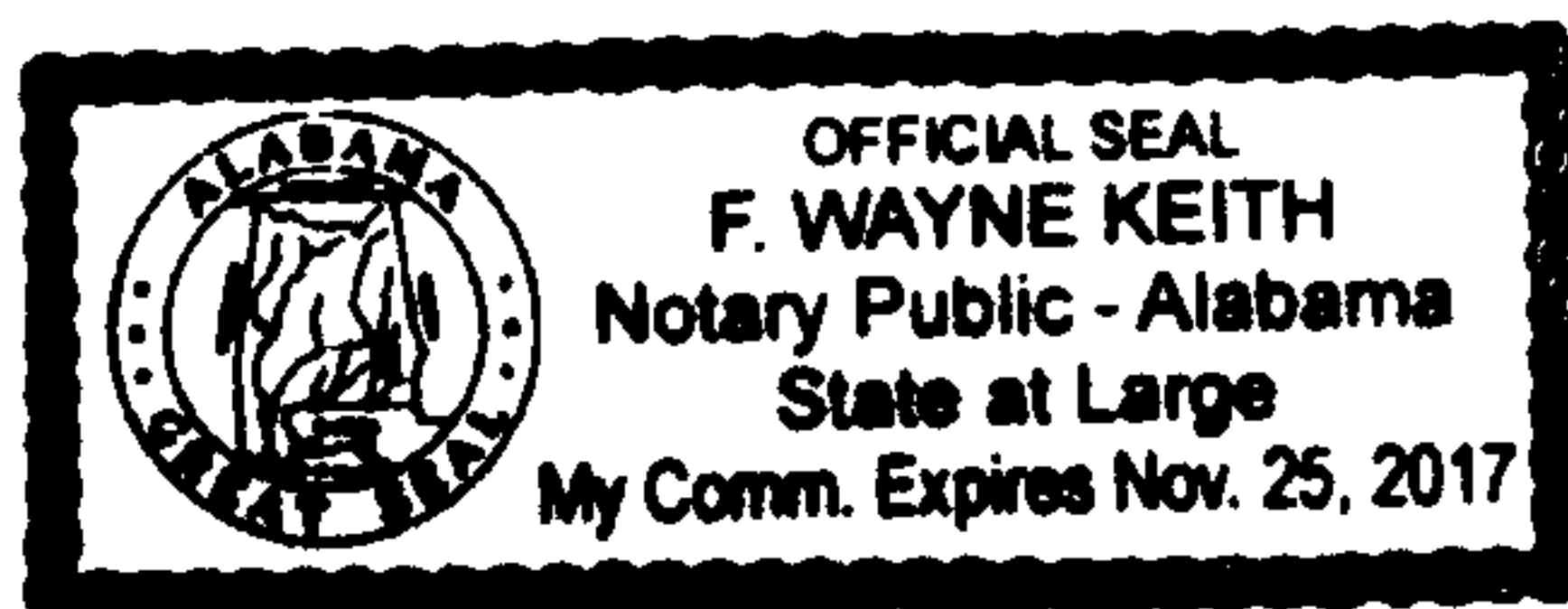

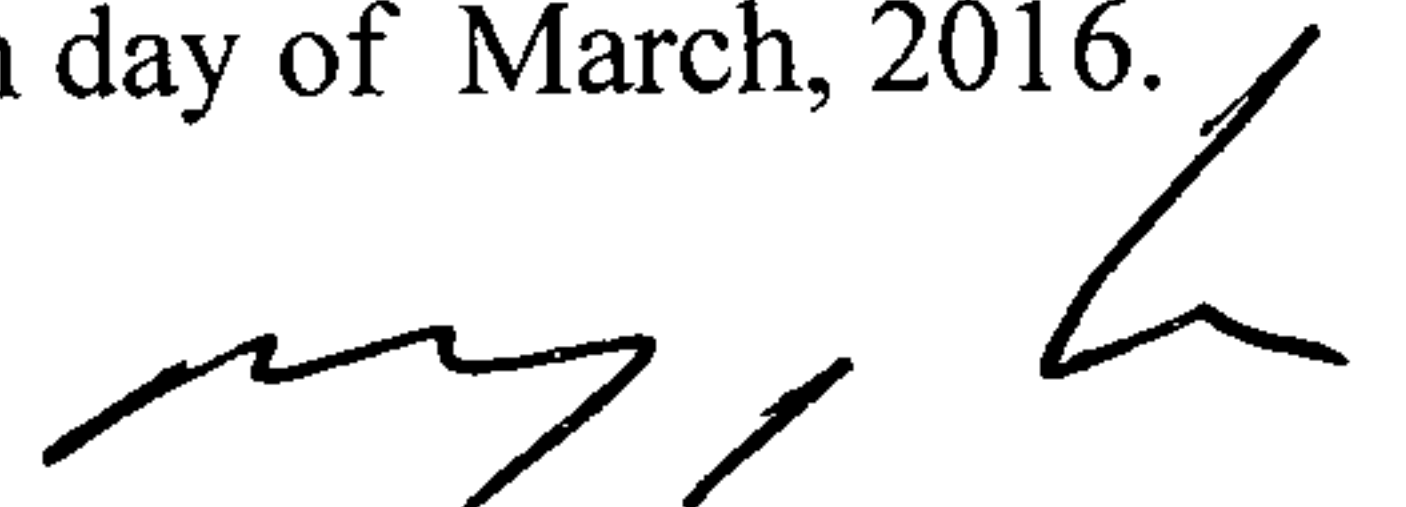
