FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on June 30, 2008, to-wit: Stanneshia K. 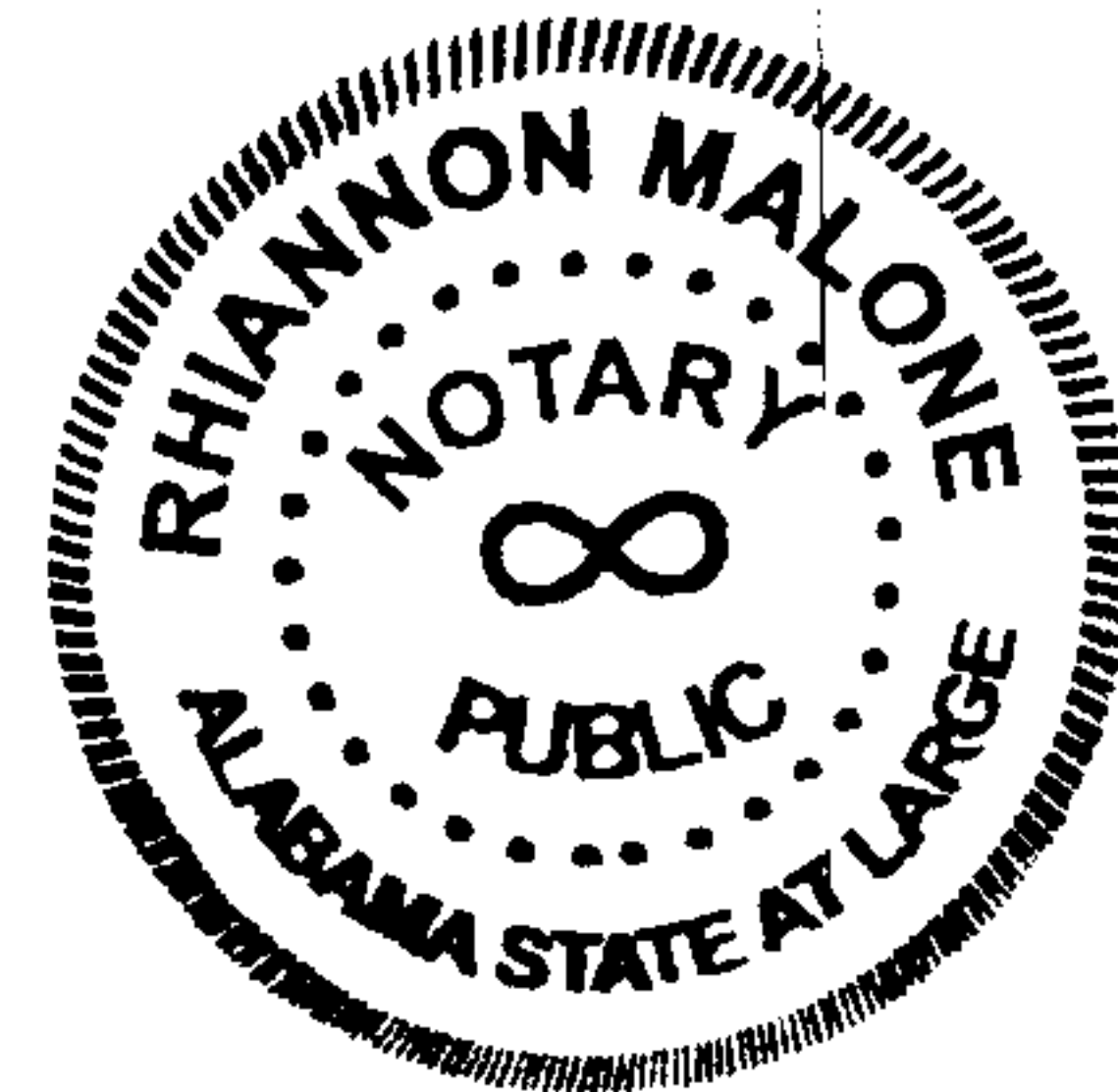

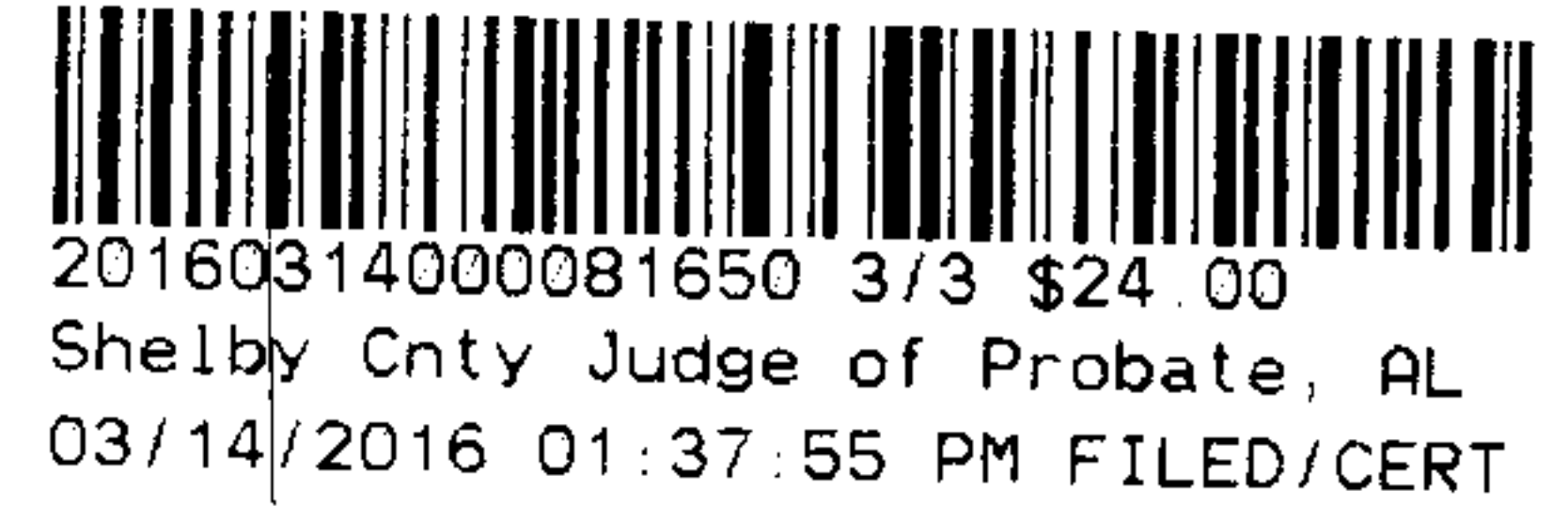
