\$237,400 of the proceeds come from a mortgage recorded simultaneously herewith.



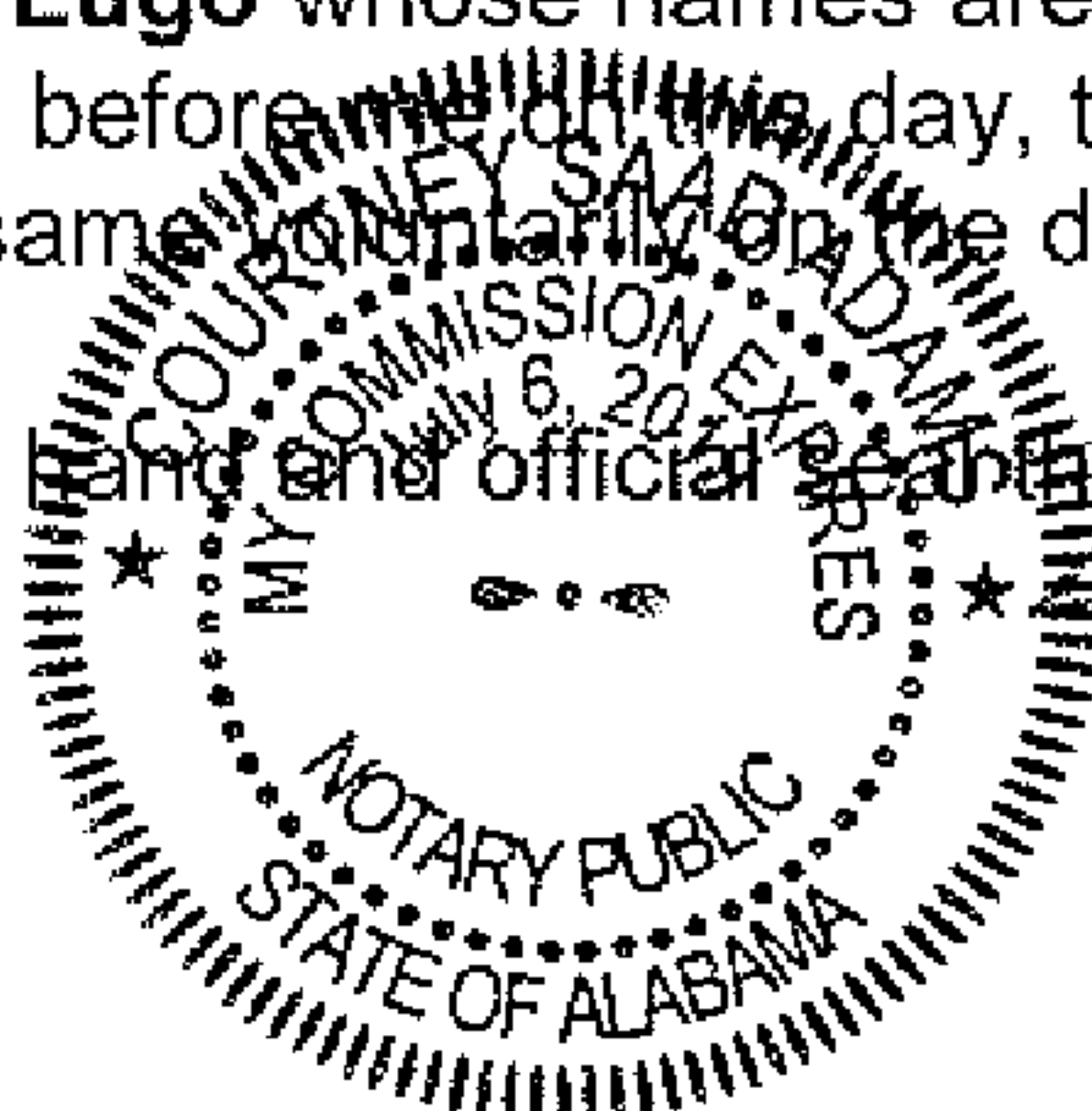
