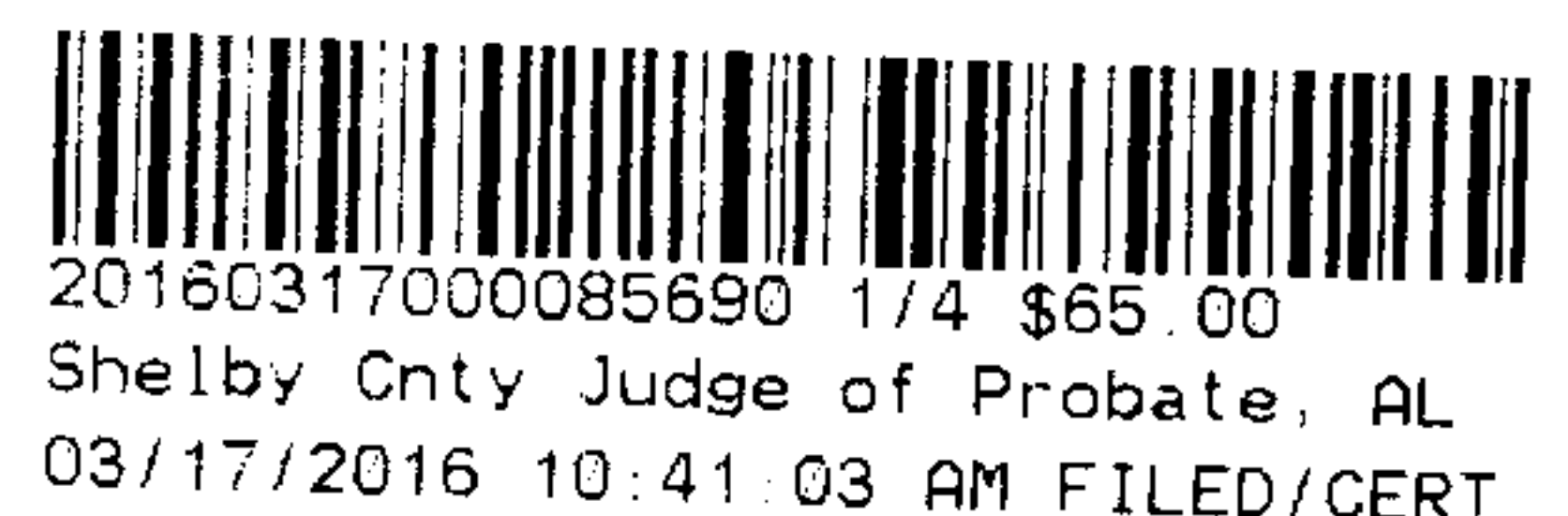

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of July, 1998, Patricia A. Dunkling, a single individual, executed that certain mortgage on real property hereinafter described to Southtrust Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1998-29163, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20091211000455760, in the aforesaid Probate Office ("Mortgagee"); and

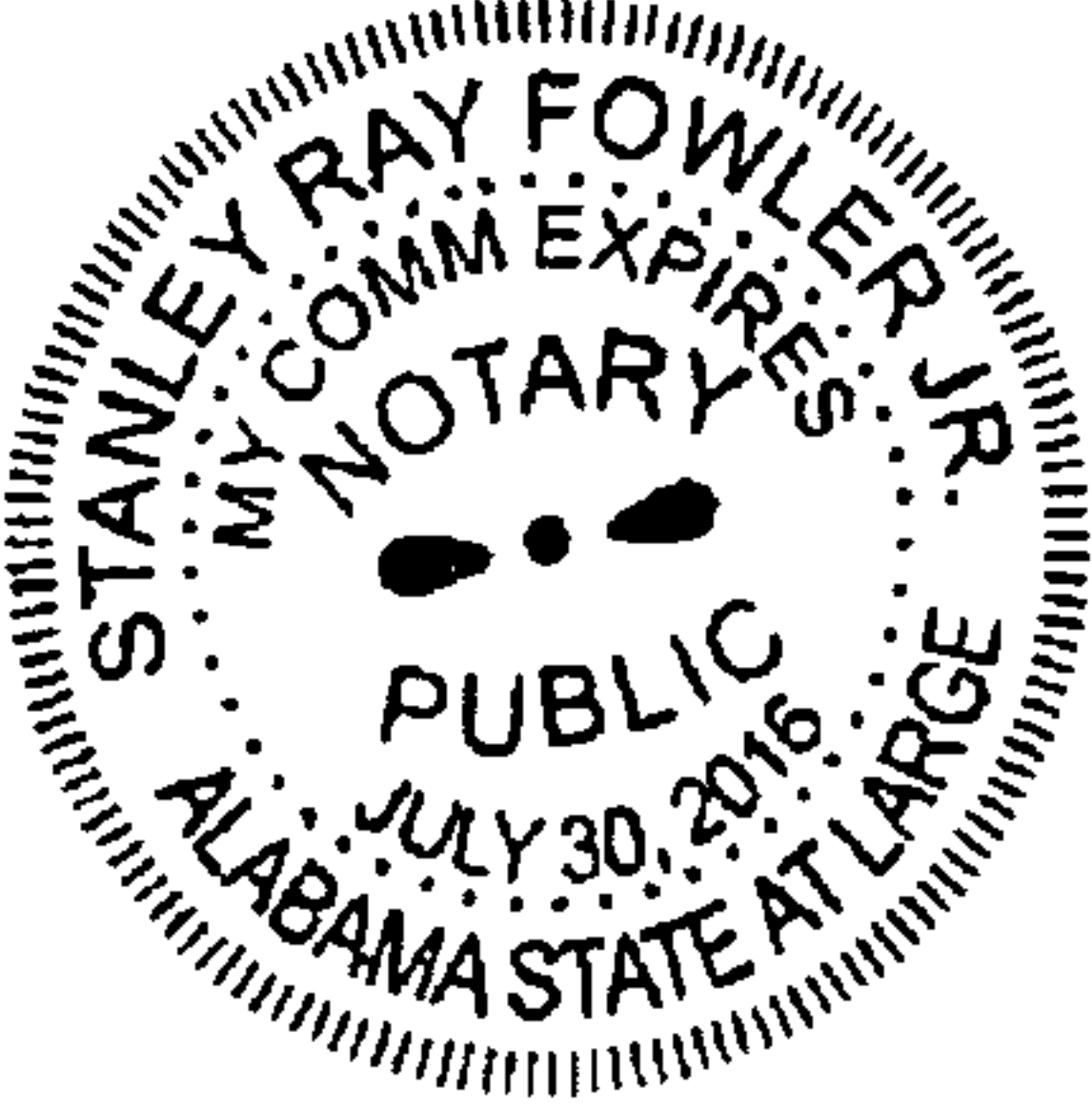
