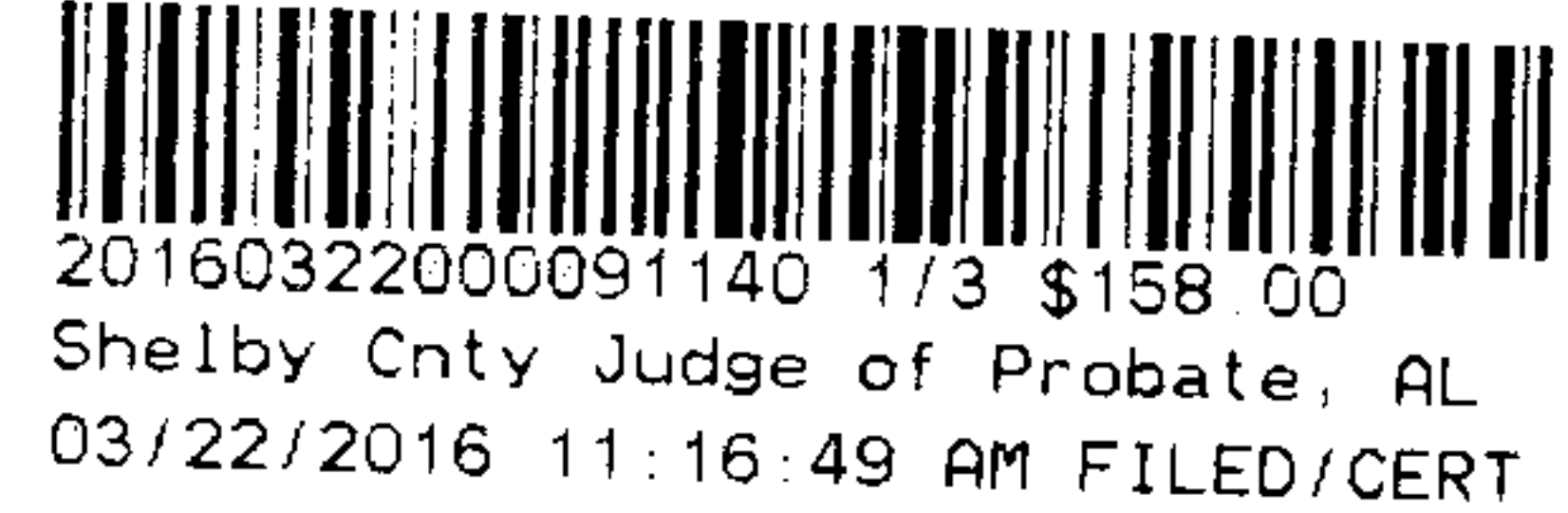

ARTICLES OF ORGANIZATION

ARTICLE I: Name

The name of the Limited Liability Company is GSCAPES, LLC (“The Company”)

ARTICLE II: Duration

The Company shall have duration from the date of organization until January 1, 2110 unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company (“The Act”)

ARTICLE III: Purpose

The purposes for which the company is formed are:

- a) To acquire, develop, operate and maintain real estate and to engage in all activities necessary, customary, convenient and incident thereto;
- b) To engage in any lawful business permitted to the limited liability companies under The Act, to exercise all power necessary to or reasonably connected with the Company’s business that which may be legally exercised by limited liability companies under the Act, and to engage in all activities necessary, customary, convenient or incidental to any of the foregoing;
- c) To engage in any lawful act or activity for which a limited liability company may be organized pursuant to the Act.

ARTICLE IV: Registered Office, Registered Agent
