## ORDER FOR ENTRY OF DEFAULT JUDGMENT AGAINST DEFENDANT AL T. ASHLEY

B. That Ditech's Mortgage shall be reformed to include on Page Three (3) of Ditech's Mortgage in the portion of Page Three (3) reserved for the legal description:

The legal description of the real property made the subject of this Mortgage is set forth fully on the attached Exhibit "A" which was recorded with this Mortgage and said legal description contained in said Exhibit is incorporated in this Mortgage as if set forth fully herein;
