**GENERAL WARRANTY DEED
With Right of Survivorship**

That in consideration of **One Hundred Fifty-Eight thousand Two Hundred and NO/100 Dollars (\$158,200.00)** to the undersigned grantor,


Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.




