GENERAL WARRANTY DEED

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

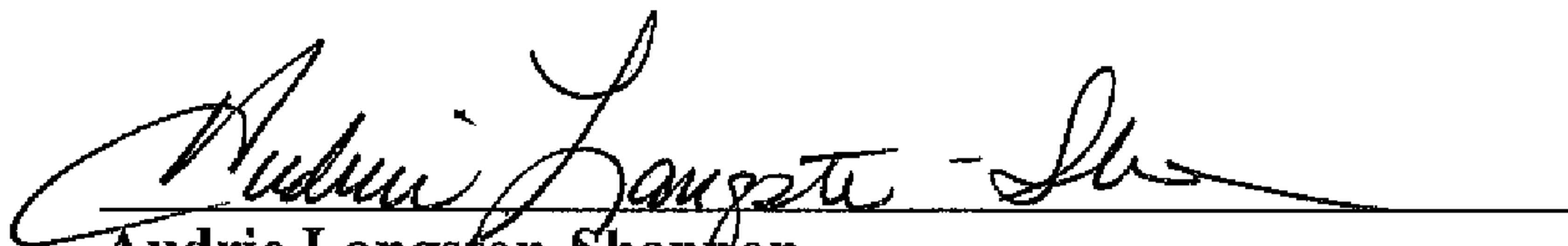
This property is not the homestead of the grantor nor that of her spouse.

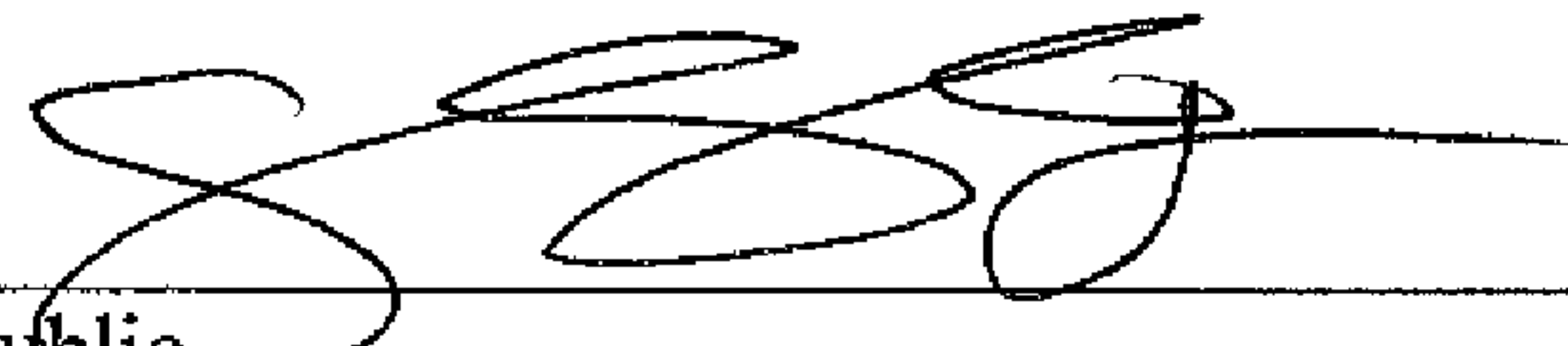

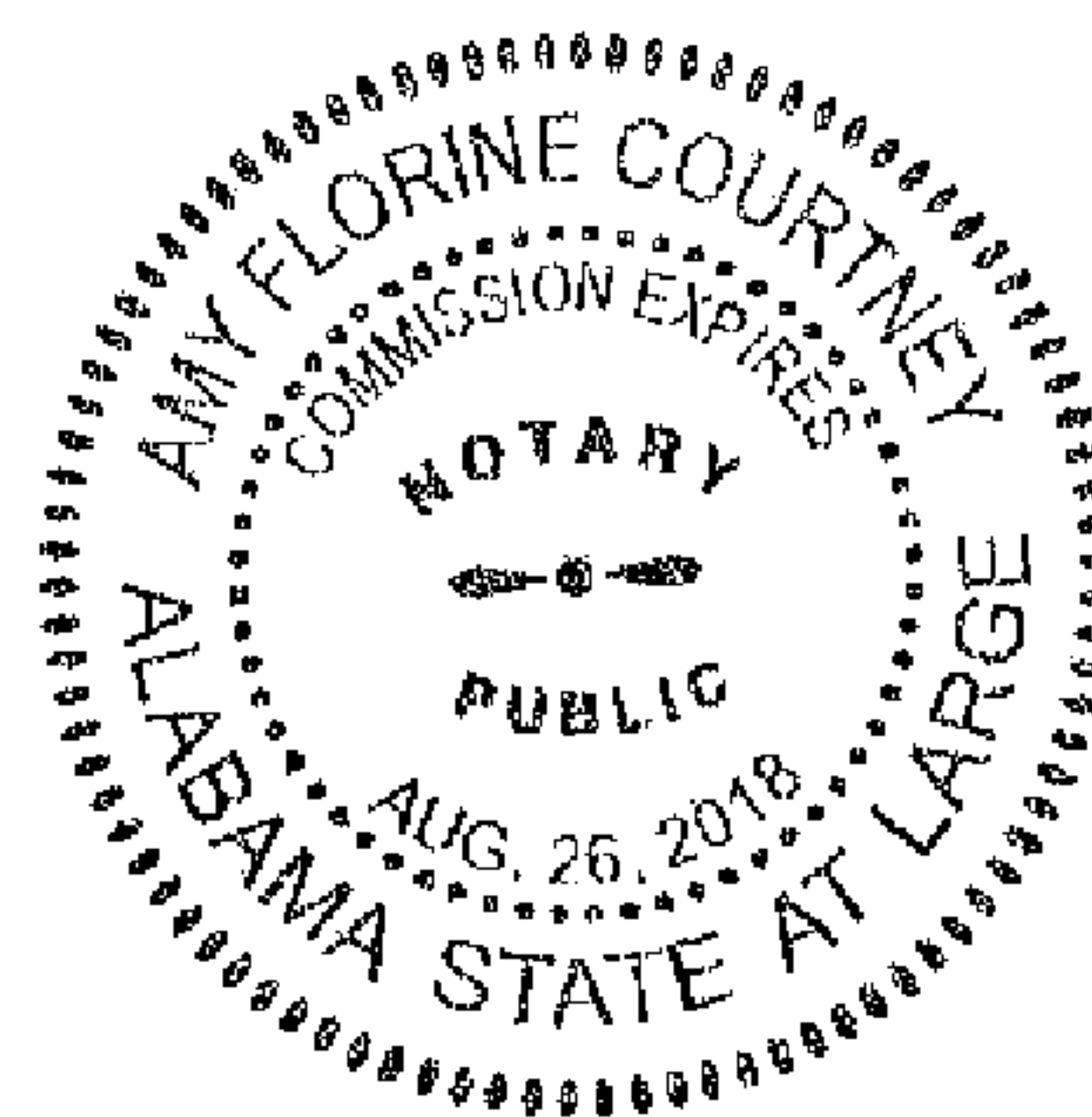
