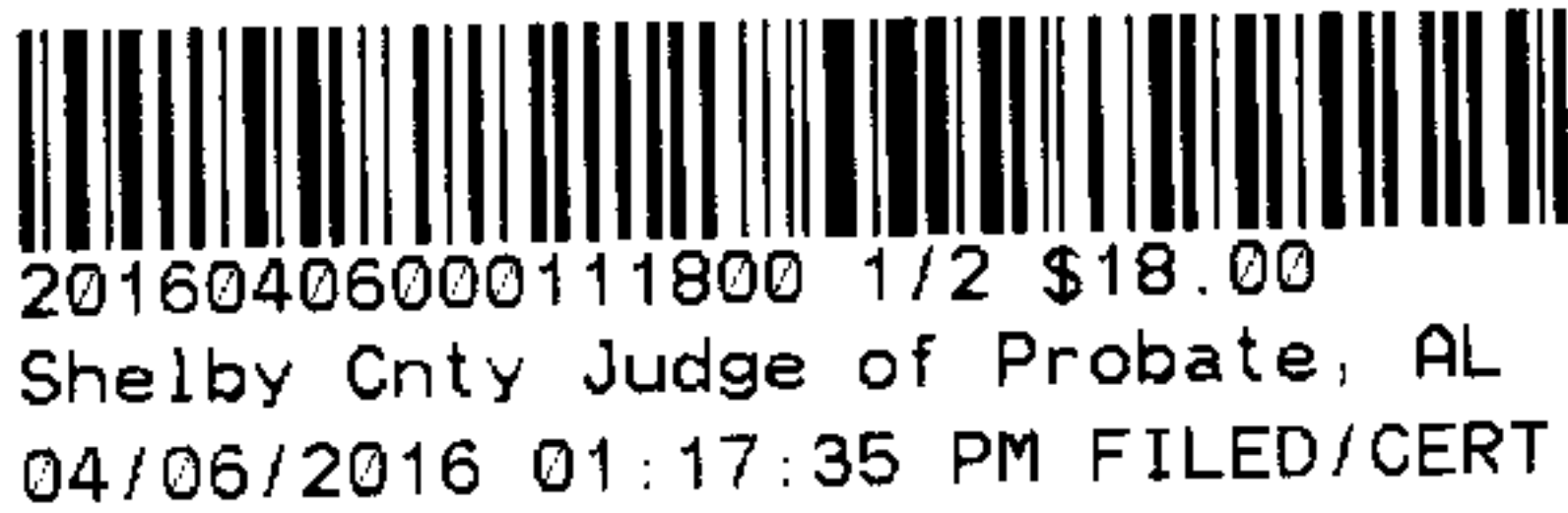

KNOW ALL MEN BY THESE PRESENTS, That in consideration **ONE HUNDRED SEVENTY FIVE THOUSAND AND NO/00 DOLLARS (\$175,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Steve Emory Thomas and wife, Jan Thomas*** (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Shanye Gilliland and Courtney Gilliland*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY County, Alabama, to-wit:**

SUBJECT TO:

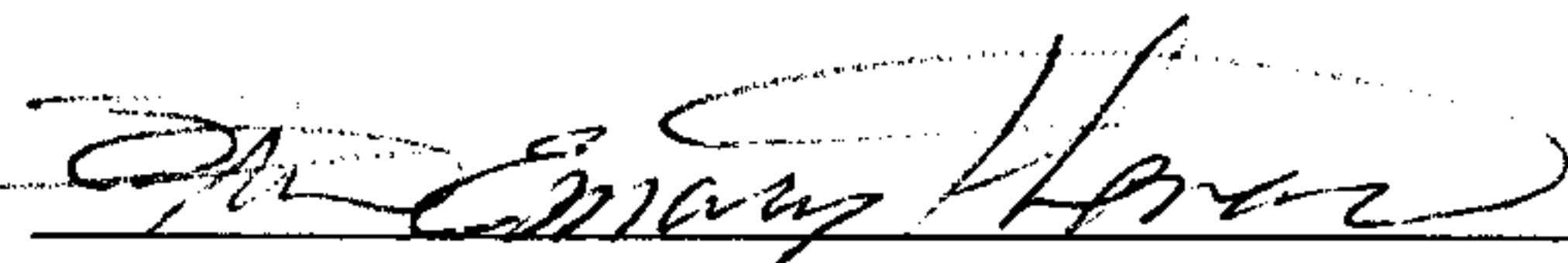
1. Ad valorem taxes due and payable October 1, 2013.

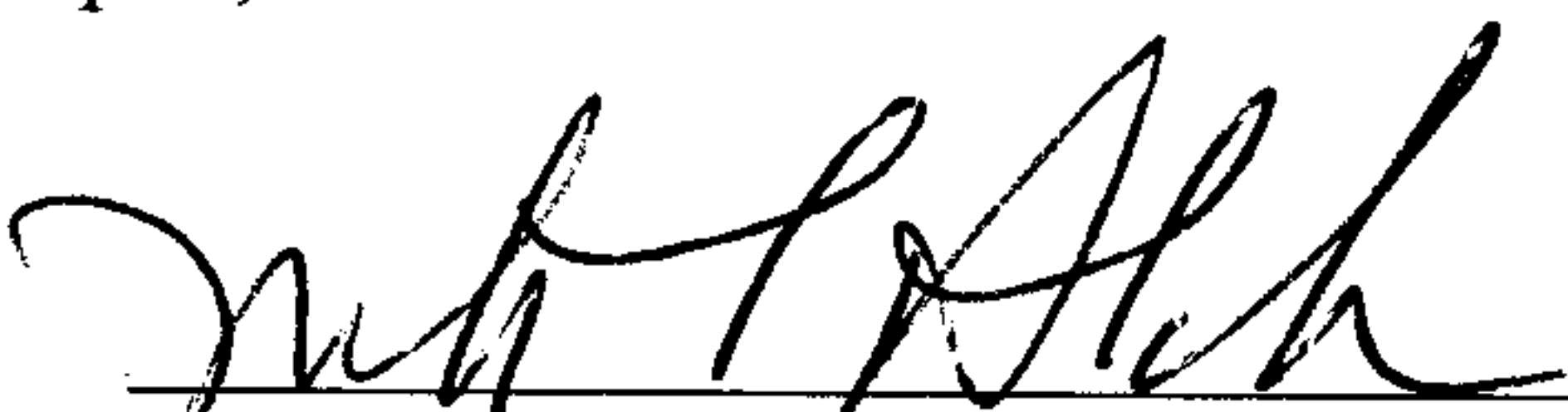
