KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of August, 2011, Lettie Crowson, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as a nominee for Nationstar Mortgage LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in instrument No. 20110908000265660, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC, by instrument recorded in Instrument No. 20151008000353810, in the aforesaid Probate Office ("Transferee"); and

for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

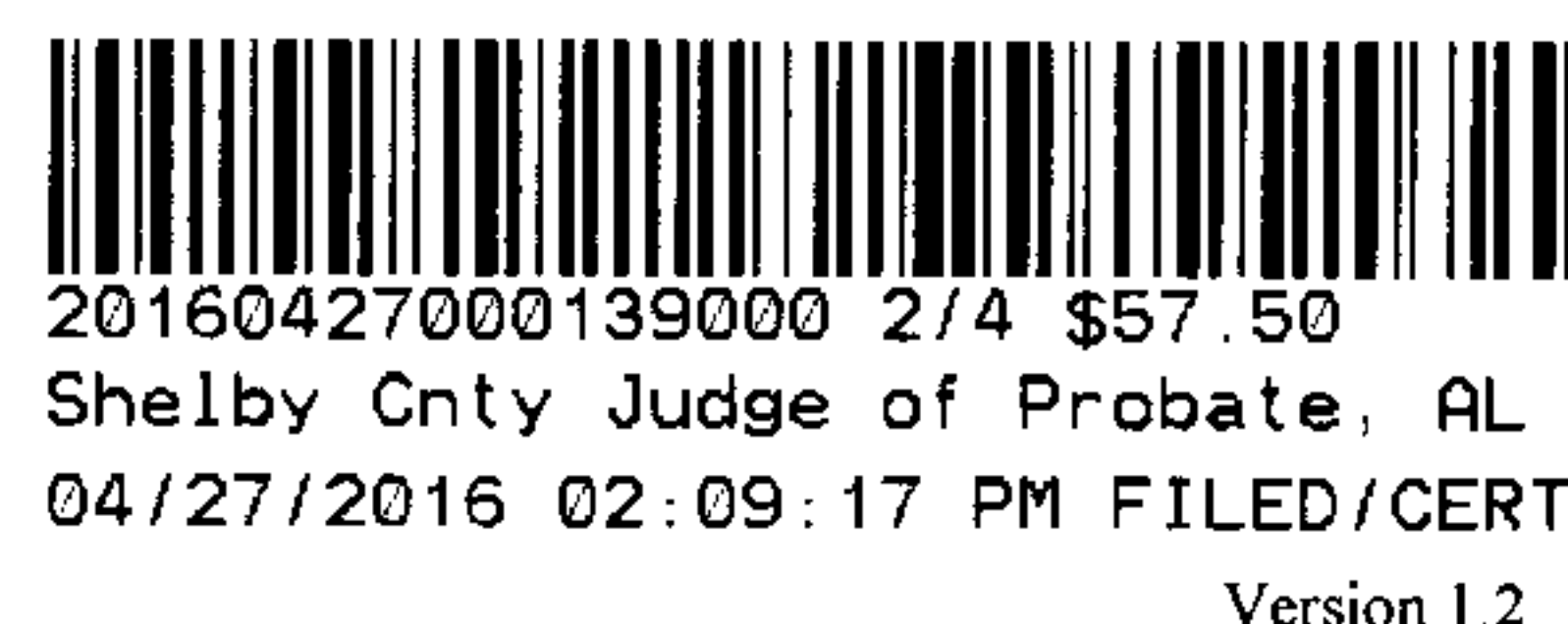

WHEREAS, Real Investors, LLC was the highest bidder and best bidder in the amount of Thirty-Four Thousand Five Hundred And 00/100 Dollars (\$34,500.00) on the indebtedness secured by said mortgage, the said Nationstar Mortgage LLC, by and through Red Mountain Title, LLC as auctioneer conducting said sale for said Transferee, does hereby remise, release, quit claim and convey unto Real Investors, LLC all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

A parcel of land located in the Southwest Quarter of the Northeast Quarter of Section 3, Township 24 North, Range 12 East, Shelby County, Alabama, more particularly described as follows: Commence at the intersection of the South right of way line of Alabama Highway 25 and the East right of way line of Gardner Street; thence in a Southerly direction along said East right of way right line of Gardner Street a distance of 400 feet to the Point of Beginning; thence continue along last described course, along said right of way line, a distance of 75 feet; thence 81 degrees 39 minutes 00 seconds left, in a Southeasterly direction, a distance of 150 feet; thence 98 degrees 21 minutes 00 seconds left, in a Northerly direction, a distance of 75 feet; thence 81 degrees 39 minutes 00 seconds left, in a Northwesterly direction a distance of 150 feet to the Point of Beginning.

TO HAVE AND TO HOLD the above described property unto Real Investors, LLC , forever; subject, however, to the statutory rights of redemption from said foreclosure sale on the part of those entitled to redeem as provided by the laws in the State of Alabama; and also subject to all recorded mortgages, encumbrances, recorded or unrecorded easements, liens, taxes, assessments, rights-of-way, and other matters of record in the aforesaid Probate Office.

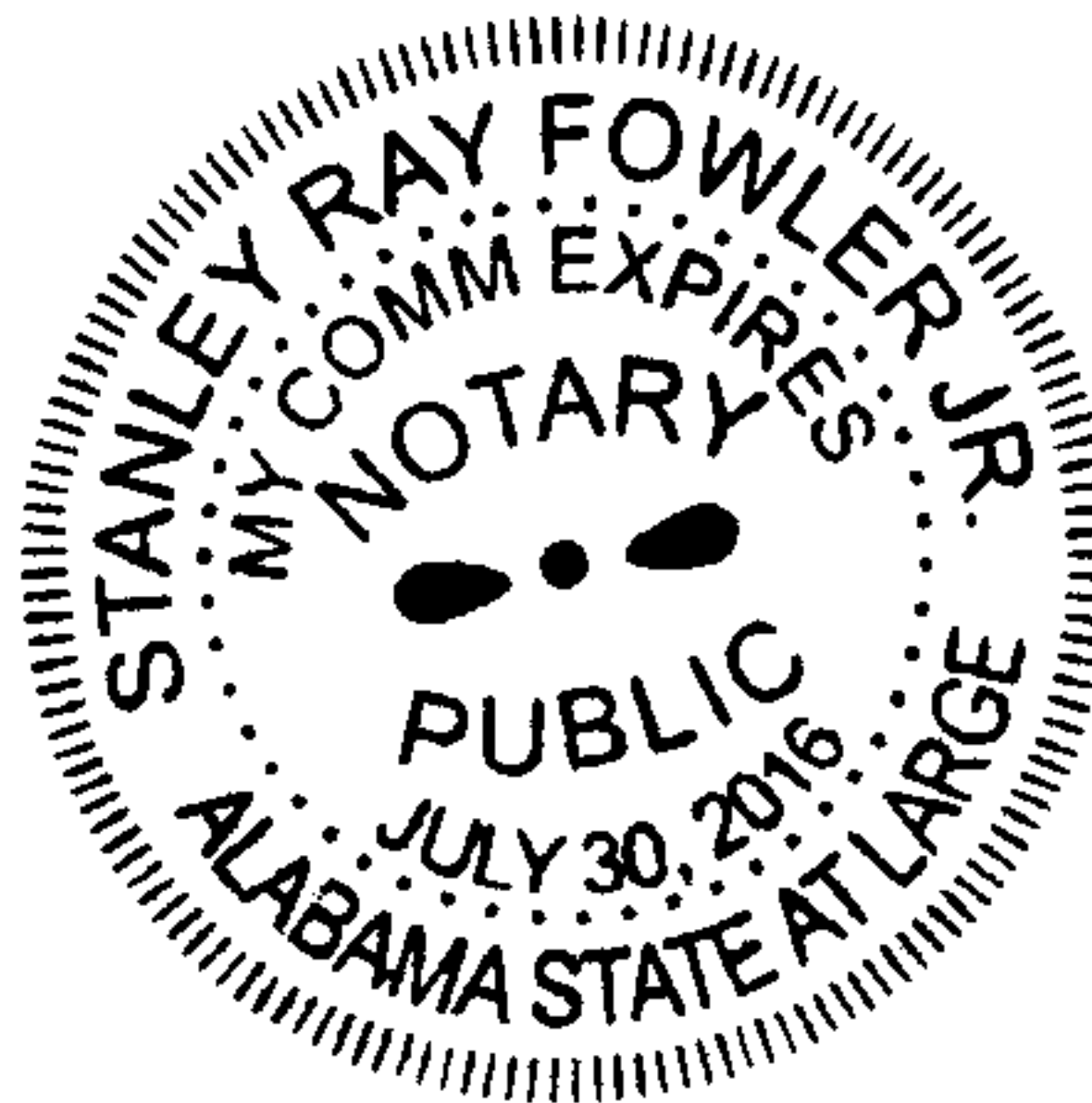
