County of Shelby

That in consideration of the sum of **Two Hundred Fifty Five Thousand Dollars and No Cents (\$255,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Ray Van Hood and Carol Ann Hood, Trustees, or their successors in interest, of the Hood Living Trust dated July 31, 2015 and any amendments thereto**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Joshua Paul Taylor and Amanda Hope Taylor**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 44, according to the Survey of Meadow Brook, 17th Sector, as recorded in Map Book 9, Page 158A&B, in the Probate Office of Shelby County, Alabama.

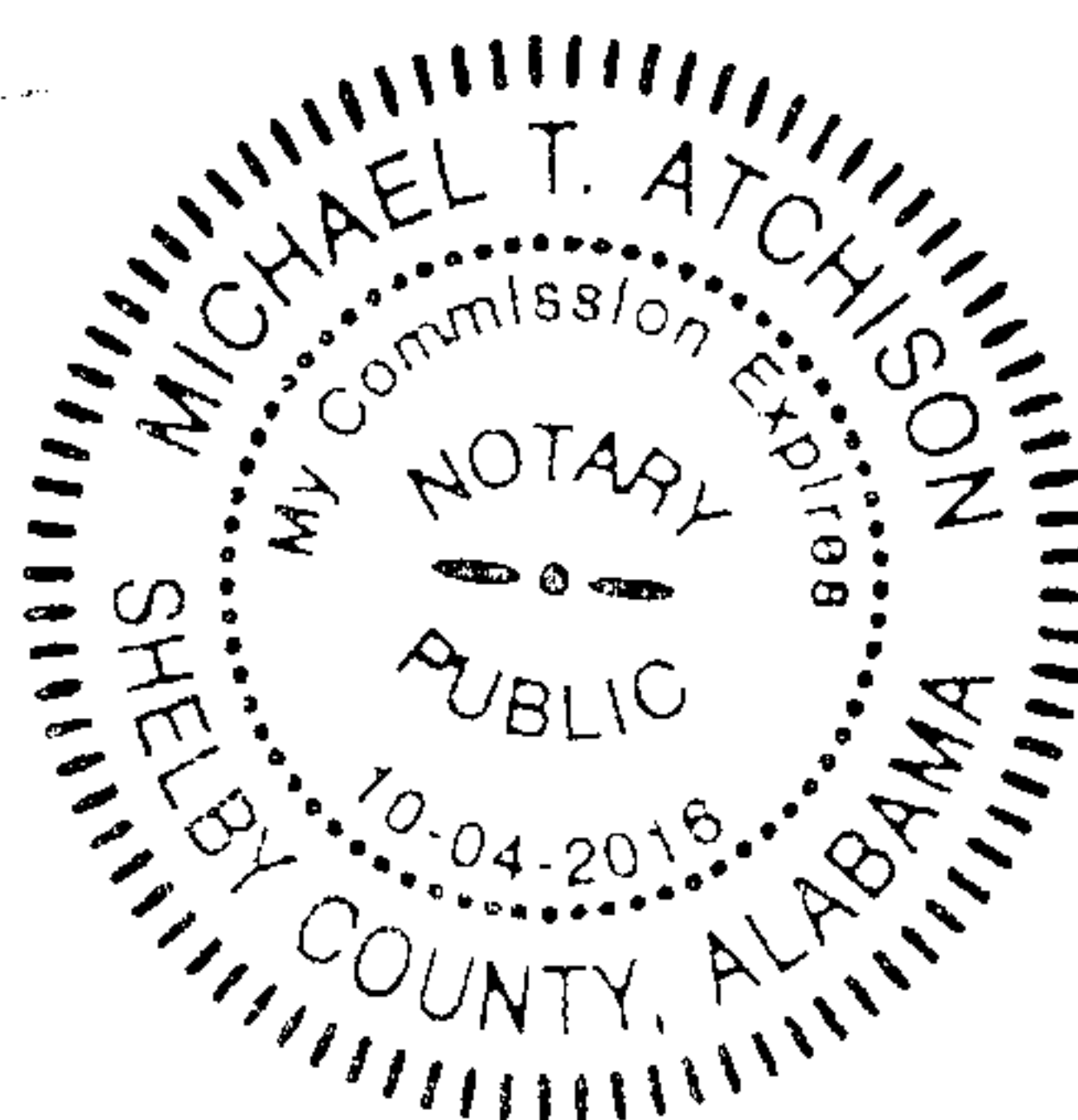

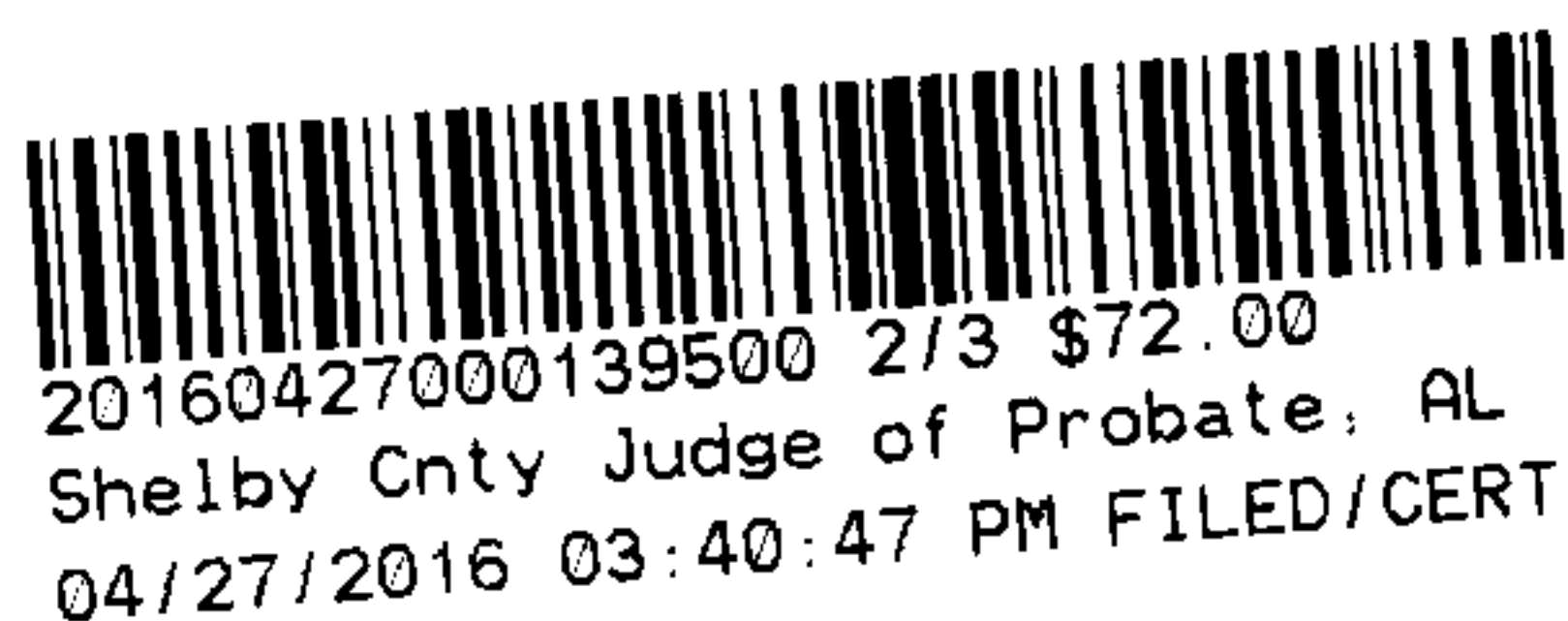
