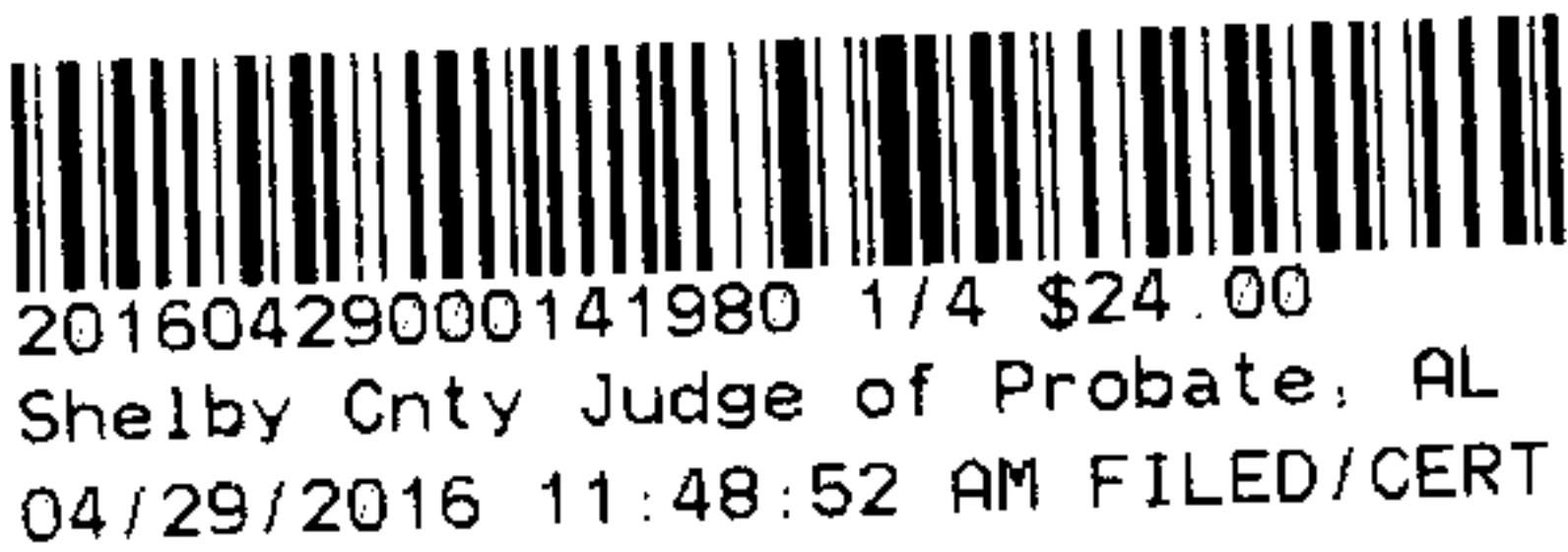

release Shelby County and all or its employees and officers from any and all damages to

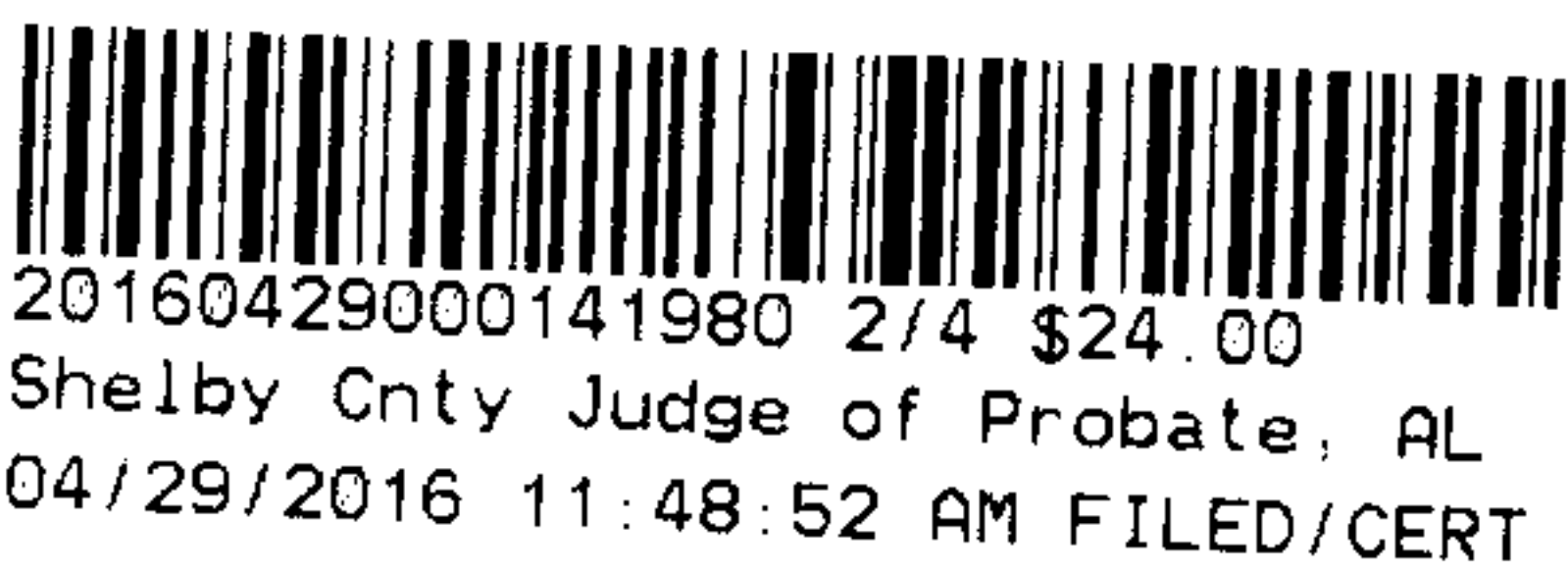
