KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 17th day of April, 2003, Robert K. Rockett, and wife Malinda Rockett, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20030421000240730, said mortgage having subsequently been transferred and assigned to Green Tree Servicing, LLC, by instrument recorded in Instrument Number 20130628000265860, in the aforesaid Probate Office ("Transferee"); and

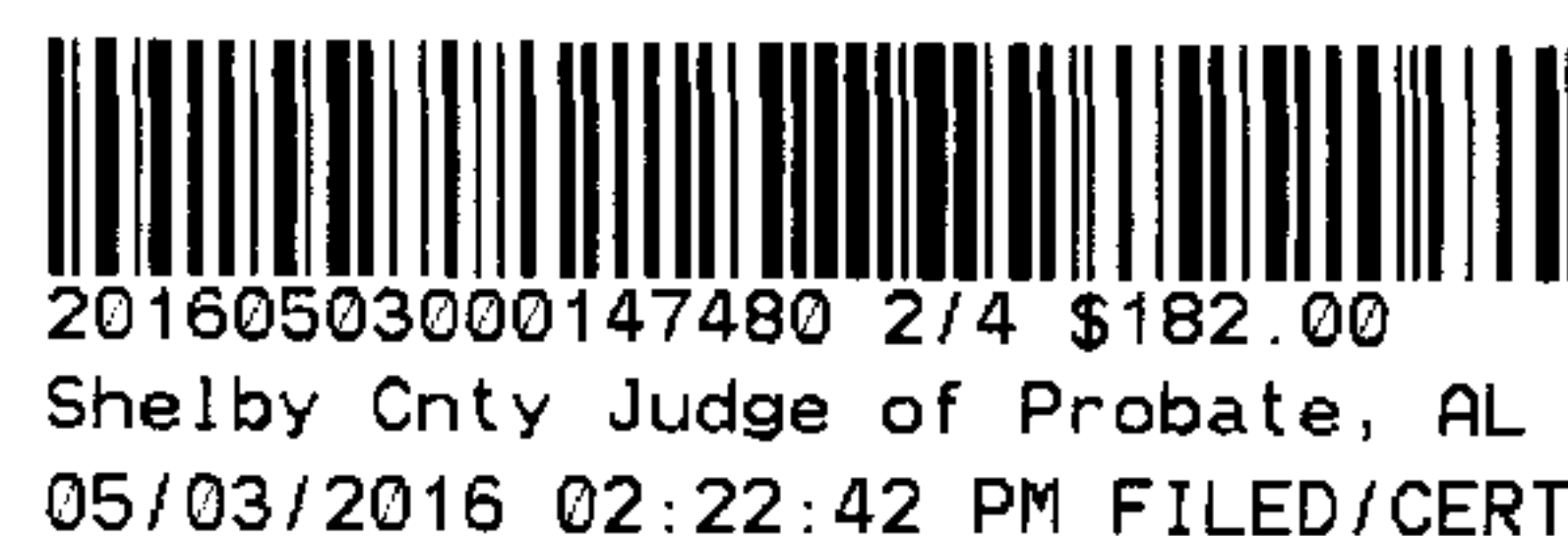

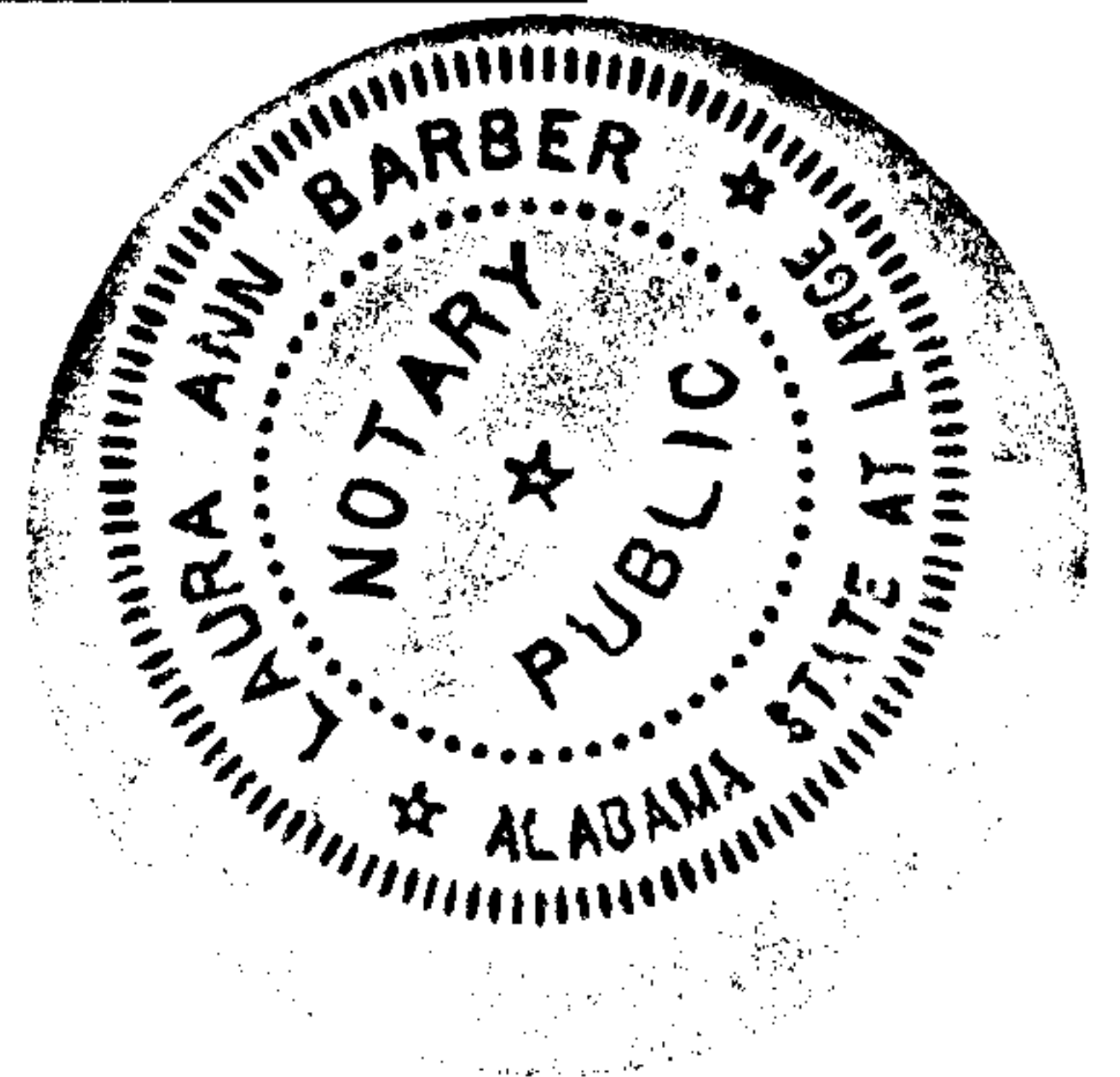
