KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of June, 2013, Alicia Ragland, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hometown Lenders, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20130708000275390; having been modified by Loan Modification Agreement recorded in Instrument 20150330000099740; and having been modified again by Loan Modification Agreement recorded in 20150708000229640, said mortgage having subsequently been transferred and assigned to PennyMac Loan Services, LLC, by instrument recorded in Instrumnet Number 20160121000021220, in the aforesaid Probate Office ("Transferee"); and

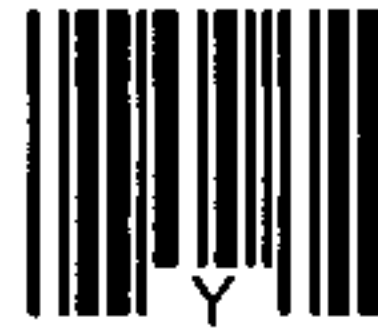
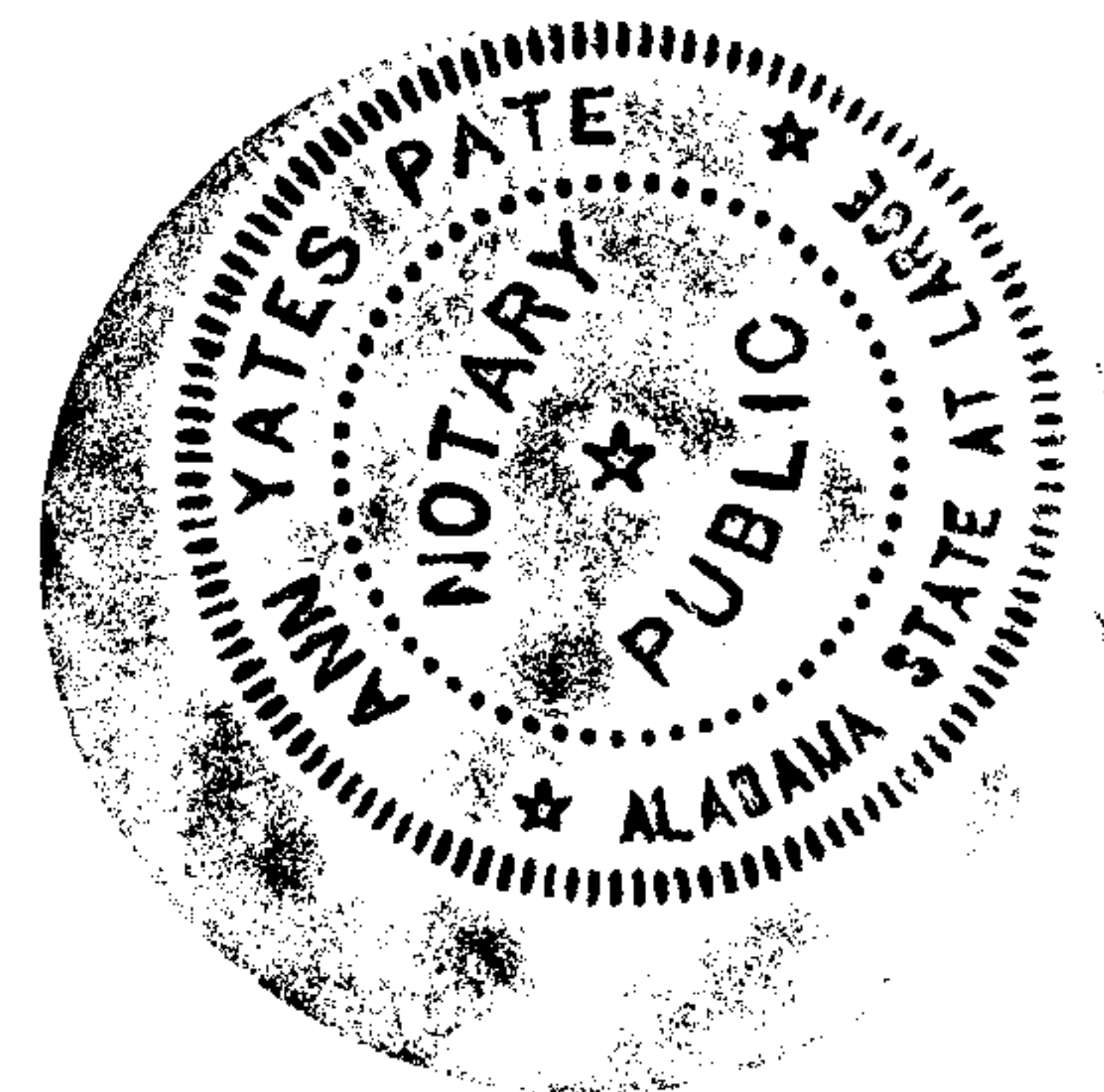
