


**AFFIDAVIT REGARDING CERTIFICATION OF TRUST
FOR THE ERMA GRAY SNYDER REVOCABLE TRUST AGREEMENT DATED MAY
15, 2014**

The undersigned, Reginald L. Snyder, being first duly sworn, deposes and says, I am at least 19 years of age and am currently acting trustee of the Erma Gray Snyder Revocable Trust Agreement dated May 15, 2014, and further state the following:

1. The Erma Gray Snyder Revocable Trust Agreement dated May 15, 2014, is a valid, existing trust, having been created by Erma Gray Snyder Revocable Trust Agreement dated May 15, 2014.
2.
 - A. The original settlors of the trust are Erma Gray Snyder and Reginald L. Snyder.
 - B. The following persons contributed money, funds, real property or personal property to the trust: Erma Gray Snyder and Reginald L. Snyder.
 - C. Erma Gray Snyder a/k/a Erma C. Snyder died on or about July 21, 2015. Reginald L. Snyder is alive and well.
 - D. The name of the currently acting trustee is Reginald L. Snyder.
3. The Erma Gray Snyder Revocable Trust Agreement dated May 15, 2014 has a definite beneficiary. The same person is not the sole trustee and sole beneficiary.
4. Excerpts from the trust agreement that establish the trust, designate the Trustee and set forth powers of the Trustee will be provided upon request. The administrative and/or managerial powers of the trustees are shown on the Powers of Trustee, and include the power to acquire, sell assign, convey, pledge, encumber, lease, borrow, manage and deal with real and personal property interests.

 - A. The trust is revocable
 - B. The people holding the power to revoke the trust are Reginald L. Snyder.
6.
 - A. The following trustee have the authority to sign documents and instruments: Reginald L. Snyder
 - B. Reginald L. Snyder is required to sign.
7. The conditions for the succession of the successor trustees are vacancy.
8. The social security number assigned to the trust is the social security number of Reginald L. Snyder.
9. Trust property should be titled as follows: Reginald L. Snyder, and any successors, as Trustee of the Erma Gray Snyder Revocable Trust Agreement dated May 15, 2014.
10. To the best of the undersigned's knowledge, the trust has not been revoked, modified or amended in any manner that would cause the representations and statements contained herein to be incorrect.


