(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Jarrett M. Kerpan and Rebecca L. Cormier

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 12, according to the Survey of Panther Ridge, as recorded in Map Book 31, page 118, in the Probate Office of Shelby County, Alabama



\$203,603.00 of the proceeds come from a mortgage recorded simultaneously herewith.

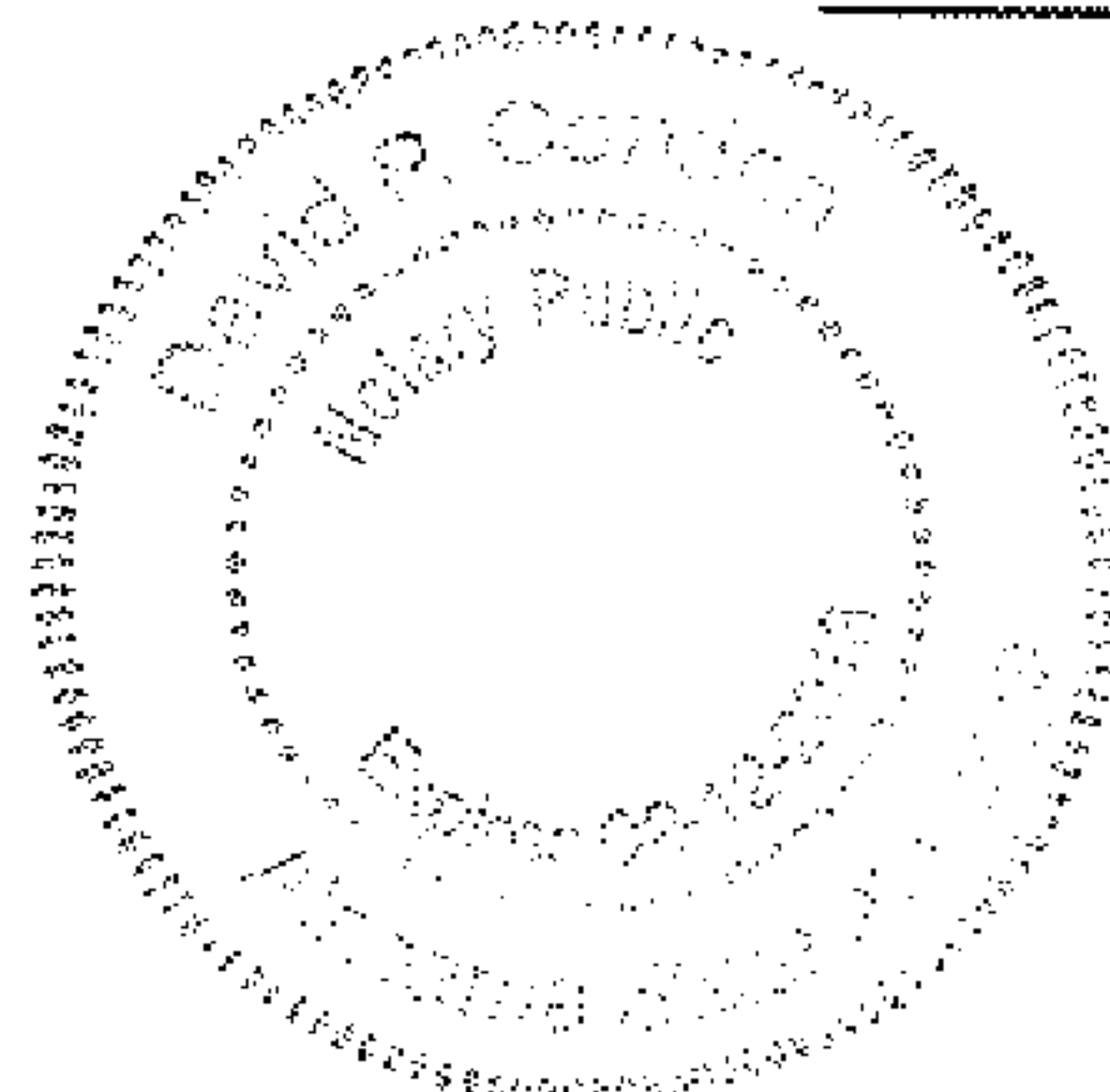

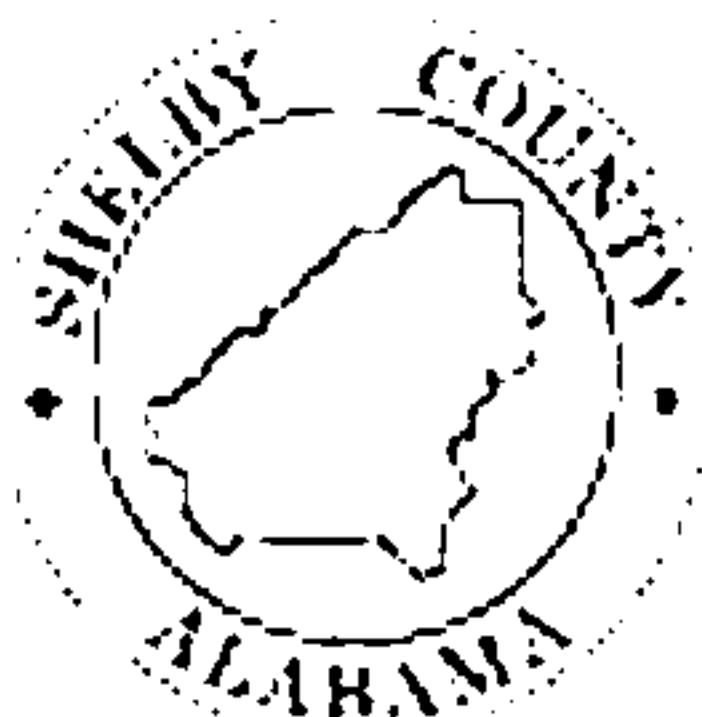
