KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Thirty Thousand and 00/100 (\$130,000.00) and other valuable considerations to the undersigned GRANTOR(S), G. DEAN PEARCE, AN UNMARRIED INDIVIDUAL, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEE(S) herein, the receipt of which is hereby acknowledged, the said GRANTOR(S) does by these presents GRANT, BARGAIN, SELL and CONVEY unto JEREMEY HANKINS and ABBEY HANKINS, hereinafter referred to as GRANTEE(S), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in County of Shelby State of Alabama, to-wit:

LOT 8, ACCORDING TO THE AMENDED MAP OF THE CREST AT GREYSTONE, AS RECORDED IN MAP BOOK 18, PAGES 17 A, B, C & D, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

Subject to easements, restrictive covenants, set back lines, limitations, rights of ways as shown by public records and ad valorem taxes as shown of record.

Subject to mineral and mining rights if not owned by grantor.
