PARTIAL RELEASE OF LIEN

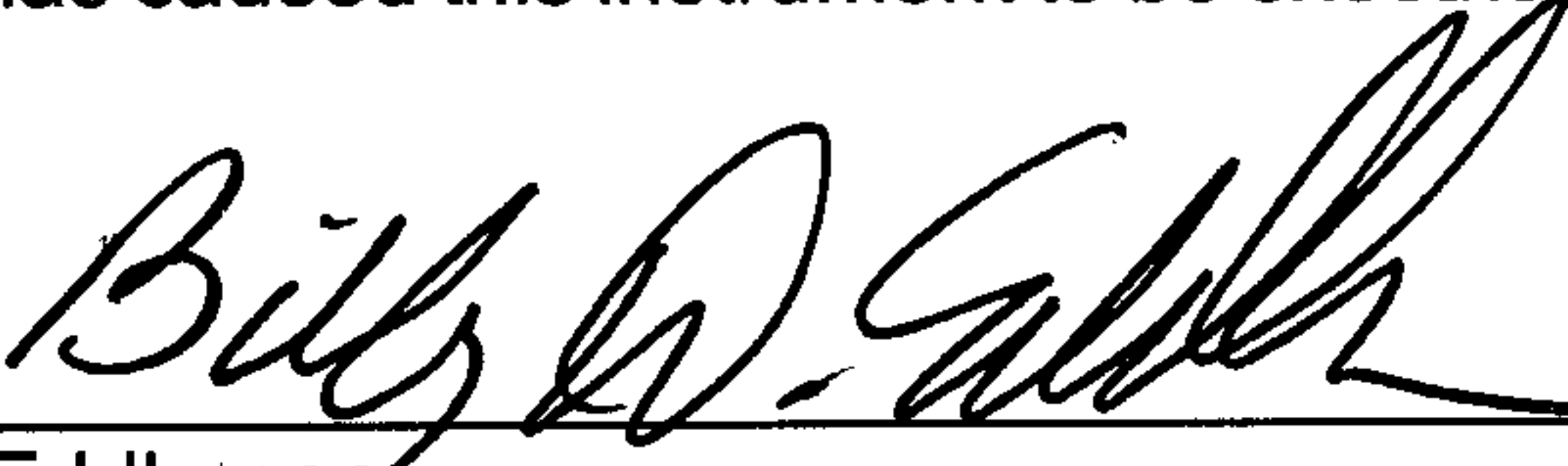
