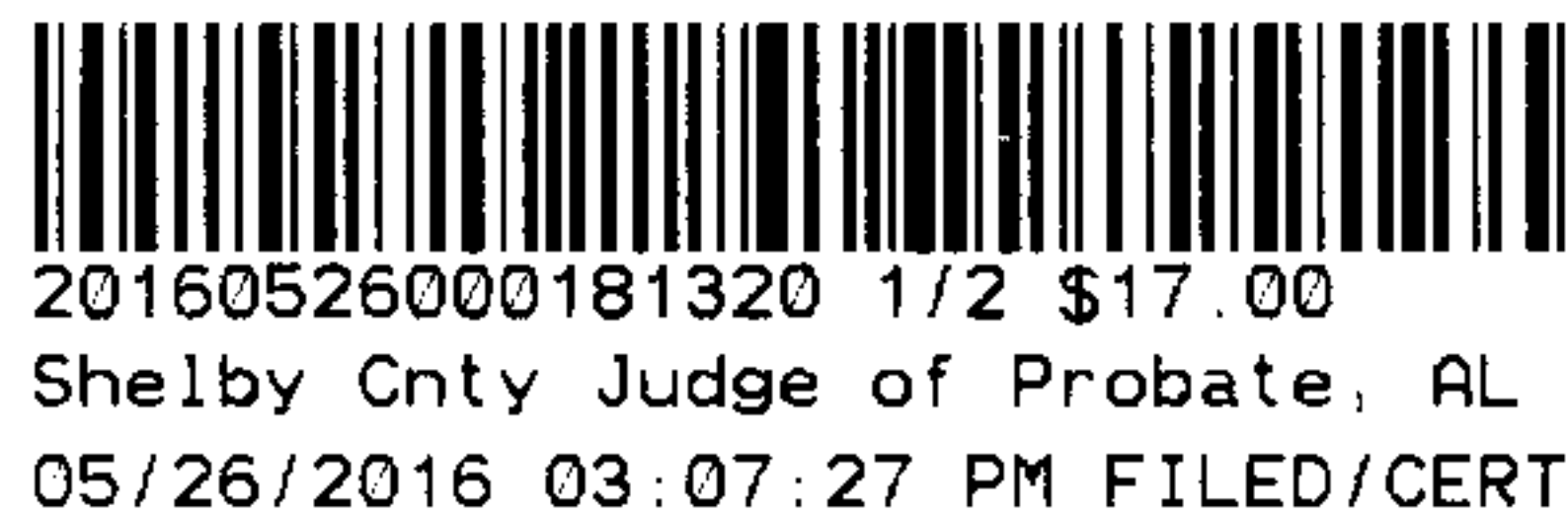

The BUKOLT LIVING TRUST dated April 17, 2002

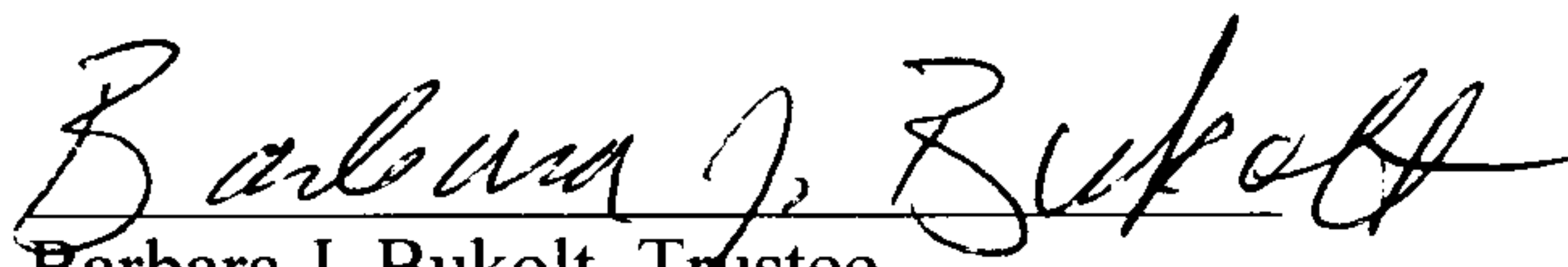

1. There is a valid and existing trust, having been created by **The BUKOLT LIVING TRUST dated April 17, 2002**.

 - A. The original settlor(s) and successor settlor(s), if any, of the trust was/were: **Earl D. Bukolt and Barbara J. Bukolt.**
 - B. The following person(s) contributed money, funds, real property, or personal property to the trust: **Earl D. Bukolt and Barbara J. Bukolt.**
 - C. The original settlor(s), **Earl D. Bukolt and Barbara J. Bukolt**, are alive and well as of this date.
 - D. The original trustees are **Earl D. Bukolt and Barbara J. Bukolt.**
 - E. The name and address of the currently acting trustees: **Earl D. Bukolt and Barbara J. Bukolt, 7047 Bradstock Court, Birmingham, AL 35242**
 - F. The BUKOLT LIVING TRUST dated April 17, 2002 has definite beneficiaries. The named beneficiaries are not the sole trustee and sole beneficiary.
3. The administrative and/or managerial powers of the trustee are:
Pursuant to the powers granted to the trustees in Article Fourteen, Section 1, paragraph (h), Trustees shall have the power to manage, control, grant options on , sell (for cash or on deferred payments), convey, exchange, partition, divided, improve and repair trust property. All powers of the Trustees are fully set forth in Article Fourteen of First Amendment and Restatement of The BUKOLT LIVING TRUST dated April 17, 2002, said First Amendment and Restatement having been executed on July 12, 1012.
4. The Trust is revocable.
5. The following trustees have the authority to sign documents and instruments: **Earl D. Bukolt, as Trustee and Barbara J. Bukolt, as Trustee.**
6. Trust Property should be titled as follows: **Earl D. Bukolt and Barbara J. Bukolt, Trustees or their successors in trust, under the Bukolt Living Trust dated April 17, 2002.**

7. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.
8. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Trustee and her powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.

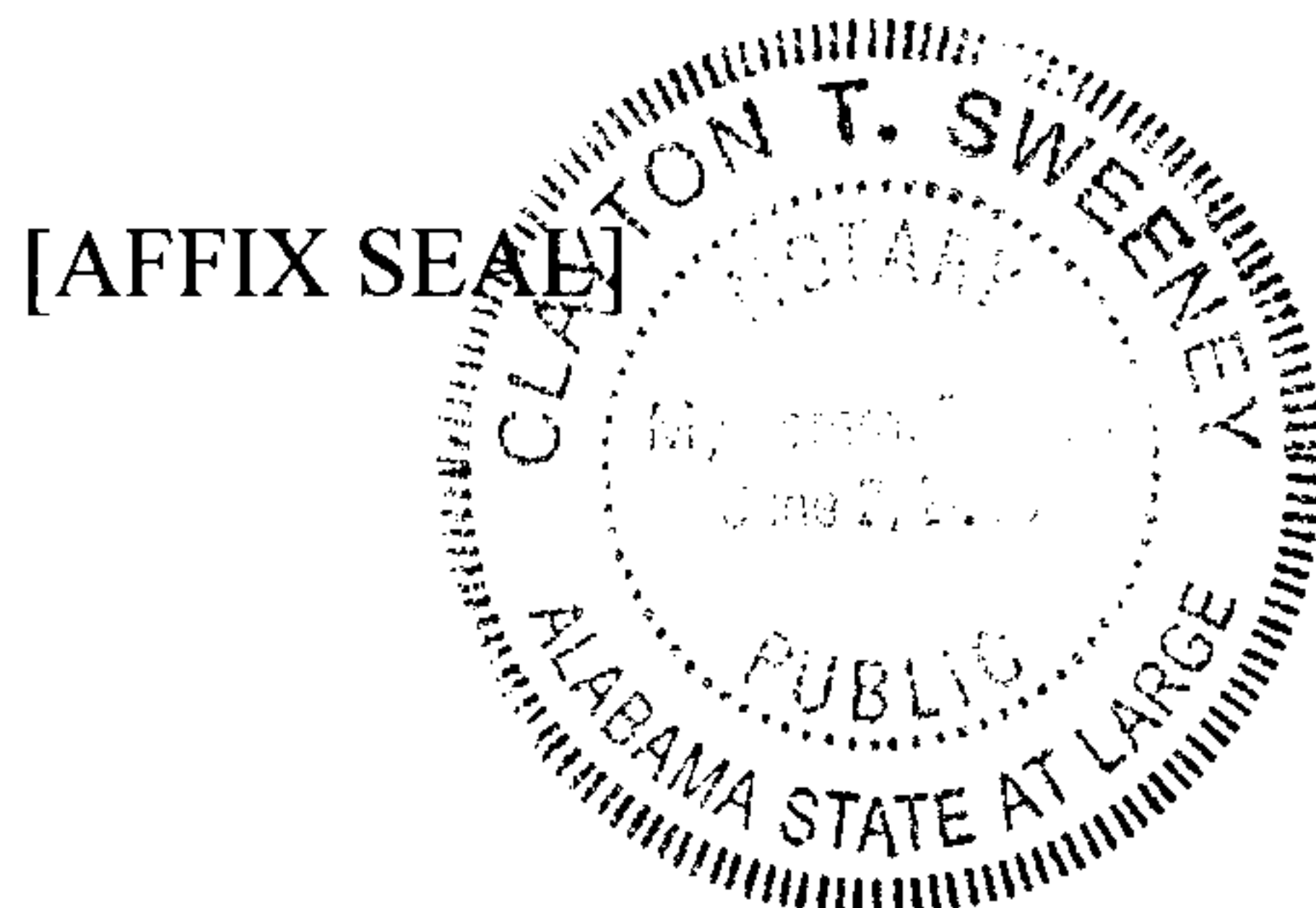

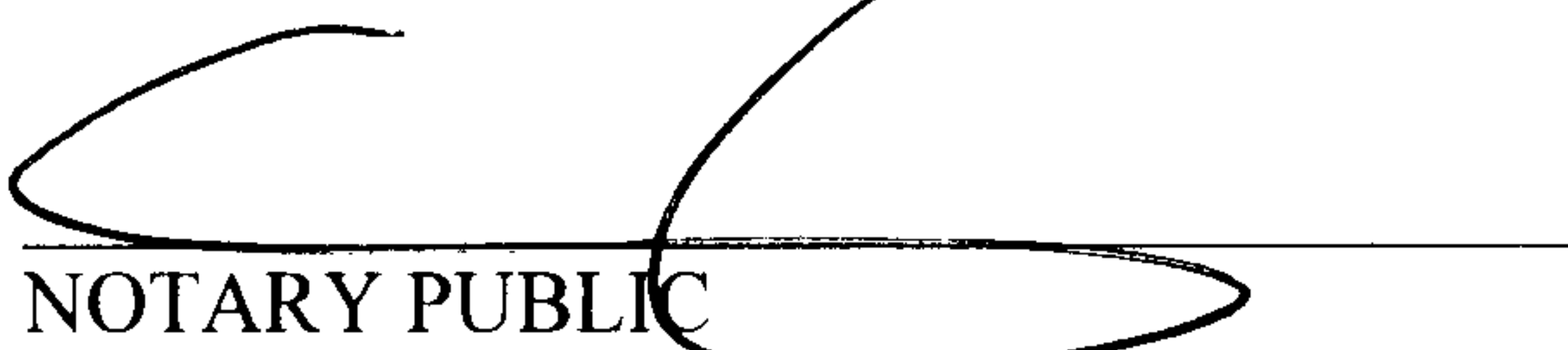
