APPOINTMENT OF SUCCESSOR TRUSTEE. RESIGNATION OF TRUSTEE AND ACCEPTANCE BY SUCCESSOR TRUSTEE

WHEREAS, Jim Conrad desires to resign as a Trustee of the Trust and Michael Stameris is willing to serve as the successor Trustee of the Trust in the place of Jim Conrad.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants and promises hereinafter set forth, the parties hereto agree as follows:

- The foregoing recitals are incorporated herein by reference and made a part hereof.
- 2. Jean E. Stameris hereby waives any notice requirement under the Will for the matters herein.
- 3. Jim Conrad hereby appoints Michael Stameris to serve as successor Trustee in the event Jim Conrad ceases to serve as a Trustee of the Trust.
 - 4. Jim Conrad hereby resigns as a Trustee of the Trust.

- 5. Michael Stameris hereby accepts his appointment to serve as a successor Trustee of the Trust along with Jean E. Stameris, pursuant to the terms, provisions and conditions of the Will.
- 6. Jean E. Stameris, individually and as a Trustee of the Trust, hereby accepts the resignation of Jim Conrad as a Trustee of the Trust and the appointment of Michael Stameris as the successor Trustee of the Trust in the place of Jim Conrad.
- 7. Subject to the provisions of the following paragraph, Jim Conrad shall, as soon as reasonably practical after the full execution of this instrument, but not later than thirty (30) days thereafter, assign, transfer, pay over and deliver all of the assets of the Trust to Jean E. Stameris and Michael Stameris as Trustees of the Trust. In addition, Jim Conrad shall deliver any and all books, records, financial documents, income tax returns, and any other records and documentation, of whatever kind and nature, of the Trust to Jean E. Stameris and Michael Stameris as Trustees of the Trust.
- 8. The parties hereto acknowledge that Jim Conrad shall be paid a fee in the amount of \$ 1,000.00 for his service as a Trustee of the Trust. Such fee shall be paid from the assets of the Trust prior to the assignment and transfer of the assets of the Trust as set forth in the preceding paragraph.
- 9. Jean E. Stameris, for herself, her heirs, executors, and administrators, hereby waives any accounting by Jim Conrad as a Trustee of the Trust, and hereby releases and discharges Jim Conrad as a Trustee of the Trust, from all loss, cost, liability or expense (including reasonable attorneys' fees) which may be hereinafter incurred by Jim Conrad as a Trustee of the Trust at any time and from time to time on account of, as a result of, or in connection with any and all claims, demands, actions or causes of actions that may be brought by any person or entity, except for conduct involving gross negligence or fraud, arising from the duties and responsibilities conferred upon Jim Conrad as a Trustee of the Trust.
- 10. Jim Burnett hereby renounces and disclaims any right he may have, now or in the future, to serve as a Trustee of the Trust.
- 11. This instrument may be executed in several counterparts, each of which, when so executed, shall be deemed to be an original, and such counterparts shall, together, constitute and be one and the same instrument.
