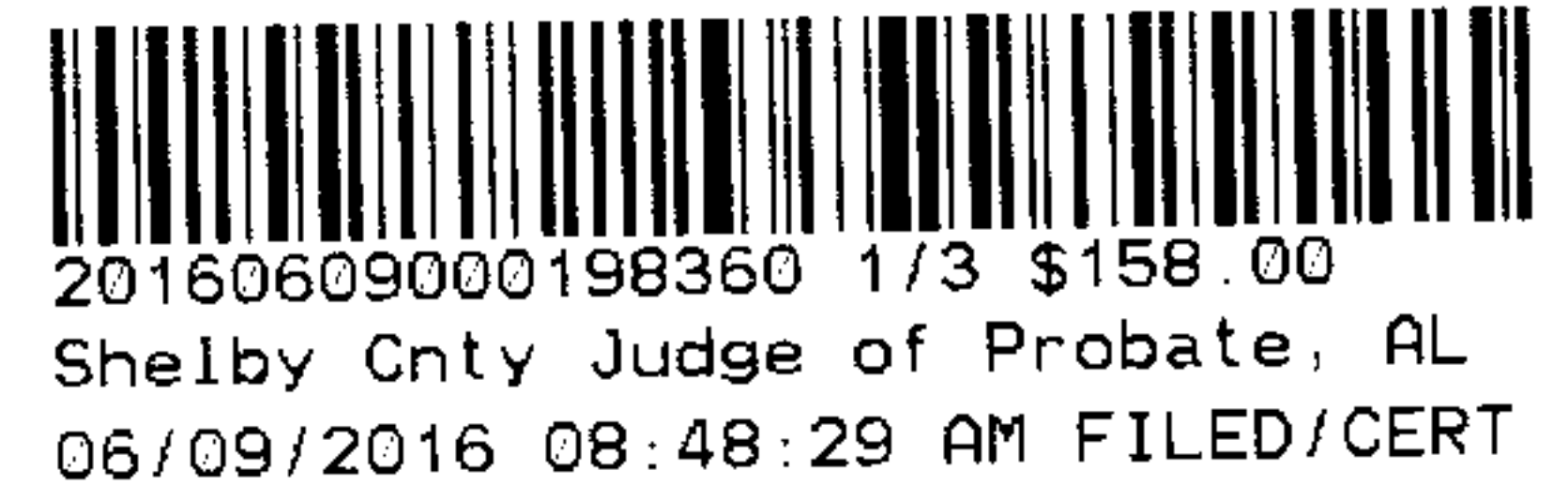


**ARTICLES OF ORGANIZATION
OF
PEEK CLINICAL SOLUTIONS LLC
An Alabama Limited Liability Company**



The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (The "Act"), hereby adopts the following Articles of Organization for **Peek Clinical Solutions, LLC**, a limited liability company (the Company).

ARTICLE ONE

The name of the Company is "Peek Clinical Solutions", Limited Liability Company (LLC).

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The Company is organized for the purpose of conducting the business of engaging in the supervision of social workers, and , all other related things to this industry, consulting in all types of social work activity and all types of private social work and counseling that the said Wendy Russell Peek, LCSW, PIP, or any other employee of the company is otherwise accredited to perform and other things related thereto and any other lawful business.

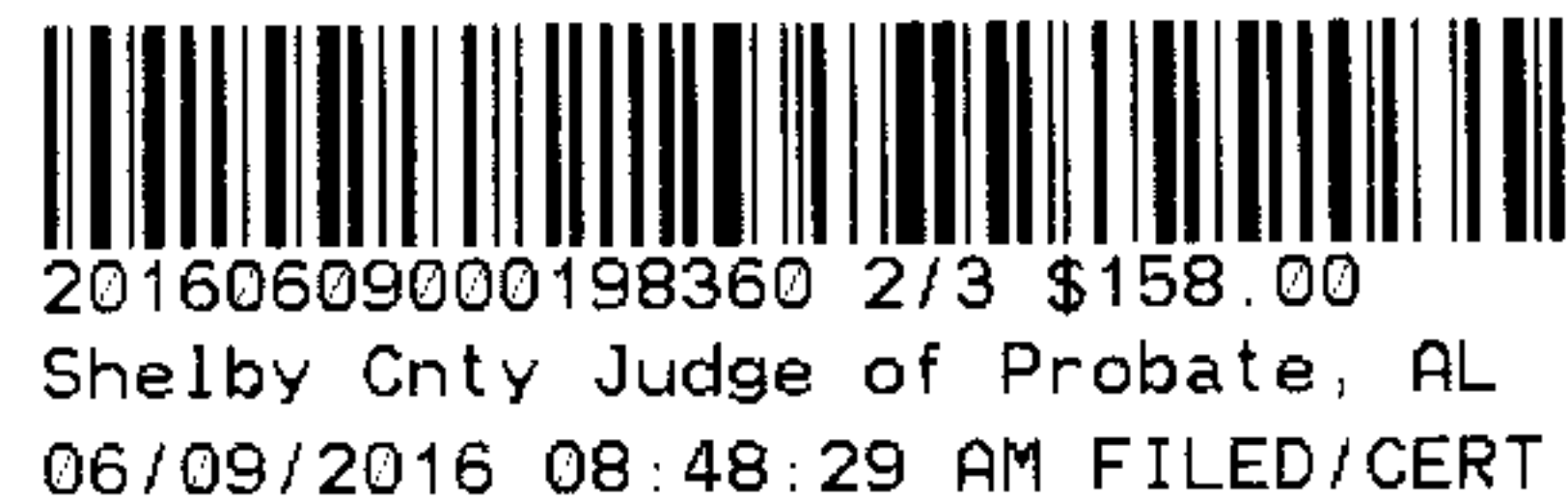
ARTICLE FIVE

ARTICLE NINE

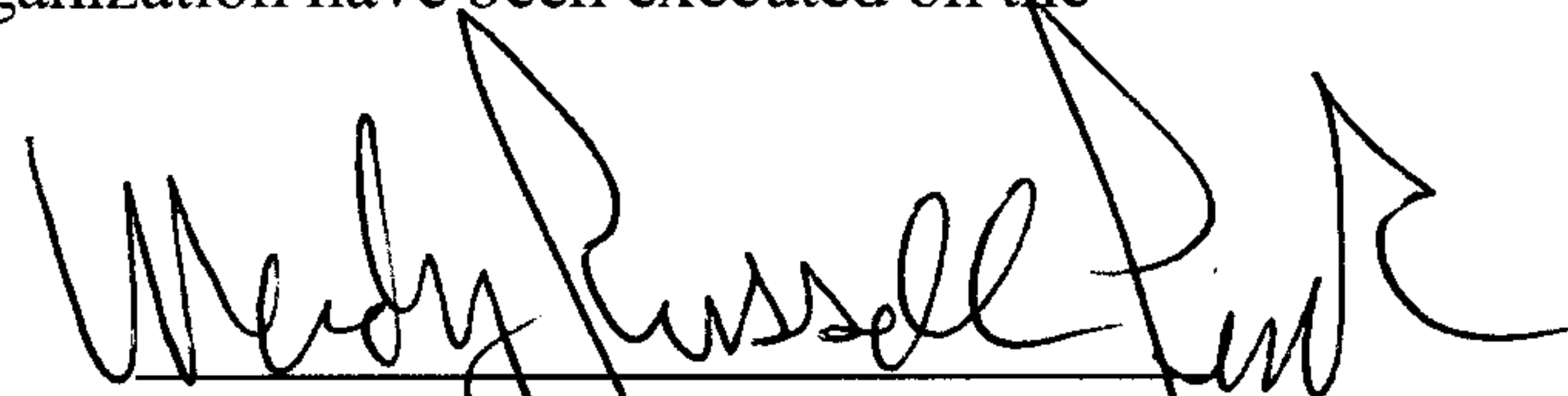
Contributions and Sharing Ratios

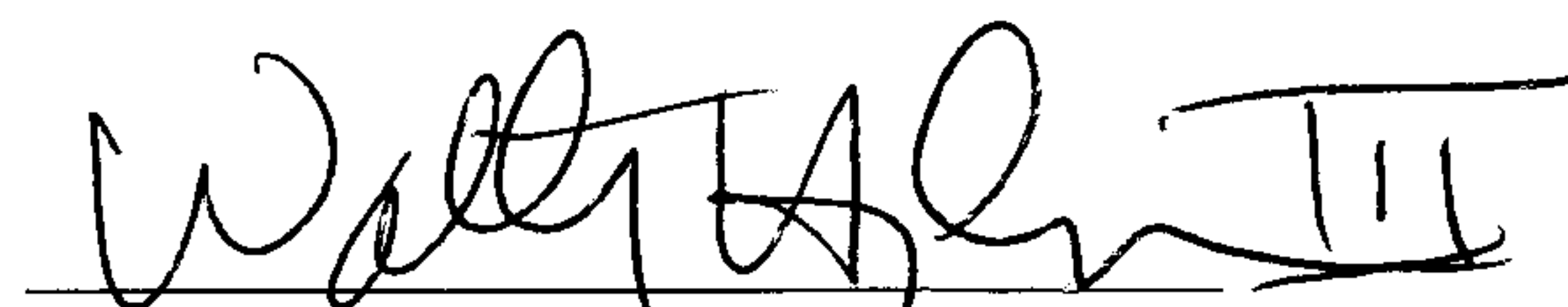
