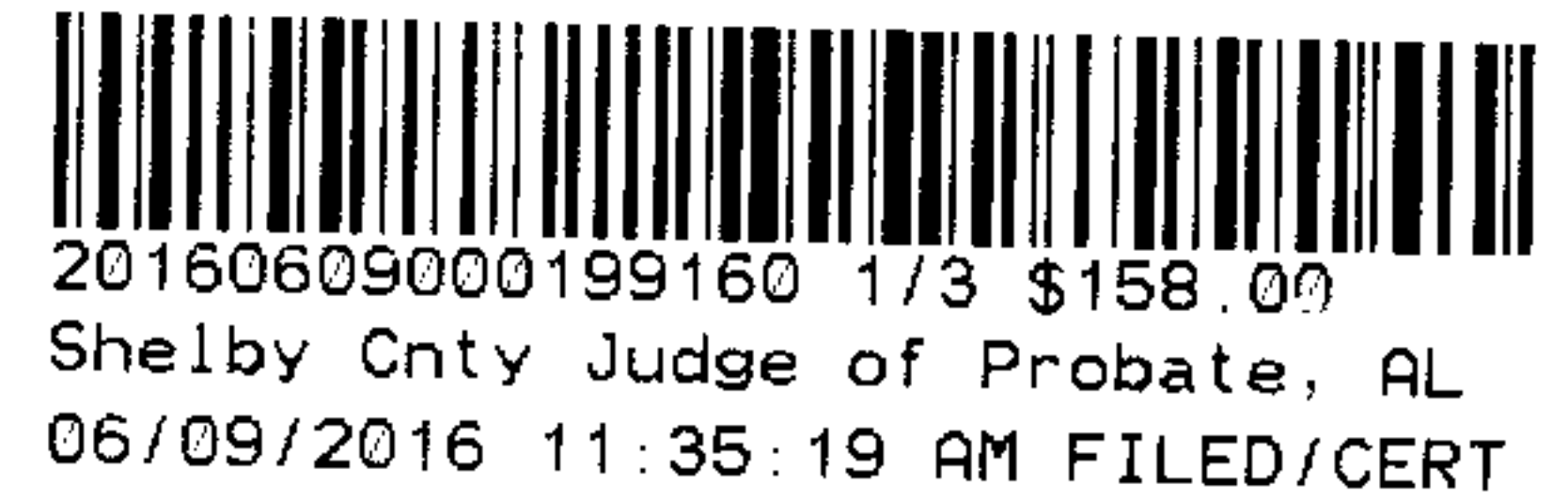


**CERTIFICATE OF FORMATION
