MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, heretofore on, July 16, 2008, to wit, Christopher M. Culver and Jennifer D. Culver, husband and wife, executed and delivered Mortgage Electronic Registration Systems, Inc. ("MERS"), (solely as nominee for Lender, Regions Bank d/b/a Regions Mortgage, and Lender's successors and assigns), a mortgage conveying to Mortgage Electronic Registration Systems, Inc. 
