AFFIDAVIT

Before me, the undersigned, personally appeared **WALTER CARLOS ANDERTON**, who, after first being duly sworn, deposes and says the following:

1. My name is WALTER CARLOS ANDERTON, and I am over the age of nineteen (19) years and a resident of Shelby County, Alabama. I have knowledge of the matters and things set forth in this Affidavit.

2. On or about January 30, 1976, my wife, MARIAN BREEDEN ANDERTON ("Mrs. Anderton"), and I each executed a certain document styled, "Declaration of Trust" as "Grantors," and naming Mrs. Anderton and me as "Trustees," of a trust entity which was later called the "Anderton Family Trust," which documents were placed of record in the Office of the Judge of Probate for Shelby County, Alabama, on January 30, 1976, at Instrument #19760130000005860 and Instrument #19760130000005970, respectively.

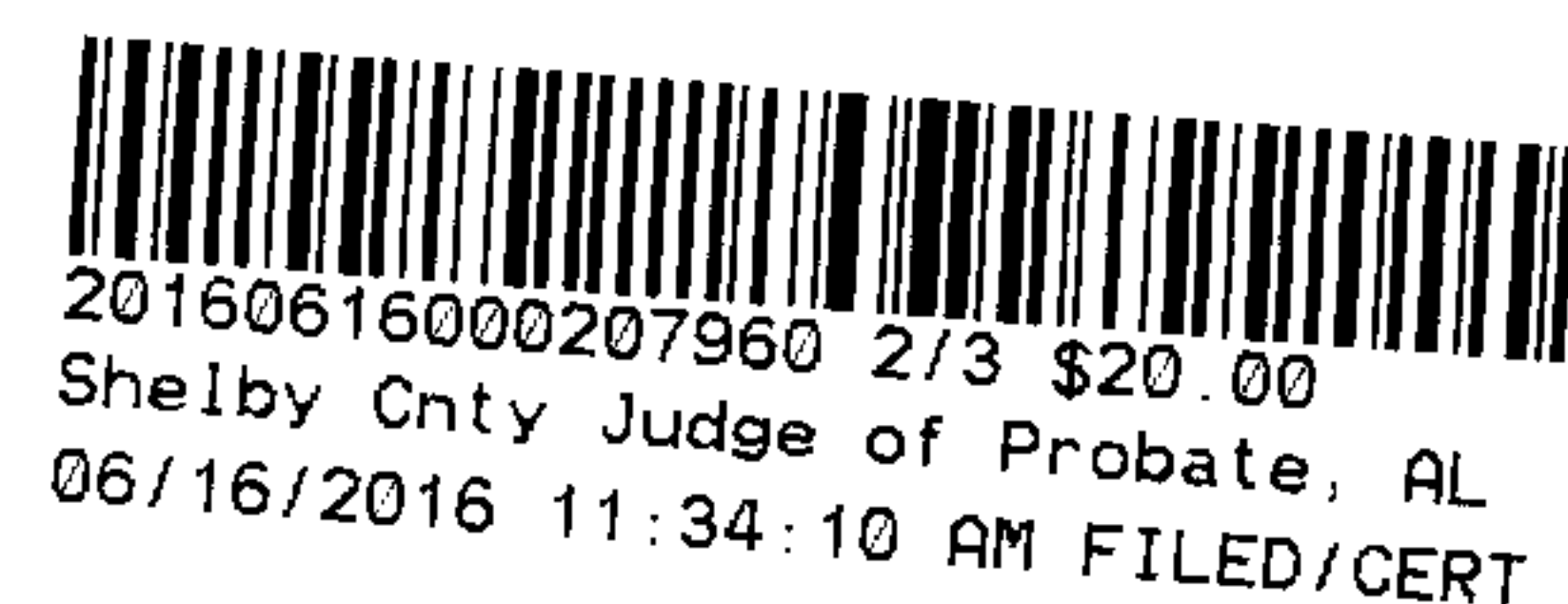
3. Thereafter, Mrs. Anderton and I executed a subsequent document, also styled "Declaration of Trust," on May 1, 2003, which was placed of record in the Office of the Judge of Probate for Shelby County, Alabama, on May 6, 2003, at Instrument #200305060000276520. However, that document was intended only to amend the two (2) earlier "Declaration of Trust" instruments dated January 30, 1976, and referred to hereinabove, with respect to the Anderton Family Trust, and was not intended to create and did not create a new and separate trust by that same or any other name.

4. Mrs. Anderton and I later executed another document, also styled "Declaration of Trust," dated March 22, 2010, which was placed of record in the Office of the Judge of Probate for Shelby County, Alabama, on March 22, 2010, at Instrument #201000322000082740. However, that document was intended only to amend the two (2) earlier "Declaration of Trust" documents dated January 30, 1976, and the "Declaration of Trust" document dated May 1, 2003, and referred to hereinabove, with respect to the Anderton Family Trust, and was not intended to create and did not create a new and separate trust by that same or any other name.

5. In addition, thereafter, Mrs. Anderton and I executed another document also styled, "Declaration of Trust," dated April 26, 2012, and placed of record in the Office of the Judge of Probate for Shelby County, Alabama, on April 27, 2012, at Instrument #20120427000145900. Again, that document was intended only to amend the two (2) earlier "Declaration of Trust" documents dated January 30, 1976, and the "Declaration of Trust" documents dated May 1, 2003, and March 22, 2010, as referred to hereinabove, with respect to the Anderton Family Trust, and was not intended to create and did not create a new and separate trust by that name or any other name.

6. There is only one (1) entity called the "Anderton Family Trust," which, as set forth hereinabove, was originally created by Mrs. Anderton and me on January 30, 1976; amended by us on May 1, 2003; again amended by us March 22, 2010; and again amended by us on April 26, 2012. There is no other trust entity named the "Anderton Family Trust" that has been created to date by Mrs. Anderton and me and/or of which she or I previously or presently serve as Trustee(s).

I am making this Affidavit for the purpose of its being placed of record in the Office of the Judge of Probate for Shelby County, Alabama, in connection confirming the existence of the





Anderton Family Trust and/or title to any real property conveyed to or by the said Anderton Family Trust.
