Subject to ad valorem taxes for the years 2016, and subsequent years, easements, restrictions, covenants, rights of way, and limitations of record.



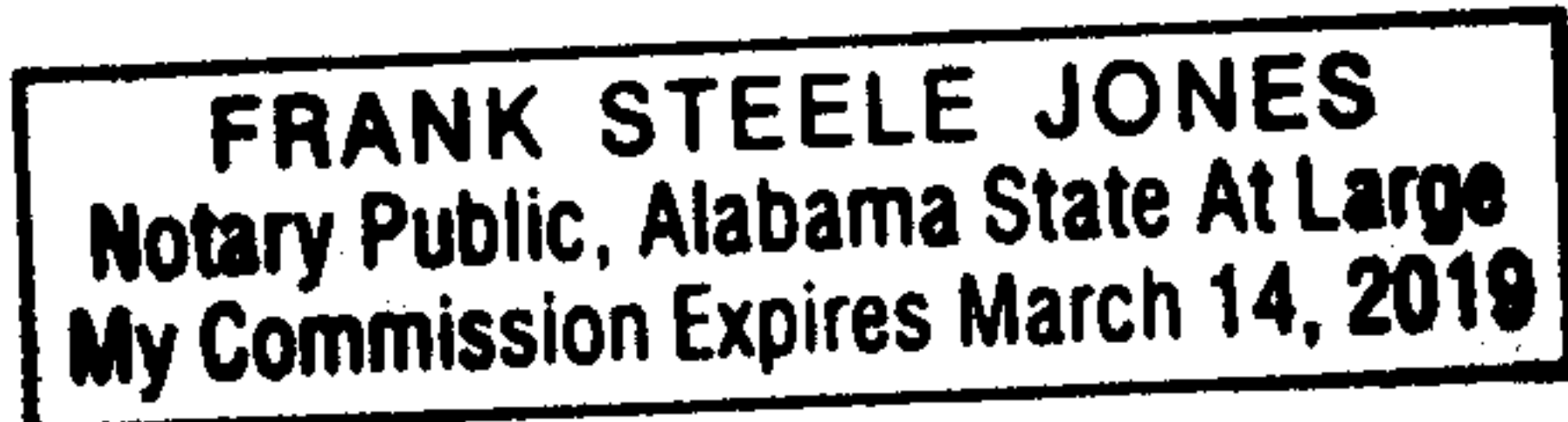
