I wish **Jeffery Smith** to be granted my late husband, Lonnie Clark's pistol.

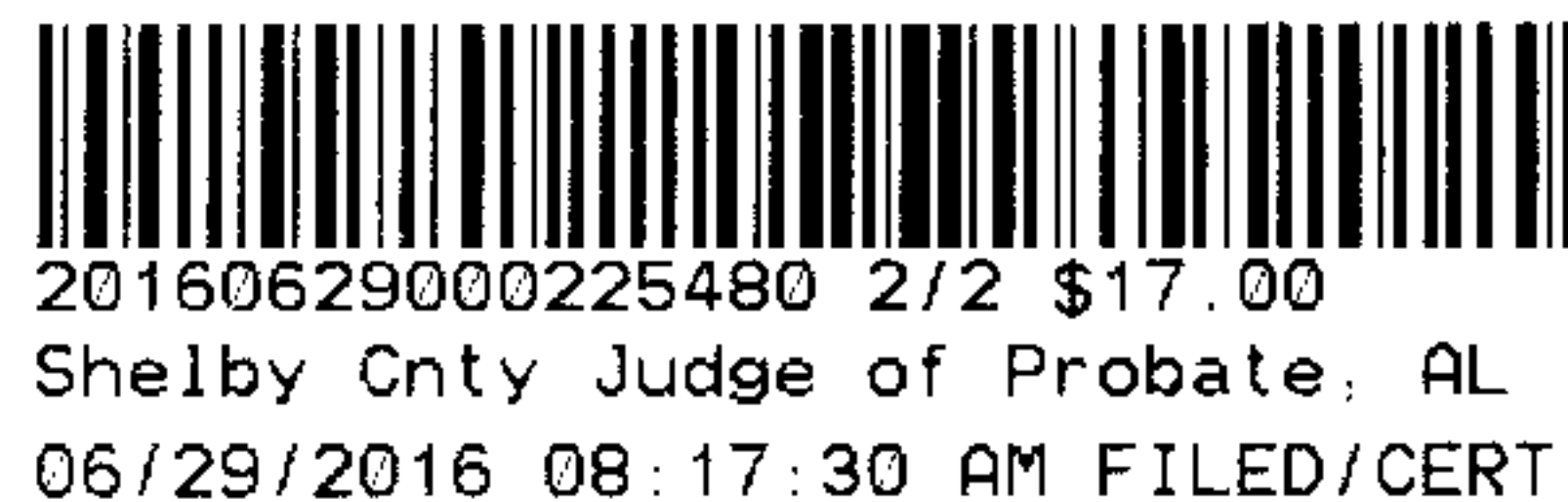
I wish my brother, **Glen Hyde** to be given my 1996 Subaru.

All contents of my home and personal items of Margaret Frances Clark will be divided equally among **Glen Hyde, Charles E. Hyde, Sara Nelson, and Judith Hyde**.
