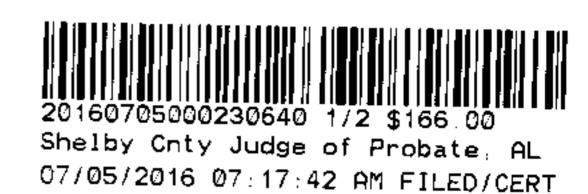

WARRANTY DEED JOINTLY WITH REMAINDER TO SURVIVOR
