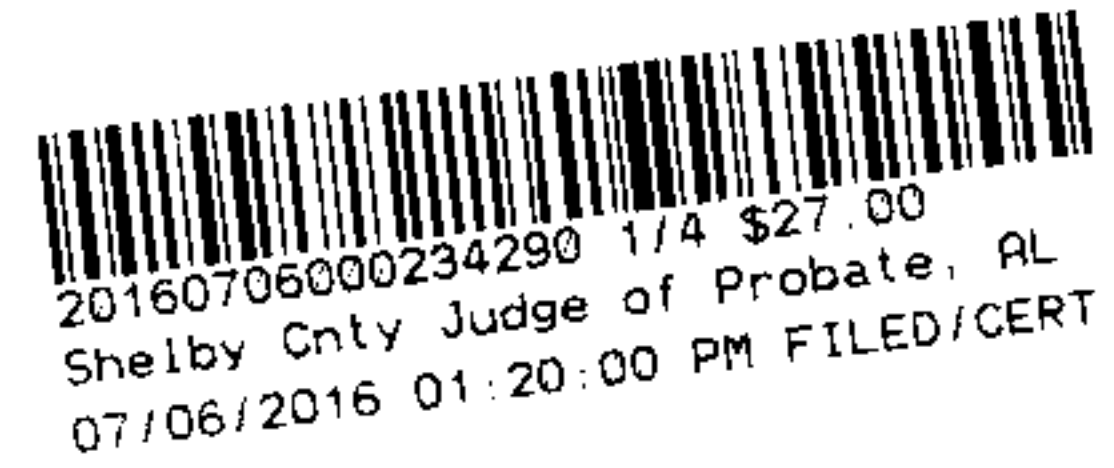


FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on to-wit, June 19, 2013, Al T. Ashley, a single man, ("Mortgagors"), executed a certain mortgage ("Mortgage") to Mortgage Electronic Registration Systems, Inc. solely as nominee for Green Tree Servicing LLC said Mortgage being recorded July 3, 2013 in Instrument Number 20130703000272640 in the Office of the Judge of Probate of Shelby County, Alabama; assigned to Green Tree Servicing LLC by instrument recorded in Instrument Number 20141014000323640 in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, on June 29, 2016 the day on which the foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure sale was duly and properly conducted, and Ditech Financial LLC FKA Green Tree Servicing LLC did offer for sale and sell at public outcry, in front of the Courthouse door, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the Mortgage was the bid of Federal National Mortgage Association in the amount of Forty Six Thousand Six Hundred and no/100 (\$46,600.00) Dollars, which sum was offered to be credited on the indebtedness secured by the Mortgage, and said property was thereupon sold to Federal National Mortgage Association, as purchaser; and


